**CSOC Council Vision:** *San Diego youth are healthy, safe, successful in school, and in their transition to adulthood, while being law abiding, while living in a home and community that supports strong family connections.*

**Mission:** *The purpose of the System of Care Council is to ensure that all agencies serving San Diego county youth from age 0 through age 21 have coordinated services resulting in improved youth and family, and system outcomes consistent with System of Care Values and Principles.*

1. **Collaboration of four sectors:** The cornerstone of the CSOC is a strong four sectors partnership between youth/families, public agencies, private organizations and education that ensure accountability to achieve System of Care (SOC) goals and quality outcomes consistent with SOC philosophy.

9. **Trauma Informed:** Sector partners recognize that trauma and chronic stress influence coping strategies and behavior, respond with compassion, and commit to the prevention of re-traumatization and the promotion of self-care and resilience.

- I. **Welcome and Introductions (Delrena Swaggerty)**
  - Welcome to Dr. Jeffrey Rowe as BHS CYF Alternate Council member
- II. **Approval of Minutes (Delrena Swaggerty)**
  - March 13, 2017 Council meeting minutes approved.
  - Review of action items from March 2017 meeting (Yael Koenig); See March 13, 2017 meeting minutes for details.
- III. **Business Items (Yael Koenig)**
  - A successful 3rd Annual Children's Mental Health Well-Being celebration took place on May 3, 2017 at the Spring Valley East Community Center. Over 170 individuals attended.
  - The SUD Ad Hoc subcommittee has completed a draft letter for the BHS Director with recommendations regarding Proposition 64-Marijuana Legalization. The draft document is included in the May 8, 2017 meeting packet. Input/feedback can be sent to Steven Jella at: through May 15, 2017. [sjella@sdyouthservices.org](mailto:sjella@sdyouthservices.org).
  - The Council is still seeking for individuals to chair and staff an Ad Hoc subcommittee to review the in The MHSA Three Year Program and Expenditure Plan for Fiscal Year 2017-18



through Fiscal Year 2019-20. More information and a sign-up sheet are included in the May 8, 2017 meeting packet.

- Council membership is being assessed for vacancies and rotation. Incumbents will be receiving a letter from the BHS Director. The new term will be effective July 1, 2017.
- The Child Abuse Prevention Coordinating Council recognized Aisha Pope with a STARS : award high quality services to youth and families

#### **IV. Mental Health Services Act (MHSA) – Update (Martin Dare)**

- The MHSA Three Year Program and Expenditure Plan for Fiscal Year 2017-18 through Fiscal Year 2019-20 is scheduled to be available for public review from June 30 through July 31, 2017. The MHSA Three Year plan is tentatively scheduled to be presented to the Board of Supervisors on September 12, 2017.
- Community planning forums for public input will take place in August 2017. A consulting group will be assisting with the coordination of these forums. Additionally, an online “Tele-Town Hall” will be implemented to obtain input and feedback from the community.
- MHSA Innovation Plan  
 The approval process has been updated by the Mental Health Services and Accountability Commission (MHSOAC). All of the MHSA Innovation proposals are still pending approval.

#### **V. “Hot Topic” Discussion (Delrena Swaggerty)**

- **CYF families facing immigration challenges**
  - ✓ Introduction of subject matter experts and guests.
  - ✓ Immigration Presentation/Handout (Jewish Family Service (JFS)-Kate Clark, Esq.)  
 Presentation highlights:
    - Immigration Status Categories include: Lawful Permanent Resident, Refugee, Asylee, Undocumented, Deferred Action for Childhood Arrivals
    - Deferred Action for Childhood Arrivals (DACA)
    - Immigration Custom Enforcement (ICE) and Customs and Border Protection (CBP) Sensitive Locations
    - 2017 Memo on Enforcement Priorities for aliens deportation
    - Resettlement agencies for Refugees and Asylees
    - Naturalization information for Lawful Permanent Residents
    - Resources:
      - Immigrant Legal Resource Center: [www.ILRC.com](http://www.ILRC.com), including “Red Cards” such as Guidance for schools and Family Preparedness Plan.
- **Discussion Summary**
  - ✓ The “red cards” function more as a reminder for immigrants to exercise their rights during a raid. Recent immigration enforcement actions seldom detain immigrants and instead have them report to an enforcement office within a week. The school-based Caregiver’s Authorization Affidavit can also be used in a hospital/ medical office setting. ILRC has Spanish/ English version of the Red Cards.
  - ✓ There are 950 non-profit, legal immigration services in California that can be consulted by DACA participants/immigrants. These agencies tend to have long waiting lists and due to different funding sources, participants may need to consult with different agencies.
  - ✓ Immigration raids starting from the beginning of 2017 were pre-planned actions from the previous administration. According to ICE, these raids focus on immigrants involved in criminal activities. Their policy states that raids are to be conducted during the day hours and when there is a warrant signed by a Judge. California Border Patrol functions differently and is separate from all ICE enforcement actions.
  - ✓ Litigation is still in progress to establish San Diego and all its surrounding unincorporated areas a “Sanctuary city”.

- ✓ Private immigration services providers, known as "Notarios" may provide questionable services. However, there are five agencies accredited by the Department of Justice's Board of Immigration Appeals in San Diego county. A listing and more information on these agencies is located in the Department Of Justice at: <https://www.justice.gov/>.
- ✓ Greg Knoll (Legal Aid Society of San Diego)
  - Some schools are inadvertently inviting "Notarios" to speak at school events and give erroneous legal advice regarding immigration relief.
  - The immigrant community should consult reputable immigration law firms with legitimate attorneys for better outcomes with their immigration goals.
  - Legitimate fear is being experienced by the immigrant community:
    - A recent incident involving an ICE truck parked outside a local elementary school, resulted in school absences.
    - An increase of people directing anti- immigrant remarks to others has been observed.
    - Some of the Legal Aid Society of San Diego clients have refused to collect government public assistance benefits, just to "stay off the radar".
- ✓ Rosa Ana Lozada
  - Recommended further discussion with the Hot Topic of immigration to connect the CYF system of care principles to the conversation and address any possible immigrant/refugee clinical interventions.
- ✓ Dr. Steven Davis (Community)
  - The United States is dealing with two separate immigrant populations. There are only 85,000 "lawful" immigrants as opposed to 11.3 million "illegal" immigrants.
  - BHS needs to formally address the immigration issues facing the children served in the system of care.
  - The San Diego Union Tribune reported that there is an increase of children going across the border to attend school. As a result, the San Diego Unified School District is now coordinating with Tijuana schools to provide counseling and a binational curriculum for these students.
  - As a volunteer in the International Rescue Committee (IRC), Dr. Davis has seen evidence of anxiety and trauma after working with children from different immigrant populations. He recommends that mental health treatment needs to be specific for "lawful" and "unlawful" populations.
  - Refugee children experience a unique set of difficulties before and after arriving in the United States, while children of undocumented parents face a different set of stressors.
  - Dr. Davis is willing to continue participating in any future discussion that may occur within the four sectors of the Council.
- ✓ Heidi Blue (CWS/Polinsky)
  - There are no records of children placed in foster care due to immigration enforcement fears. Children receive services regardless of immigration status.
  - CWS has an international liaison that provides international social services. CWS receives approximately 50 international services requests each month. The international liaison locates child/children's parents and/or relatives in their native country. Also handles home evaluations.
  - CWS has a Memorandum of Agreement with the Mexican Consulate to handle Mexican born child/children cases.
  - A major influx of parents with United States born children seeking asylum occurred in 2014. Many families became separated during the asylum process. As a result, CWS established a protocol with the United States Customs and that Border Patrol that places a hold on a child's Asylee parent(s) until a social worker arrives. The child/children is/are temporarily placed with a relative(s) and avoids Foster care placement. There has been a decrease of asylum seekers as of late.

- ✓ Consensus by Council to continue the immigration discussion with an emphasis on best practices through the system of care as well as learn of available resources.

#### VI. Director's Report (Alfredo Aguirre)

- The federal House of Representatives passed the "Repeal and Replace" bill for the Affordable Care Act. The Senate will be the next entity to evaluate this bill.
- BHS will be submitting the Drug Medi-Cal Organized Delivery System Implementation Plan to the Department of Health Care Services (DHCS) at the end of May 2017.
- The BHS budget is increasing by 28.5 million dollars in Fiscal Year 2017-18. The increase will provide enhancements to several programs including, but not limited to:
  - ✓ Emergency Screening Unit: Improvements include increasing bed space from 4 to 12 beds and moving to a more central location in the Hillcrest area. The new facility is expected to open in October 2017.
  - ✓ The Substance Use Disorder (SUD) budget will be increased to address requirements of the Drug Medi-Cal's organized delivery system. Implementation of the Drug Medi-Cal program is expected to begin in July 2018.
  - ✓ Existing outpatient programs for children will also become more comprehensive as they transition to Full Service Partnerships (FSPs).
  - ✓ I CARE program will provide a safe and healing environment to Commercially and Sexually Exploited Children (CSEC). Contract is scheduled to be effective July 1, 2017.
  - ✓ Our Safe Program will provide direct clinical services, and a drop-in center support with connection with a job training, GED preparation, life skills training, and crisis support to Lesbians, Gay, Bisexual, Transgender, Queer, Intersex (LGBTQI) youth. Contract is scheduled to be effective July 1, 2017.
  - ✓ The Treatment and Evaluation Resource Management (TERM) provides specialized evaluation and treatment services for youth in the Juvenile Court system. TERM rates for this program will increase to keep current providers in place and to recruit new providers.
  - ✓ The Supplemental Security Income (SSI) assistance through an augmentation of a contract managed by Eligibility Operations has been very successful and will be receive a funding increase to assist more clients with SSI applications, provide representation for SSI applicants and support through appeals and hearings to those children who have a qualifying disability and meet financial eligibility criteria.

## QUALITY MANAGEMENT TEAM UPDATES

### **CCBH Client Plan and Progress Note (CPPN) Training**

CPPN training has steadily become more efficient. The focus of the training has shifted to learning the system, as opposed to both the system and the documentation. The content has adjusted to only cover applicable client plan-type folders and routine planned interventions. As a result, we are pleased to announce that effective June 2017, the two-day CPPN training will be reduced to one day!

### **Client Plan Redesign and Guidelines**

New guidelines for what is required in CCBH CP's, new templated language to assist with compliance and the addition of new CP families will be part of the client plan redesign that will effective July 1<sup>st</sup>. Be on the alert for memo with instructions coming out soon.

Due to upcoming Department of Health Care Services (DHCS) data reporting requirements, BHS has worked to develop systems to collect data for the use of interpreters in service delivery and the languages in which services have been provided.

To reach this goal, BHS is utilizing two previously unused tables in the Billing Encounter to capture the use of interpreters and language utilized in service delivery. These two tables are **BILLING TYPE** and **SERVICE INTENSITY TYPE**.

**Billing Type** = Language utilized for service delivery.

**Intensity Type** = Interpreter utilized for service delivery.

**Effective July 3, 2017**, these two fields will be required at service entry. These fields will be defaulted to blank when entering the service indicators. Both of these fields are required in order to save the service data. These fields must be entered for every service.

**DEFINITIONS OF SERVICE INTENSITY TYPE (USE OF INTERPRETER)**

1. **Bilingual Program Staff** – Select this value if the service was provided in a language other than English and the service was provided by an internal program bilingual staff.
2. **External Interpreter Agency** – Select this value if the service was provided utilizing an external agency that comes to the program site to provide interpretation for the service delivery.
3. **Internal Interpreter LE** – Select this value if your Legal Entity has a dedicated trained staff(s) that provides interpreter services for all programs within the legal entity. Also use, if an internal program staff is used as an interpreter for another program staff within the program. (Example: If a bilingual staff interprets for the client during a medication visit with M.D.)
4. **Not Applicable** – Select this value when no interpreter is used for the service delivery.



These services are reimbursed at a different rate and therefore need to be coded as emergent/urgent. These providers will not need to do anything for the Billing Type. These subunits are defaulted to include the appropriate Billing Type.
2. The above referenced providers will enter the Language of service delivery in the Intensity Type field.
3. The Performance Improvement Team (PIT) will be using an alternate method to determine Interpreter use for the above referenced providers.

### **Step 2 in the ASAM Series**

This interactive, skills-based training will begin with a brief overview of the ASAM criteria and a cross-walk between the levels of care articulated in the ASAM criteria and the levels of care defined by the DMC-ODS Waiver. Following this brief review, the presenter will focus the remaining portion of the training on a detailed review of the four progress note formats approved for use in clinical files by SAPC, which are: (1) SOAP (Subjective, Objective, Assessment, and Plan); (2) GIRP (Goals, Intervention, Response, and Plan); (3) SIRP (Situation, Intervention, Response, and Progress); and (4) BIRP (Behavior, Intervention, Response, and Plan), followed by instruction on how to develop a comprehensive, individualized treatment plan. Each focus group format will be reviewed in detail, and participants will have the opportunity to practice drafting progress notes through a series of case scenarios.

### **Learning Objectives:**

1. Demonstrate ability to apply ASAM risk ratings to information gathered through multidimensional assessment
2. Demonstrate an ability to create an individualized treatment plan based upon the ASAM criteria and risk across the six dimensions of multidimensional patient assessment.
3. Use progress notes to demonstrate movement toward attainment of treatment plan goals

## Description of ASAM Criteria-C

**ASAM Criteria-(C) - Using the ASAM Criteria to Re-Assess Clients within the Context of the California Treatment System**

### **Step 3 in the ASAM Series**

This interactive training will provide an overview of the ASAM Criteria, Levels of Withdrawal Management and ASAM Levels of Care. Using case examples, participants will be divided into two groups with the task of reassessing individual case studies and determining if the client is to remain in the same level of care or be stepped up or down, depending upon the outcome of the assessment across each of the six dimensions. Participants will present their case to the overall group, describe the re-assessment process, provide an overview of the risk rating for each dimension, and establish a level of care placement utilizing the ASAM Level of Care Determination Tool developed in Los Angeles County.

1. Review the ASAM Criteria and discuss the value of a multidimensional assessment.
2. Apply, through case study discussion, the use of ASAM Criteria to establish risk ratings for each case study across the 6 ASAM dimensions.
3. Explain how to determine an appropriate level of care based upon the risk ratings for each case study reviewed.
