I. Welcome and Introductions

Piedad Garcia, Adult Older Adult (AOA) Deputy Director Yael Koenig, Children Youth and Families (CYF) Deputy Director

- The Transitional Age Youth (TAY) Workgroup has officially transitioned from a workgroup into a Council. Co-chairs will be announced once they have been selected.
- **Hepatitis A Outbreak update**: Homeless communities have been largely impacted by the Hep A outbreak. To date, there have been 17 deaths caused by Hep A in San Diego County.
- In July 2017, approximately 40 Homeless Outreach Workers (HOW) were embedded into the Substance Use Recovery Centers to outreach to homeless in the communities within the regions. For Homeless Full Service Partnership (FSP) ACT Programs, there are approximately 13 FSPs specifically for outreach and engagement to homeless with a Serious Mental Illness (SMI). An estimated 1,500 homeless have been housed through the FSP ACT programs.
- The CO-19 Report assists Behavioral Health Services in identifying individuals
 who are touching the system in terms of urgent and/or emergency services
 but are unconnected to ongoing treatment and services in our system of care.
 These individuals are usually found in jail, emergency rooms, or through PERT.
 Once these individuals are identified, ACT teams are asked to search and
 engage them within the system of care for treatment, services or referrals.

- The Drug Medi-Cal Organized Delivery System Implementation Plan has been approved by the Department of Health Care Services. Once the fiscal plan with proposed rates has been approved, a Board Letter will be drafted to the Board

- of Supervisors to give County the authority to contract with the Department of Health Care Services. The County is looking at a possible start date of July 1, 2018 and is currently working to get current alcohol and drug providers certified, as well as recruit new providers.
- Local Roadmap Activities: BHS has been working to consolidate roadmap and how to frame priorities to be more aspirational and strategic. Once the new version of the Roadmap with COR strategies has been finalized, it will be released to the community to discuss major accomplishments.

 - Community Forums Update: This year, two large community forums, 13 focus
 groups and two tele-town halls were conducted to gather community
 feedback. The feedback received from the forums and focus groups will be
 used to develop next year's Annual Update.
 - The Three Year Plan will be presented to the Board of Supervisors on October 10th. Proposals to increase three Innovations programs will be included in the Board letter: Urban Beats, CREST and Peripartum.
 - On October 26th, the proposals for Urban Beats, CREST and Tele-mental Health will be presented to the Mental Health Services Oversight and Accountability Commission for approval.

- Accessory Dwelling Units (ADU also known as Granny flats): a second small dwelling attached to or on the same grounds of a regular single-family home. Several bills have adopted legislation to reduce restrictions on building ADUs.
- <u>Tiny Home</u>: self-contained housing unit between 100-400 square feet meant for permanent housing.
- o <u>Sleeping Cabin</u>: similar to Single Room Occupancy (SRO), meant for temporary housing.
- o <u>Modular Dwelling</u>: prefabricated/factory-built housing providing reduced housing costs through mass production.

VII. Closing Announcements

Question regarding if families moving from house to house with no permanent address would be considered 'homeless' even though they would not identify as homeless. Most provide an address at point of contact but case managers later discover it was not a permanent address – could this contribute to a possible underrepresentation of amount of homeless in Children's system? Recommendation to address that piece in Children's area.
