3:00 PM	I. Welcome and Introductions (Jessica Hamilton)	Newly appointed Co-Chair Diana Rabban was announced.	
3:05 PM	II. Approval of November 2018 minutes (Co-Chair)	Minutes approved as written.	
3:10 PM (subject to change)	III. Director's Update (Alfredo Aguirre)	 Governor Gavin Newsom released his first proposed FY 19-20 budget 1/10/19. The budget is \$209 billion in total state spending, consisting of \$144 billion from the state General Fund (GF), \$60 billion from special funds and \$5 billion from bond funds. The Governor's Budget proposes to move youth correctional facilities from the California Department of Corrections and Rehabilitation (CDCR) to a new department under the Health and Human Services Agency with a focus on rehabilitative programming. The 2019-20 budget builds upon recent legislative and ballot efforts by prioritizing funding for jurisdictions to tackle homelessness. The budget includes \$500 million one-time GF for jurisdictions to build emergency shelters, navigation centers or supportive housing. There are also some longer-term programs included from the past few years. It was announced that there is a need for Mental Health/SUD education in Community Colleges.



RRA WORK TEAM




The goal of the RRA Work Team is to increase the quality of recovery residences in San Diego County Region and to maintain a focus on the whole-person approach to recovery.


RRA MEMBERSHIP GOALS






% OF BEDS IN SAN DIEGO COUNTY REGION
