#### STAFF TO THE BEHAVIORAL HEALTH ADVISORY BOARD

# I. CALL TO ORDER

The Behavioral Health Advisory Board (BHAB) was called to order by Chair Bill Stewart at 2:36 PM inperson and via Zoom.

### II. NON- AGENDA PUBLIC COMMENT

- Robin Sales shared her concerns regarding select San Diego County school districts that are not renewing contracts with San Diego Youth Services for mental health support. She is concerned about the continuity of care for youth.
- Jerry Hall shared his concern that BHAB is going dark in 2024 for the months of January and July due to national holidays. He additionally encouraged BHAB to attend recommended trainings and to focus on their duties and responsibilities as an advisory board.
- Karen Marie stated that her son has anosognosia and is concerned with how to ensure he
  receives the care needed to help his condition. Her son has been in a continuous cycle of
  hospitalizations, homelessness, and jail and she advocates that the family should have the right
  to be involved in his care.
- Mary Jo shared that she is satisfied with the mental health services that are available, however, she is at risk of becoming unhoused and advocates for more funding towards senior subsidy programs.

# III. APPROVAL OF THE MEETING MINUTES FROM September 7, 2023

ON MOTION of Judith Yates, seconded by Joel San Juan, BHAB approved the minutes from September 7, 2023, with the following amendment to the public comment provided by Karen Lotus whereby Karen described her son's multiple encounters with law enforcement and medical providers, yet, regardless of his grave condition, he was released or left on the streets.

#### IV. ACTION ITEM: BHS PROCUREMENTS AND CONTRACT EXTENSIONS

Luke Bergmann, Director, presented the BHS Procurements and Contract Extensions Board Letter authorizing competitive solicitations, single source contracts, amendments to extend existing behavioral health service contracts, an amendment to reflect a change to services and an increase in funding, and execute the Drug Medi-Cal Organized Delivery System (DMC-ODS) intergovernmental agreement with the state and accept funding. The following recommendations were made:

- Issue Competitive Solicitation
  - o Four (4) contracts \$12 million in Fiscal Year (FY) 2024-25
- Single Source Contract
  - o One (1) contract \$.8 million in FY 2024-25
- Contract Amendments
  - o Four (4) contracts \$12.2 million in FY 2024-25
- Single Source Contract Amendments
  - Six (6) contracts \$5.8 million in FY 2024-25
- Contract Amendment
  - One (1) contract \$1.3 million in FY 2024-25
- Execute DMC-ODS Intergovernmental Agreement & Accept Funding
  - \$684.8 million in FY 2023-24 through 2026-27

Robin Sales from the Criminal Justice (CJ) Subcommittee shared that at the September meeting the group received a presentation that provided an overview of jail-based competency treatment programs, they also discussed the SANDAG report on criminal justice, as well as District 3 Board staff, Aaron Burgess Jr, shared information on the Gun Violence Reduction Summit, and members discussed the CJ Subcommittee recommendations for the year-end report to BHAB.

Serita Polinaire from the Alcohol and Other Drug Prevention (AOD) Subcommittee shared that the Subcommittee has been successful in meeting their goals this year and the group will reevaluate their goals to ensure they are meeting the community needs.

#### VIII. DIRECTOR'S REPORT

Luke Bergmann shared the following:

- The CARE Act program officially started on October 1, 2023, in San Diego County and has the
  potential of positively impacting people's lives. He could not provide an update on how many
  referrals had been received to date by BHS. Luke and Charity White-Voth responded to BHAB
  member questions and provided details on the CARE Act program including the court process.
- The Board of Supervisors will likely be approving on consent facilitating the establishment of a new substance use disorder treatment clinic focused on medication assisted treatment for people with opioid use disorder. This facility will be established as a Tribal Federally Qualified Health Center (FQHC, Tribal 638) in East Region, owned though not operated by a Tribe.
- The City of San Diego is moving towards declaring a state of emergency in response to the insufficiency of mental health beds.
