Justice System Overview (David Mullen)</p>	<ul style="list-style-type: none"> • Approximately 40% of individuals served by BHS have justice-involvement in the past two years • Anyone who meets income eligibility can use the BHS system of care • Collaborative Courts available with or without BHS Contracted Services • “In-Reach” Services: Clinician builds relationships with individuals who have serious mental illness in order to bridge them into the community and ensure successful re-entry <ul style="list-style-type: none"> ✓ Wellness Ministry available for those who are more comfortable working with a clergy person • Sobering Center: Diverts intoxicated persons from custody to treatment and linked to services as needed • Psychiatric Emergency Response Teams (PERT): Mental health clinician or registered nurse works with law enforcement officer to manage mental health crises, divert from custody, and link to services • Assertive Community Treatment (ACT): Bringing services like medication management, case management, and housing to an individual with serious mental illness <ul style="list-style-type: none"> ✓ Center Star, Vida, and Post Release Outpatient Psychiatric Services (PROPS) are specific to individuals with justice involvement ✓ Probation officers are embedded into ACT programs to assist with navigating the legal system • Strength-Based Case Management: Specific to those on AB-109 probation, provides similar services as ACT but less frequent contact • In-Home Outreach Team (IHOT) and Assisted Outpatient Treatment (AOT): Team consisting of clinician, case manager, family support specialist, and peer specialist engages with persons 	



	<p>with serious mental illness in the community</p> <ul style="list-style-type: none"> ✓ IHOT referral made by family, PERT, hospitals, or law enforcement ✓ Can move into an AOT referral to determine if court-ordered treatment is appropriate • Justice Involved Services Training Academy (JISTA): Trainings for service providers who serve justice-involved individuals in order to stop recidivism <ul style="list-style-type: none"> ✓ Risk-Need Responsivity ✓ Criminogenic Risk • PC 1000 Programs: Two track system for opportunity to dismiss low-level drug charges <ul style="list-style-type: none"> ✓ Education track ✓ Treatment track through Drug Medi-Cal - Organized Delivery System (DMC-ODS) • Prop 47 Funded Programs: Certain theft and drug possession charges changed from felonies to misdemeanors to focus prison spending on violent crimes <ul style="list-style-type: none"> ✓ San Diego Misdemeanants at Risk (SMART), StrengTHS, Recovery for Life
