	 County criminal agencies have responsibility for individuals sentenced to serve a prison term in county jail instead of state prison for certain non-violent, non-serious, or non- high risk sex offenses pursuant to Penal Code 1170(h). 	
	 Probation Department to supervise an additional population of felons released from state prison, in which recent offense was non-violent, non-serious, or non-high risk sex crime. Individuals are called Post Release Community Supervision (PRCS) offenders. 	
	 Prior to the realignment these offenders would have been supervised by State Parole. State parole continues to exist and are responsible for felons who have been convicted of serious and violent felonies.

	 The Community Transition Center (CTC) was created and operational in January 2013, which allows Probation officers to immediately assess and engage the offenders and connect them with service needed to reintegrate into society. CTC Team: Sworn Probation Officers Behavioral Health Services Team AOD Treatment Counselors Nurse Case Manager Medi-Cal Application Assistors Drivers At the CTC the offenders are individually screened for criminogenic needs, Behavioral Health needs, Physical Health needs and Special Consideration needs. The collaboration of the county and its partners allows for successful progress to focus on community safety.
