Presentation Whole Person Wellness Ellen Birrell, County of San Diego, HHSA 12:00-12:20pm	<ul> <li>Whole Person Wellness (WPW) is a waiver for Medi-Cal 2020 to reduce costs for highest utilizers by adding a level of case management. Goal is to reduce costs through reducing hospital days, emergency room visits, jail days, etc.</li> <li>WPW is looking at serving 1,049 people between now and end of 2020. Clients can be eligible for up to 2 years of case management services.</li> <li>Phases: outreach and engagement → stabilization → transition → maintenance → 1 year of aftercare.</li> <li>Service integration teams include a peer support specialist, housing navigator, and case manager with additional support via licensed clinician and RN.</li> <li>Of 302 referred (goal was 200), 144 had some involvement with County mental health services; 158 had homeless indicator; and 23 likely ineligible for WPW. Largest # was enrolled through Eligibility Ops and Homeless Outreach Teams.</li> </ul>

# VIII. BHS Director's Update Alfredo Aguirre & Piedad Garcia 12:20-12:30pm

#### Alfredo:

- The finalized Ten Year Roadmap will be released to the public within 2-3 weeks.
- Drug Medi-Cal update: County will be going to the Board of Supervisors on March 13<sup>th</sup> to request authority to execute a contract with the Department of Healthcare Services.
- One of the newer strategies folded into DMC-ODS are recovery residences (formerly sober living). The County is looking at an entity similar to ILA to provide oversight for recovery residences. The idea is to look at current programs around ILA and use as a model for recovery residences.
- Recovery residences are typically transitional housing but do not have a designated end date.

#### Piedad:

- The need to expedite housing placement in North/East/South and Central/North Central regions was discussed in a recent POFA Crosswalk meeting, particularly to streamline the application process and make standards less rigid.
- Other strategies to expedite housing placement/application include:
  - Birth certificate and ID Requirement: will now accept receipt of application to quicken process.
  - Inspections: housing authorities are looking into allowing its own inspectors to come to expedite housing placement.
  - CRF is looking into allowing electronic signatures.
- POFA update: Need 1,250 clients housed by June 2019. For existing FSPs with sponsor-based subsidies, would need 10-15 clients placed in housing per month to meet goal.
- How to find available housing stock? Piedad to go back to SDHC to discuss rapid housing approach.
- Adrienne Berlin suggested VI-SPDAT to be conducted at psych hospitals and jails.

#### MHSA housing program:

- Currently in process of the conversion of an existing Quality Inn hotel in Banker's Hill with project-based subsidies (92 units). Development is move-in ready, but units will be rehabbed over the course of 2018. 25 units will be MHSA.
- Service providers for MHSA units at Quality Inn will be CRF Downtown IMPACT and Pathways Catalyst (TAY).
- West Park Inn is another hotel currently in process for conversion, making it 139 total units and 48 MHSA units that will become available
