BHS Director's Update Alfredo Aguirre & Piedad Garcia 12:10-12:20pm	<ul> <li>Last briefing as Director for Behavioral Health Services</li> <li>Dr. Alfredo Aguirre expressed his gratitude to the Housing Council for their dedication and time in helping develop housing options and resources for people with serious and persistent mental illness</li> <li>Dr. Luke Bergmann will serve as the Director for Behavioral Health Services</li> <li>National Association of County Behavioral Health &amp; Developmental Disability Directors (NACBHDD) gave Dr. Alfredo Aguirre the Lifetime Achievement Award for his excellent work as county behavioral health director over many years</li> <li>Director Nick Macchione also received an award for his leadership and for his outstanding work at the county and national levels in implementing the Healthy Counties Initiative</li> <li>San Diego contingent came together and there was a joint Aging and Independence Services and Behavioral Health Services presentation on key issues</li> <li>Michigan is in the process of getting approval from the Center for Medicare &amp; Medicaid services, also known as CMS, to allow within their 1115 waiver to allow for housing infrastructure and planning</li> <li>No Place Like Home Advisory Committee has yet to appoint someone to take Dr. Alfredo Aguirre's place on the committee</li> <li>In the process of finalizing the Behavioral Health budget for fiscal year 2019/2020 and Housing will remain a top priority</li> <li>Dr. Piedad Garcia spoke about the triple RFPs going through the process</li> <li>Potential housing opportunities and services for people stepping down from an Institution for Mental Diseases, Acute Care, and Justice Involved</li> <li>No Place Like Home is also in process and it is progressing smoothly</li> <li>Capitalized Operating Subsidy Reserve (COSR) is being offered and the developers are requesting the funds</li> <li>Housing Authorities need to provide subsidies in order to stretch the funding further and provide the 500 units</li> </ul>
