III. <b>Directors Update</b> (Piedad Garcia)	<ul style="list-style-type: none"><li>MHSA Annual Update has been reviewed and submitted for BOS review on July 19, 2016.</li><li>Whole Person Care Pilot is tied to Project One for All (POFA) the application was submitted on July 1, 2016, notification of award expected on October 7, 2016. The pilot will address Medi-Cal beneficiaries who are frequent users of Emergency Departments, acute care and health care and are currently experiencing homelessness or are at risk of homelessness and have a SMI and/or SUD.</li></ul>	
IV. <b>Conservatorship – Presentation</b> (Beth Olin)	<p>Conservatorship Presentation:</p> <ul style="list-style-type: none"><li>Lanterman-Petris-Short Act (LPS) Act of 1968 was intended to:<ul style="list-style-type: none"><li>End inappropriate, indefinite involuntary commitment</li><li>Provide a comprehensive system of care</li><li>Define the process for establishing involuntary care including conservatorship and due process protections</li></ul></li><li>Criteria individuals must have for LPS conservatorship:<ul style="list-style-type: none"><li>Have a mental disorder</li><li>Be gravely disabled</li><li>Refuse psychiatric treatment</li></ul></li><li>The purpose of conservatorship is to provide individualized treatment, support, and placement for conservatees. Basic freedom is removed from individuals under conservatorship, so it must be considered as a last resort. Decisions by a judge or jury are made with the highest legal standard.</li><li>Referral must be from a psychiatrist at an LPS facility or from a County forensic psychiatrist/psychologist.</li><li>There is an investigation process in which LPS investigator interviews individual, review records, consult with treating staff, family member, other providers and collateral contracts, a comprehensive report is submitted to the Superior Court</li><li>At the hearing the Court determines; whether to establish the conservatorship, to appoint a public or private conservator, and the rights and disabilities.</li></ul>
