The OAC has selected the issues of housing and social isolation as areas of focus. The OAC Executive team is looking at ways to restructure monthly meetings to allow time for workgroup discussions and planning activities.

The Roadmap was developed in July 2016 to proactively address the most serious health issues facing San Diego County over the next ten years and identifies 12 priorities and 2-3 implementation strategies for each priority.
