<p>II. BHS Director's Report/BHS Update Cecily Thornton-Stearns</p>	<ul style="list-style-type: none"> 1115 waiver update- BHS presented to BHAB regarding the proposed plan. This plan was supported and will go to the BOS in September. If approved, it will be submitted to the State. INN- Urban Beats was invited by the State to present and table at Mental Health Awareness Day in Sacramento and took 2-3 youth. Presented to OAC about extension and expansion of the contract. BHS to consider revisiting the request as the outcomes support continuation of the program. The next opportunity to present to the OAC is in August. INN- TAY REST program= new model for homeless TAY that are unconnected (SMI and Co-Occurring). The program includes 90 days of housing and intensive case management and linkage to reduce access to emergency services. This is being presented on 5/25/17 to the OAC in Sacramento. County update: ending Fiscal Year. BHS is working with programs to ensure outcomes being met and assisting with program closeout. There is a new ACT program in C/NC region that will serve 100 18+ adults.

Adult Behavioral Health Council Meeting Alex Heyer/Mary Ellen Baracerros</p>	<p>Update provided by Hope Graven.</p> <ul style="list-style-type: none"> County is raising bed rates for SUD programs. AB 109 and residential programs to receive 6-12 month enhancements. MHSA will have community engagement forums in August and will have a tele-townhall opportunities to attend remotely. Three INN programs will be presented to the MHAOAC Training on Cal-Medi Connect on August 11th . Whole Person Wellness RFP going out soon, possibly next month. Program would assist 100 clients.

Children, Youth and Family Behavioral Health Council Meeting</p> <p>Claire Marquez/Mike Miller</p>	<p>Update provided by Claire Marquez and Mike Miller:</p> <ul style="list-style-type: none"> • Immigration Attorney, Kate Clark from Jewish Family Services presented on Immigration and Refugee numbers in San Diego County as well as offered insight into the experiences of these children, youth, and families. • Ms. Clark shared regarding services available to assist with resettlement and gave information about Immigrant Legal Resource Center. • Council is looking for individuals to chair and staff an Ad Hoc subcommittee to review Three Year Program and Expenditure Plan for FY 17-18. • BHS Budget is increasing by 28.5M in FY 17-18 which will provide enhancements to several programs such as ESU, Substance Use Disorder budget, transitioning various children’s outpatient programs to Full Service Partnerships, and TERM provider rates will be increased in order to keep providers as well as recruit new providers. • There was much discussion around immigration and noted there has been a decrease in undocumented persons accessing services. Attorneys and advocates were present.
