Nadia Privara Brahms, Acting Director of Behavioral Health Services provided the following updates:

- Facility Developments: In collaboration with the Department of General Services (DGS), planning is underway to finance, develop, and operate a licensed Board and Care facility in Hillcrest, with engagement from consultants and developers.
- Workforce Development: The Elevate Behavioral Health Workforce Fund is being leveraged to support the creation of practitioner and peer support programs. Partnerships with local academic institutions aim to integrate trained professionals into County-funded direct care programs, with the long-term goal of establishing a replicable, population-specific model.
- Budget Outlook: Core funding sources such as the Mental Health Services Act (MHSA) and new opportunities like BH-CONNECT remain integral to sustaining and expanding services. However, the impact of the forthcoming State budget remains uncertain.
