IV. Brown Act Requirements and Meeting Practices

V. CARE Act Update

Luke Bergmann, BHS Director provided the following CARE Act update:

- The CARE Act program has always emphasized that participation is entirely voluntary. However, it's important to note that some cases within the CARE program could potentially be elevated depending on individual circumstances.

- Procedurally, the CARE Act prioritizes individuals considered to be at higher risk, placing them at the top of the referral list. While the CARE Act isn't driven by traditional payment incentives commonly seen in broader healthcare systems, it does appear to be producing some positive outcomes. The incentive structure is less about financial gain and more about effectiveness in connecting individuals to needed care.
