III. NON-AGENDA PUBLIC COMMENT

In-Person Comments:

• Dang Le, an active-duty military personnel member transitioning to civilian life, highlighted the role of VETART in supporting veterans through arts-based community engagement.

- Purita Javier, a community member, raised awareness regarding a home business that uses a ceramics kiln, leading to toxicity and creating health concerns in a populated residential zone.
- Cesar Javier, a community member, raised awareness of the Tijuana River Valley sewage problem.
- Jerry Hall, with BHAB Rehab, encouraged BHAB members participation in planning sessions regarding homelessness, justice-involved, people, and more.

E- Comments:

- Mary Jo O'Brien, a community member, expressed appreciation for BHAB and BHS efforts for their awareness and responsiveness to the needs and impact of peer respite services.
- Sandra Robinson raised awareness of the use of jails for individuals with serious mental illness and advocated for expanded long term treatment options and improvements to board-and-care facilities.
- June Dudas expressed support for County efforts on involuntary behavioral health treatment and
 psychiatric advance directives and raised concerns regarding the Community Assistance,
 Recovery and Empowerment (CARE) program implementation when individuals decline
 voluntary participation.

V. ACTION ITEM: BHS PROCUREMENTS AND CONTRACT EXTENSIONS BOARD LETTER

Public Comments: In-person/zoom

- Cesar Javier expressed the importance of competitive procurement for alcohol, substance use, and mental health services.
- Jessica Kramer, BHAB member, discussed about the California Advancing and Innovating Medi-Cal (CalAIM) implementation and shared concerns regarding contractual expectations, access to community supports through insurance providers, and processes related to Americans with Disabilities Act (ADA) reasonable accommodations.
- Mary Jo O'Brien stated the historical involvement of peer support specialists in developing scopes
 of work and recommended including peers on Source Selection Committees for procurement
 processes reflected in the Board Letter.

- Pathways to Continuum of Care for Children, Youth, and Adults Impacted by Alcohol and other Drugs Subcommittee
 - Julie Hayden, Subcommittee Chair, reported that the subcommittee met in October and co-hosted a Community Program Planning (CPP) input sessions with the BHS Community and Engagement Team to identify gaps and challenges across the alcohol and drug continuum of care.
- Re-Entry for Justice-Involved Youth and Adults Subcommittee
 - Robin Sales, Chair, reported the next subcommittee meeting is rescheduled to Monday,
 November 17 and will be led by Minola Clark Manson in her absence.

VII. DIRECTOR'S REPORT

Nadia Privara, MPA, Acting Director, BHS provided the following updates:

- Population Health Unit, led by Dr. Nicole Esposito, continues naloxone distribution and overdose
 efforts, including the San Diego Relay Program, which provides peer support following nonfatal
 overdoses or behavioral health holds. Expansion to additional hospitals and pursuit of Medi-Cal
 certification are in progress.
- Data Science reported continued progress on major data-integration efforts. Mental health and substance use electronic health records were successfully unified under SmartCare, and BHS is joining the County's enterprise Data Lake, which will enhance access to secure, integrated, crossdepartmental data. Data Science continues ongoing monitoring of the CARE Act, Senate Bill 43, and BH-CONNECT.
- Community input sessions for the Behavioral Health Services Act (BHSA) Integrated plan for Fiscal Year (FY) 2026-2029 will continue through Winter 2026. Community members may participate in the input sessions to provide feedback on behavioral health priorities, service needs, and future system treatments.
- Under the BHSA, responsibility for certain statewide prevention activities is transitioning to the California Department of Public Health (CDPH). CDPH will release the next phase of its Statewide Prevention Plan, and the session will be open to the public. Counties, Tribes, and community partners are encouraged to provide feedback on proposed funding levels and implementation strategies prior to finalization of the 2026–2029 plan.

VIII. CHAIR'S REPORT

Robin Sales, Chair, BHAB provided the following updates:

- Expressed appreciation to BHS staff for supporting the BHAB Fall Retreat held on November 1, 2025, and noted the benefit of strengthened member engagement.
- Acknowledged Skylar Weatherford and Cristina Rios Vega for their support for BHAB as they transition to other assignments.
- BHAB sought volunteers to serve on the BHAB 2026 Priorities Committee, which will develop the board's priorities for 2026. Minola Clark Manson, Julie Hayden, and Robert Alm, volunteered to participate and will convene to organize and refine the priority areas for the board.
- Announced District 1 and District 5 currently need representatives for the Community Program Planning (CPP) Committee and invited volunteers from those districts to fill the vacancies.
