#### **CLUBHOUSE SERVICES**

- 10 existing Clubhouses in San Diego County provide members opportunities for work, wellness, and socialization for individuals with mental illness utilizing an evidence-based approach
- Due to contract end dates, the Board of Supervisors authorized the procurement of five Clubhouses in 2021; the current request is for the procurement of the remaining five Clubhouses in 2023
- When remaining five are awarded, all 10 Clubhouses will provide services in alignment with Clubhouse International standards

#### 2. AUTHORIZE COMPETITIVE SOLICITATION

Establish New Community-Based Crisis Stabilization Services Co-Located with Sobering Services in East Region

### **Highlight on East County Community-Based CSU**

- Crisis Stabilization Units (CSUs) provide medication, peer support, psychiatric services, and transition planning, with stays of less than 24 hours
- Expansion of CSU services in East County include:
  - Law enforcement drop-off with co-located sobering services
  - Capacity dependent on community need, facility design, and available footprint
