I. CALL TO ORDER

The Behavioral Health Advisory Board (BHAB) was called to order by Chair Bill Stewart at 2:31 PM in-person and via Zoom.

II. APPROVAL OF THE MEETING MINUTES FROM November 2, 2023

ON MOTION of Judith Yates, seconded by Serita Polinaire, BHAB approved the minutes from November 2, 2023.

III. NON- AGENDA PUBLIC COMMENT

- Karen stated that her son has anosognosia and is concerned with how to ensure he receives the care needed to help his condition. Her son has been in a continuous cycle of hospitalizations, homelessness, and jail. After 15 months, the LPS conservatorship has been approved but her son continues to wait for his facility placement. Karen advocates that the family should have the right to be involved in his care.
- Janice Luna Reynoso shared concerns for the impacts to the mental health of community members distressed over the Israeli-Palestinian conflict. Janice asked for this trauma to be acknowledged and for dialogue about the conflict.
- Fadwa Falestine shared her concerns for the safety and mental health of Arabs, Palestinians, and older Arab immigrants who reside in San Diego County. She would like BHAB to take these concerns to the Board of Supervisors (Board) and would like to see support for a call to a cease fire in the Israeli-Palestinian conflict.

VIII. DIRECTOR'S REPORT

Luke Bergmann shared the following:

- Vista Hill's North Central Regional Recovery Center will be closing on December 31, 2023 and their clients will be transitioned to other programs.
- The planning of the East County Crisis Stabilization Unit has been ongoing. To cover infrastructure
 costs BHS applied for Behavioral Health Continuum Infrastructure Program funding but was not
 awarded the state funding. However, BHS continues with the project and has an opportunity to
 leverage Mental Health Services Act (MHSA) funds to help subsidize the build on County owned
 property and will require and amendment which will be presented to BHAB.
- Senate Bill (SB) 43, signed in October 2023, will expand involuntary detainment and treatment for behavioral health conditions. It allows for involuntary care for severe substance use disorder (SUD), including as a standalone condition and redefines the definition of gravely disabled. The Board voted to defer implementation of SB 43 until January 2025.

IX. CHAIR'S REPORT

Bill Stewart, Chair, acknowledged the end of his two-year term as the BHAB Chair and expressed gratitude to BHAB members and BHS staff for their support over his tenure. Starting 2024, BHAB member Robin Sales, will serve as the new Chair for BHAB.
