IV. <u>DISCUSSION ITEM: BHAB ANNUAL RETREAT DRAFT AGENDA</u>

The BHAB Annual Retreat will be held Saturday, October 28, from 9:00 AM – 1:00 PM at the Behavioral Health Services administration building located at 3255 Camino del Rio S. San Diego, CA 92108. BHAB

members provided input for the retreat agenda and suggested that an ad-hoc group convene with Dania to help finalize the agenda.

V. PRESENTATION: EAST REGION CRISIS STABILAZATION UNIT AND RECOVERY BRIDGE CENTER

Dr. Piedad Garcia, Deputy Director, BHS presented on the East Region Crisis Stabilization Unit (ECSU) and Recovery Bridge Center (RBC) that will be located in El Cajon. Dr. Garcia described the services that will be offered at the ECSU and RBC:

- The ECSU will provide immediate mental health support and treatment services in a therapeutic setting to individuals in acute behavioral health distress who require urgent care beyond what an outpatient clinical service can provide.
- The RBC, co-located with the ECSU, will provide short-term services, usually about four hours but not exceeding 24 hours, in a supervised, non-medical environment to intoxicated individuals whose level of public intoxication puts themselves or others at risk. Outpatient substance use disorder services will also be available to ensure continuity of care.

VI. BHAB SUBCOMMITEE UPDATES

- Richard McGaffigan from the Criminal Justice (CJ) Subcommittee shared his concern with the challenges CalAIM may pose to developing new programs.
- Serita Polinaire from the Alcohol and Other Drug Prevention (AOD) subcommittee spoke on the success of the 2023 National Recovery Month Kick-Off Celebration held on August 26, 2023, at the Waterfront Park.
- Janice Luna-Reynoso from the Community Engagement (CE) Subcommittee had no update.

VII. PRESENTATION: BHS COMMUNITY ENGAGEMENT UPDATES

Kat Briggs, Chief Communication and Engagement Team, provided updates on BHS community engagement efforts and informed the board that BHS' approach to community engagement will include holding input sessions in a variety of community spaces, in smaller groups, and providing advanced notice to the community with the goal of creating multiple means of obtaining community input. Kat informed BHAB that in October they will have an action item to approve the community engagement approach.
