AUTHORIZATION FOR COMPETITIVE SOLICITATIONS AND AMENDMENTS TO EXTEND EXISTING BEHAVIORAL HEALTH SERVICES CONTRACTS, EXECUTION OF REVENUE AGREEMENT WITH THE STATE DEPARTMENT OF REHABILITATION, AND RATIFICATION OF BEHAVIORAL HEALTH SERVICES PERFORMANCE CONTRACT AGREEMENT WITH THE STATE (DISTRICTS: ALL)

OVERVIEW

In a series of actions since 1999, the San Diego County Board of Supervisors (Board) approved initiatives to redesign and implement an expanded continuum of comprehensive behavioral health care for children, adolescents, transition age youth, adults, older adults, and families. The County Health and Human Services Agency (HHS) Behavioral Health Services (BHS) department provides a comprehensive array of community-based mental health and substance use disorder services through contracts with local public and private agencies to vulnerable populations, including individuals who are experiencing homelessness, individuals with justice involvement, and children and youth with complex behavioral health conditions. In pursuit of these initiatives, the Board previously approved the procurement of these critical services.

As the County continues to evaluate and address the impact of the novel coronavirus (COVID-19), BHS remains focused on maintaining continuity of critical mental health and substance use disorder services to the most vulnerable individuals and families within the community. Approval of today's recommended actions authorizes competitive solicitations and amendments to extend existing behavioral health services contracts, including single source contracts, to sustain critical behavioral health services. Today's action will also authorize a revenue agreement with the State of California, Department of Rehabilitation for mental health employment services. Today's action also authorizes the ratification of the Fiscal Year (FY) 2020-21 Performance Contract Agreement with the California Department of Health Care Services to provide public mental health services throughout the county. These recommended actions support the continuation of critical work to advance the Behavioral Health Continuum of Care in alignment with Board direction.

Today's action supports the County's *Live Well San Diego* vision by ensuring access to services, promoting health and well-being in children, adults, and families, and encouraging self-sufficiency, which together promote a region which is building better health, living safely, and thriving.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. In accordance with Section 401, Article XXIII of the County Administrative Code, authorize the Director, Department of Purchasing and Contracting, to issue competitive solicitations for behavioral health services, and upon successful negotiations and determination of a fair and reasonable price, award contracts for an initial term of up to one year, with one to four option years, and up to an additional six months, if needed; and to amend the contracts to reflect changes in program, funding or service requirements, subject to the availability of funds and the approval of the Agency Director, Health and Human Services Agency.
2. In accordance with Board Policy A-87, Competitive Procurement, and Administrative Code Section 401, authorize the Director, Department of Purchasing and Contracting, subject to successful negotiations and a determination of a fair and reasonable price, to amend the contracts listed in Attachment A, Table 1 extending the contract term up to June 30, 2022, and up to an additional six months if needed; expand services, subject to the availability of funds; and amend the contracts as required in order to reflect changes to services and funding allocations, subject to the approval of the Agency Director, Health and Human Services Agency.
3. In accordance with Board Policy A-87, Competitive Procurement, and Administrative Code Section 401, authorize the Director, Department of Purchasing and Contracting, subject to successful negotiations and a determination of a fair and reasonable price, to amend the single source contracts listed in Attachment A, Table 2 extending the contract term up to June 30, 2022, and up to an additional six months if needed; expand services, subject to the availability of funds; and amend the contracts as required in order to reflect changes to services and funding allocations, subject to the approval of the Agency Director, Health and Human Services Agency.
4. In accordance with Board Policy B-29, authorize the Director, Health and Human Services Agency, upon receipt, to execute the Cooperative Agreement with the State Department of Rehabilitation for mental health employment services for Fiscal Years 2021-22 through 2023-24, amendments thereto, and in agreements and amendments in future years, provided terms, conditions, program services and funding are not materially impacted or altered.
5. Approve and authorize the Clerk of the Board to ratify the Fiscal Year 2020-21 Performance Contract Agreement with the California Department of Health Care Services, amendments thereto, and future years' Agreement and amendments, provided terms,

conditions, and funding are not materially impacted, subject to the approval of the Director, Health and Human Services Agency.

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2020-22 Operational Plan in the Health and Human Services Agency. If approved, today's recommendations will result in no changes in costs and revenue in Fiscal Year 2020-21 and approximately costs and revenue of \$171.6 to \$178.6 million in Fiscal year 2021-22. There will be no change in net General Fund cost and no additional staff years.

Recommendation #1: Authorization to Issue Competitive Solicitations

If approved, this request will result in estimated costs and revenues ranging from \$20.9 to \$27.9 million in Fiscal Year 2021-22 and \$21.2 to \$28.2 million in Fiscal Year 2022-23. The funding sources are Mental Health Services Act (MHSA), Realignment, Short-Doyle Medi-Cal, Drug Medi-Cal, Projects for Assistance in Transition from Homelessness (PATH), and State General Funds. There will be no change in net General Fund cost and no additional staff years.

Recommendations #2 & #3: Authorization to Extend and Amend Contracts

If approved, this request will result in estimated costs and revenues of \$150.3 million in Fiscal Year 2021-22. The funding sources are Mental Health Services Act (MHSA), Realignment, Short-Doyle Medi-Cal, Drug Medi-Cal, Substance Abuse Block Grant (SABG), and State General Funds. There will be no change in net General Fund cost and no additional staff years.

Recommendation #4: Execute a Cooperative Agreement with the State Department of Rehabilitation for Mental Health Employment Services

If approved, this request will result in estimated costs and revenues of \$0.4 million in Fiscal Year 2021-22 and \$0.4 million in Fiscal Year 2022-23. The funding source is Realignment. There will be no change in net General Fund cost and no additional staff years.

Recommendation #5: Ratify the Performance Contract Agreement with the State Department of Health Care Services

There is no fiscal impact from this action. If approved, this request will result in no current year costs and revenue. There will be no change in net General Fund cost and no additional staff years.

BACKGROUND

In a series of actions since 1999, the County of San Diego (County) Board of Supervisors (Board) approved initiatives to redesign and implement an expanded continuum of comprehensive behavioral health care for children, adolescents, transition age youth, adults, older adults, and families. The County Health and Human Services Agency (HHSA) Behavioral Health Services (BHS) department provides a comprehensive array of community-based mental health and substance use disorder (SUD) services through contracts with local public and private agencies to vulnerable populations, including individuals who are experiencing homelessness, individuals with justice involvement, and children and youth with complex behavioral health conditions. In pursuit of these initiatives, the Board approved the procurement of these critical services.

As the County continues to evaluate and address the impact of the novel coronavirus (COVID-19), BHS remains focused on maintaining continuity of essential mental health and substance use disorder services to the most vulnerable individuals and families within the community. Approval of today's recommended actions authorizes competitive solicitations and amendments to extend existing behavioral health services contracts, including single source contracts, to these sustain critical behavioral health services. Today's action will also authorize a revenue agreement with the State of California, Department of Rehabilitation for mental health employment services. Today's action also authorizes the ratification of the Fiscal Year (FY) 2020-21 Performance Contract Agreement with the California Department of Health Care Services to provide public mental health services throughout the county.

These recommended actions support the continuation of critical work to advance the Behavioral Health Continuum of Care in alignment with Board direction. All contracts are contingent upon the availability of funding, successful negotiations, and determination of a fair and reasonable price.

Recommendation #1: Authorization to Issue Competitive Solicitations

If this recommendation is approved, competitive solicitations will be issued and contracts will be awarded for the critical behavioral health services, as outlined below:

a. Clubhouse Services

On January 13, 2004 (5), December 13, 2005 (1), September 23, 2008 (8), and January 7, 2014 (9) the Board authorized the competitive procurement of Countywide clubhouse services. Clubhouses provide member-driven rehabilitation and recovery programs for adults with serious mental illness (SMI), including individuals who may have a co-occurring SUD. Clubhouses provide skill development, social rehabilitation, and symptom management. Services assist members in maximizing their recovery by increasing their rehabilitation and social skills, reducing social isolation, identifying areas of personal, cultural, vocational, intellectual, and recreational interest, increasing independent functioning, increasing employment and education, and improving quality of life. In FY

2019-20, 2,449 unduplicated clients were served through all clubhouses countywide, with a total of 55,072 annual member visits.

The combined total annual cost for the clubhouses included within this request is estimated to range from \$2.2 - \$3.0 million. Today's action would authorize a competitive solicitation for clubhouse services, resulting in the award of up to five total contracts in the North Inland, North Coastal, Central, and South Regions for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

b. Housing Support Services (Countywide)

On June 20, 2017 (13), the Board authorized a competitive procurement for housing support services through the tenant peer support program. The program provides housing navigation services and peer support services to assist clients in identifying, securing, and maintaining safe and affordable housing. The program supports clients referred to housing units funded by No Place Like Home (NPLH) and the Mental Health Services Act (MHSA). To complement the tenant peer support program, the home finder program provides outreach and engagement, housing navigation and location, and tenant support services to individuals with SMI who are experiencing homelessness, to identify and secure safe and affordable housing. To ensure optimal and centralized support to existing eligible clients and to meet the needs of new clients who will be housed in units funded by NPLH, the tenant peer support program will merge with the home finder program as a larger housing supportive services program to serve clients countywide. In FY 2019-20, the tenant peer support services and home finder programs collectively served a total of 586 unduplicated clients.

The annual cost of this program typically ranges from \$1.5 - \$2.0 million. Today's action would authorize the procurement of a housing support services program, inclusive of tenant peer support and home finder services, for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

c. Assisted Outpatient Treatment Outreach and Evaluation Services (Countywide)

On April 21, 2015 (4), the Board approved the implementation of Assisted Outpatient Treatment (AOT), also known as Laura's Law. On September 27, 2011 (7), the Board approved the implementation of the In-Home Outreach Team (IHOT) program, and on July 30, 2013 (6) the Board authorized the expansion of IHOT services countywide. AOT provides treatment services to adults who are experiencing SMI through court-ordered mental health treatment, outreach, engagement, community-based intensive case management, rehabilitation and recovery services, employment, and housing supports. The AOT service continuum also includes IHOT, which provides services to engage individuals and families, and evaluation services to conduct client, family and staff focus groups, evaluate services and outcome data, and prepare and submit findings and recommendations

to the County and State. In FY 2018-19, IHOT served 643 unduplicated clients and provided services to 319 unique family members.

The annual cost of the IHOT, AOT and program evaluation services typically ranges from \$3.3 - \$4.4 million. Today's action would authorize the competitive solicitation for IHOT, AOT and program evaluation services countywide, for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

d. Outpatient Mental Health Services for Adults (North Coastal, North Inland, North Central, Central Regions and Countywide Specialty Services)

On October 29, 2019 (8), the Board authorized competitive solicitations for biopsychosocial rehabilitation (BPSR) mental health outpatient services in the North Inland, North Coastal, North Central, and Central Regions. Additional BPSR services are provided throughout the county, including a countywide program that provides BPSR services to individuals of all ages who have experienced trauma and torture. BPSR programs provide evidence-based and comprehensive outpatient mental health services, which include rehabilitation services, medication management, care coordination, recovery services, and employment support. BPSR programs provide culturally competent, age and developmentally appropriate mental health services that exemplify best practices in psychiatric, vocational, nursing, social skill and illness management techniques tailored to each individual's needs. BPSR services increase clinical stability, decrease functional impairment, facilitate independence and sufficiency, improve employment options, and enhance psychiatric and social rehabilitation, and recovery. A wide range of BPSR services are available through these programs to meet the needs of the community, and include geriatric, crisis, urgent, walk-in, primary care collaboration, and co-occurring mental health and SUD services. For FYs 2017-18 through 2019-20, 4,899 unduplicated clients on average were served annually by all regions, inclusive of the program that serves victims of trauma and torture.

The combined total annual cost of services for the five BPSR programs included in this request is estimated to range from \$8.9 - \$11.8 million. Today's action would authorize a competitive solicitation for BPSR programs in the North Inland, North Coastal, Central, and North Central Regions, including a Countywide program that serves survivors of trauma and torture, resulting in the award of five contracts, with an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

e. Outpatient Mental Health Services for Children and Youth

i. Behavioral Crisis Center and Mobile Assessment Team Services (North Regions)

On August 4, 2015 (4), the Board authorized a competitive solicitation for outpatient services provided through a walk-in crisis center and mobile assessment team. The program provides assessment services for children and youth who are experiencing a mental health crisis or have an urgent need for mental health services. The mobile assessment team provides crisis intervention services to focus on reducing unnecessary utilization of emergency and inpatient services for children and youth. Services include case management, mental health, and psychiatric services to stabilize immediate crisis while linking to appropriate ongoing outpatient services. In FY 2019-20, the program served 243 unduplicated clients.

The annual cost of this program typically ranges from \$0.5 - \$0.7 million. Today's action would authorize a competitive solicitation for walk-in crisis and mobile assessment team services in the North Regions of San Diego County for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

ii. Mental Health Developmental Evaluation Services (Countywide)

On May 22, 2007 (8), and August 4, 2015 (4), the Board authorized the negotiation of a contract for specialized mental health developmental evaluation services for children. These services are provided through the developmental evaluation clinic by licensed psychologists with specialized training and experience in the diagnosis and treatment of children with developmental disabilities. Interdisciplinary teams provide comprehensive evaluations of young children presenting with suspected developmental delays and other concerns. The program provides culturally and developmentally appropriate evaluations of each child's functioning, makes referrals, and consults with caregivers to improve the child's functioning. In FY 2019-20, the program served 914 unduplicated clients.

The annual cost of this program typically ranges from \$0.6 - \$0.8 million. Today's action would authorize a competitive solicitation for mental health developmental evaluation services for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

f. Onsite Care Coordination and Case Management Services (Central Region)

On August 25, 2020 (2), the Board approved funding for onsite care coordination and behavioral health services at new housing projects in the Central Region. The program will serve residents living at two new San Diego Housing Commission (SDHC) housing developments with the goal of increasing housing stability and retention, and linking residents to ongoing behavioral health services. Services include outreach and engagement, screening, behavioral health assessment, case management, crisis intervention, care coordination and linkage to ongoing behavioral health services as appropriate. The services

provided by this program align with current services provided at the Convention Center and temporary County lodging for COVID-19.

The annual cost of this new program is estimated to range from \$2.0 - \$2.7 million. Today's action would authorize a competitive solicitation for onsite care coordination services for an initial term of up to one year, with up to one option year, and up to an additional six months, if needed.

g. Homeless Outreach Worker Services (Countywide)

BHS provides homeless outreach through mental health outpatient treatment programs, and in FY 2016-17, BHS further enhanced services by adding homeless outreach workers (HOWs) in SUD outpatient treatment programs. HOW services include outreach and screening for mental health, physical health, and SUD, along with linkage to services, which may include a warm handoff with community providers to ensure connection. HOWs often outreach to individuals who are underserved in non-traditional settings to link them to services with the goal of improving their physical and mental health and social functioning and engage them into services. In FY 2019-20, HOWs in the substance use disorder outpatient treatment programs conducted 4,317 homeless outreach contacts across all regions.

The annual cost of this program typically ranges from \$1.9 – \$2.5 million. Today's action would authorize a competitive solicitation for homeless outreach worker services for an initial term of up to one year, with up to four option years, and up to an additional six months, if needed.

Recommendation #2: Authorization to Extend and Amend Contracts

Essential BHS contracts, as outlined in Attachment A, Table 1, are currently scheduled to terminate at the end of Fiscal Year 2020-21. The Board previously authorized competitive solicitations for these programs. To ensure continuity of critical services these contracts need to be amended and extended.

If approved, today's actions would authorize an amendment and extension of these programs up to June 30, 2022, and up to an additional six months, if needed. Additional details of these programs can be found in Attachment A, Table 1.

Recommendation #3: Authorization to Extend and Amend Single Source Contracts

Essential BHS contracts, as outlined in Attachment A, Table 2, are currently scheduled to terminate at the end of Fiscal Year 2020-21. The Board previously authorized the single source procurements of these programs. To ensure continuity of critical services these contracts need to be amended and extended.

If approved, today's actions would authorize an amendment and extension of these programs up to June 30, 2022, and up to an additional six months, if needed. The Director of the Department of Purchasing and Contracting awarded the contracts listed in Attachment A, Table 2 under the following Board Policy A-87, Competitive Procurement guidance:

- Section 1.D.3, the procurement is for services from a provider with unique knowledge, skill, or ability not available from other sources.
- Section 2.I, categorical exemption from competitive procurement for medical or surgical equipment or supplies or professional services for use by a County facility.

Recommendation #4: Execute a Cooperative Agreement with the State Department of Rehabilitation for Mental Health Employment Services

On October 16, 2001 (4), the Board authorized the execution of an amendment to the Cooperative Agreement with the State Department of Rehabilitation (DOR). The program provides vocational services for adults experiencing SMI to support them in achieving placement in competitive employment. Services are provided through a contracted provider countywide and include client assessment, short-term support services, and employment services. In FY 2018-19, the program served 182 unduplicated clients, with a success ratio of 50 percent, exceeding the Statewide program success ratio of 41 percent.

Today's action would authorize a revenue agreement with DOR for the employment services program for the period of July 1, 2021 through June 30, 2024, with an increase in revenue match dollars not to exceed \$0.4 million annually, and any amendments thereto, and future years' Agreements and amendments, provided terms, conditions, program services and funding are not materially impacted or altered. The current annual County cost for this program is \$240,948, a 21.3 percent revenue match that leverages State funding of \$1,131,210. The agreement will be enhanced to include the individual placement and support model of supported employment for individuals experiencing SMI.

Recommendation #5: Ratify the Performance Contract Agreement with the State Department of Health Care Services

Under Section 5650(a) and 5847 of the California Welfare and Institutions Code, and Title 9, California Code of Regulations (CCR), section 3310, the California Department of Health Care Services (DHCS) enters into an agreement with the County of San Diego through a performance contract to provide public mental health services. DHCS is responsible for the administration of the Mental Health Services Act (MHSA), Substance Abuse Block Grant (SABG), Projects for Assistance in Transition from Homelessness (PATH) and Community Mental Health Services

Grant (MHBG) programs, in addition to each county’s provision of community mental health services provided with realignment funds.

The performance contract establishes the County’s responsibility to provide an integrated and coordinated range of services appropriate to meet the needs of clients and to implement systemwide performance outcome measurements in San Diego County. In alignment with previous years, DHCS sends forward the annual performance contract agreement for approval after the beginning of the fiscal year; therefore, ratification during or after the contract term is required.

Today’s action, if approved, authorizes the Clerk of the Board to ratify the FY 2020-21 Performance Contract Agreement with the California Department of Health Care Services, amendments thereto, and future years’ Agreement and amendments, subject to the approval of the Director, Health and Human Services Agency.

LINKAGE TO THE COUNTY OF SAN DIEGO STRATEGIC PLAN

Today’s proposed actions support the Building Better Health and Living Safely Initiatives in the County of San Diego’s (County) 2021-2026 Strategic Plan as well as the County’s *Live Well San Diego* vision, by ensuring that vulnerable populations of individuals with mental illness and substance use disorders continue to have access to a comprehensive continuum of behavioral health services administered through accessible behavioral health programs.
