## V. <u>PRESENTATION</u> – HHSA Recommended Fiscal Year 2017-18 Ops Plan – Amy Thompson, HHSA Assistant Finance Director

#### VI. UPDATE - Drug Medi-Cal Implementation Plan Update - Alfredo Aguirre/Judith Yates

Over the last year, the BHAB Drug Medi-Cal (DMC) Workgroup has been meeting with County BHS staff to discuss the impact of implementing a Drug Medi-Cal Organized Delivery System (DMC-ODS) in San Diego County. All of this hard work is leading up to the County's submission of a comprehensive DMC-ODS Implementation Plan and proposed rates to the Department of Health Care Services (DHCS) by May 31, 2017. Alfredo Aguirre and Judith Yates summarized the BHAB workgroup and County staff

actions that have occurred to date. Copies of the DMC-ODS Overview Document, draft Implementation Plan, and draft Implementation Plan Appendices were sent to the BHAB for their review prior to today's meeting.

# VII. <u>ACTION ITEM</u> – Vote to Support Submittal of the Drug Medi-Cal Organized Delivery System Implementation Plan to the Department of Health Care Services – Alfredo Aguirre Background

On January 7, 2016, BHAB voted to establish a priority for Drug Medi-Cal Organized Delivery System (DMC-ODS) Implementation for the 2016 calendar year. On March 3, 2016, BHAB voted to establish a Behavioral Health Advisory Board Drug Medi-Cal (DMC) Workgroup.

Over the course of 2016 and the first quarter of 2017, workgroups within BHS researched other counties' implementation plans, studied service delivery implications (increase staffing, certification by the Department of Health Care Services of Substance Use Disorder providers to bill for Drug Medi-Cal, training needs, etc.) and conducted financial analyses to address questions regarding fiscal sustainability of opting-in to the California Section 1115 DMC-ODS waiver. The BHAB DMC Workgroup also participated in meetings to share concerns and questions about expansion of services and what the implementation would mean for residents of San Diego County experiencing substance use disorders.

After careful consideration of all factors, in March of 2017, BHS executives met and agreed that submitting the DMC-ODS Implementation Plan and proposed rates to DHCS would be an advisable next step. Submission of the plan and rates would not obligate the County to the DMC-ODS waiver implementation. It would provide an opportunity for DHCS to work with the County to finalize the Implementation Plan, with State and Federal input, and negotiate proposed rates. If successful, the County would request Board of Supervisors approval to enter into a DMC-ODS contract with DHCS.

It is, THEREFORE, staff's recommendation that the Board vote to Support Submittal of the Drug Medi-Cal Organized Delivery System Implementation Plan to the Department of Health Care Services by May 31, 2017.

#### **DISCUSSION:**

How is BHS dealing with the State's minimum wage increase?

Putting aside the DMC-ODS, BHS still has to address the issue of the wage increase by raising the
rates of its current alcohol and drug providers. BHS is also working with its other behavioral health
contractors to address this issue.

Have any of the other Counties opted out?

 To date, there have been no counties in Phase I (Bay Area) or Phase II (Southern California and Los Angeles) that have opted out of the DMC-ODS.

How is the County rationalizing the cost (as compared to other Counties) as staff make the rounds to the Board of Supervisor offices?

BHS recognizes that the DMC-ODS will not all be federally subsidized; thus it will require investment
of realignment dollars and investment by our behavioral health partners. All of this will be made clear
to the Board of Supervisors.

ON MOTION of Judith Yates, seconded by John Sturm, the BHAB voted to support the submittal of the Drug Medi-Cal Organized Delivery System Implementation Plan, with discussion as noted above. AYES: 12 NAYS: 0 ABSTENTIONS: 0

VIII. <u>ACTION ITEM</u> – Vote to Establish a Workgroup to Amend the Behavioral Health Advisory Board Bylaws

#### Background

The BHAB Executive Committee recommends consideration of revisions to the BHAB Bylaws. Such revisions include the clean-up of certain Bylaw provisions to reflect amendments to Section 5604 of the Welfare and Institutions Code related to advisory board membership. At the BHAB meeting on April 6, it was announced that an ad-hoc Workgroup would be formed and that interested participants should inform BHS staff prior to today's meeting.

Today's action recommends the formation of an ad-hoc Workgroup with the following parameters:

- 1. Workgroup to consist of a minimum of three BHAB members including one member to be designated as Chair. Since the announcement at the April meeting, Tom Behr has volunteered to Chair; Jenifer Mendel and Deanne George have volunteered to serve as Workgroup members.
- 2. Workgroup will meet in May and June (frequency to be determined) to create a draft of the amended Bylaws with a final draft due to the BHAB Chair and BHS staff in early July.
- 3. Workgroup Chair will return to BHAB in August to review the recommendations and seek approval to proceed with changes.
- 4. The final draft of Bylaws (and required Board Letter to be drafted by BHS staff) to be presented to the Board of Supervisors in September 2017.

It is, THEREFORE, staff's recommendation that the Board vote to Establish a Workgroup to Amend the BHAB Bylaws and Accept the Members.

#### DISCUSSION:

Tom Behr, Jenifer Mendel, and Deanne George were appointed earlier by the BHAB Executive Committee. No vote was taken.

#### IX. <u>DIRECTOR'S REPORT</u> – Alfredo Aguirre, Director, Behavioral Health Services

- Affordable Care Act (ACA) update
  - The House voted today to repeal and replace the ACA with the American Health Care Act (AHCA). The vote now goes to the Senate, so the County will wait and see the results and what the ultimate amendments will look like. A replacement likely will have ramifications on funding. For example, if Medicaid is significantly cut or block granted, what will it mean for the State and current entitlements? Once this is known, it will shape the direction the County will go in term of its contracts with the Department of Health Care Services.
- May is Mental Health Month event highlights
  - The NAMI Walk and HHSA Wellness Expo on Saturday, April 29, was a great success. Supervisor Kristin Gaspar and HHSA Director Nick Macchione were in attendance.
  - Two events on Saturday, May 20: Changing Minds-Minds Matter Resource Fair at Chula Vista High School and the annual Fellowship Center Walk for Recovery Health Fair in Escondido.
  - o A complete calendar of events was distributed and posted on the BHS website.
- Behavioral Health Recognition Dinner will be held on Friday, June 9, at the San Diego Marriott Mission Valley. More details to come.
- Directing Change Screening and Awards will take place this year at the California Center for the Performing Arts in Escondido on Thursday, May 11, 11:00 am-2:00 pm. A list of the regional winners along with the event invitation was emailed to the BHAB.
- Posted for public comment are the guidelines for the No Place Like Home statewide initiative. A copy was emailed to the BHAB.
- Kudos to Yael Koenig and her team for a successful and fun Children's Mental Health Well-Being Celebration event held Wednesday, May 3, 4:00-6:00 pm at East County Community Center in Spring Valley.
- Alfredo Aguirre will not be attending the June BHAB meeting due to another statewide organization's strategic planning meeting he has to attend outside the county. Dr. Michael Krelstein, Clinical Director, BHS will cover the BHAB meeting in his place.

## X. <u>CHAIRPERSON'S REPORT</u> – Phil Deming, Behavioral Health Advisory Board Chair Action Item: Change in Meeting Time

Behavioral Health Advisory Board (BHAB) meetings are currently held at the County Administration Center (CAC) on the first Thursday of each month from 3:30p-6:00p.
