# VI. <u>ACTION ITEM: ALLOCATION OF FUNDING FOR PERMANENT SUPPORTIVE HOUSING PROGRAM BOARD LETTER</u>

# Alfredo Aguirre, Director, Behavioral Health Services

The Mental Health Services Act (MHSA), provides funding for counties to address a broad continuum of prevention, early intervention and service needs, and the necessary infrastructure, technology and training elements to effectively support the public mental health system. The funds are utilized for capital loans for the development, acquisition, construction and/or rehabilitation of permanent supportive housing. This recommended action requests the Board of Supervisors to approve the transfer of up to an additional \$10 million to California Housing Finance Agency (CalHFA) for the Special Needs Housing Program (SNHP) to develop new permanent supportive housing units.

### **DISCUSSION:**

**Q**: Is this funding coming out of the MHSA budget?

**A**: This funding is coming from the unspent MHSA fund.

Q: Does the County of San Diego own any subsidized housing?

**A**: The County of San Diego does not directly own subsidized housing.

## VII. PRESENTATION: METHAMPHETAMINE IN SAN DIEGO COUNTY

### **Linda Bridgeman-Smith, Prevention Services Coordinator**

Linda Bridgeman-Smith came before BHAB to present on methamphetamine use in San Diego County. There has been a steady increase in methamphetamine related issues including deaths and misdemeanor or felony arrests for methamphetamine sales and possession. Currently, 55% of male arrestees and 58% of female arrestees test positive for methamphetamine. The County of San Diego continues to utilize law enforcement, substance use disorder treatment, and wrap around services for families to combat the issue.

### **DISCUSSION:**

- **Q**: What are the factors that keep methamphetamine a consistent problem within San Diego County?
- A: Methamphetamine is easy to obtain. There are also cultural elements of methamphetamine use being accepted within certain parts of the community. Users are experimenting, having mental health issues, or might be going through a tough time and are using methamphetamine. When methamphetamine is readily available, people will use it.
- Q: Based on the knowledge of methamphetamine, are there prevention efforts to reduce use?
- A: San Diego County is a border region and methamphetamine comes across the border. San Diego utilizes law enforcement and border patrol to try and prevent methamphetamine from coming into the County. There also education, drug treatment systems for substance users, and wrap around services for families.
- **Q**: Is the relative rate of methamphetamine used at a higher rate in San Diego County or nationally?
- **A**: There is a growing concern of methamphetamine use nationally. However, San Diego County is the only region that tracks methamphetamine this closely for the longest period of time.
- **Q**: Is liquid methamphetamine a problem?
- **A**: Liquid methamphetamine continues to be a problem because it is easier to transport. Also, drug sniffing dogs don't alert to liquid methamphetamine as quickly. It is easier to bring across the border than traditional methamphetamine.

- At the Behavioral Health Recognition Dinner, it was announced the Mental Health Person
  of the year is Walter Phillips, Executive Director for San Diego Youth Services and the

- Walter Hekimian from Edgemoor received a leadership award for overseeing the Edgemoor facility.

Health Services Advisory Board (HSAB) meets on the first Tuesday of every month. They
reported a drop in HIV/AIDS cases in San Diego County. The handwashing stations and
restrooms that were implemented due to the Hepatitis A crisis have been removed.

### XI. BOARD MEMBER COLLABOARATION:

An issue was raised that the Annual Homelessness Point in Time Count was not correct because it did not count individuals in RV's or Cars.

The closure of 12 step programs was not an anticipated consequence of the implementation of DMC-ODS (Drug Medi-Cal Organized Delivery System). The closure is not required as there was no language that stated programs had to end 12 step programs. The providers have the ability to close their 12 step programs as business decisions. Providers also have the ability to not be DMC certified. If a provider has multiple locations, each location needs to be certified which could prompt them to move certain services to certain locations.

Annual QI Knowledge Forum is on July 25<sup>th</sup> at the Scottish Rite Center. The forum looks at the new regulations from the State that need to be implemented and what areas to focus on for the upcoming year.
