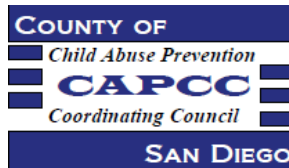
- Review and approve the Community Services for Families (CSF) Program Board Letter (Motion/Second/Vote)

- *Parent Summit and Family Resource Fair - Save the Date flyer was distributed. We welcome our members and the community to join the committee. Ideas and suggestions are welcome for speakers and break-out sessions. Meetings will be held in-person to alternate with Webex meetings. Parent Summit Goals and Themes for Resource Fair: to encourage the use of services; to facilitate community support for prevention of child abuse and neglect; and to increase acceptability of services for all parents.*
- *Community Prevention Framework – Finalizing report and information from Strategies from the Community Prevention Dialogues; come up with a document summary of our guiding principle.*
- *Probation has the Racial Ethnic Disparity Council coordinated by The Children’s Initiative that will be beneficial to work with.*
- *Partnership with CASEY – Do small tests of change: PLAN, DO, STUDY, ACT*
- *Strategies: Goal to have partnerships that focus on father-friendliness, importance of fatherhood and father involvement. CWS coordinates the case plans to engage fathers, dependent on youth to start with phone calls and building up to that relationship; put staff training on the agenda, evidence-based importance of involving both parents in a child’s life.*
- *Probation Department is offering parenting skills for youth although they are not encouraging young adults to be in a relationship and have kids out of wedlock. Be realistic and set them up for success together.*
- *One of the modules received for CSF is Healthy Relationships. Help youth build a healthy relationship to parent together for the well-being of the child.*

Introduction:

Title IV-E Waiver- California Well-Being Demonstration Project

- *Title IV-E Waiver-California Well-Being Demonstration Project is a 5-year project that started on October 1, 2014.*
- *Powerpoint presentation*
- *All Demonstration counties must use two strategies to focus on areas of prevention, family engagement, and after care. The strategies are Family Centered Practice: Safety Organized Practice (SOP) for CWS and Probation’s Prevention: Wraparound for probation youth exhibiting delinquency risk factors that put them at risk of entering foster care.*
- *Focus on evidence-based practices for both Prevention, Intervention and After-Care*
- *CWS’ funding has been based on a formula from the 1996 federal TANF. The funds can only be spent on open CWS cases. With the Waiver, the federal funding is changed to a capped allocation. This will provide flexibility to reinvest savings on Prevention.*

- *San Diego Dads is one of the very few comprehensive programs for fathers in San Diego County, may refer any fathers and families who need support and employment assistance. They provide SafeCare and Home Parenting, workshops, legal clinics, and counseling.*
