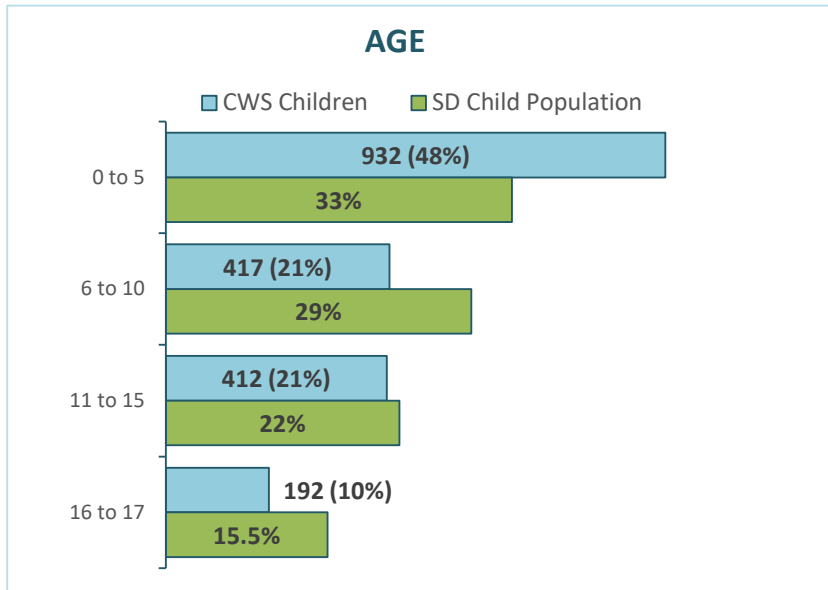

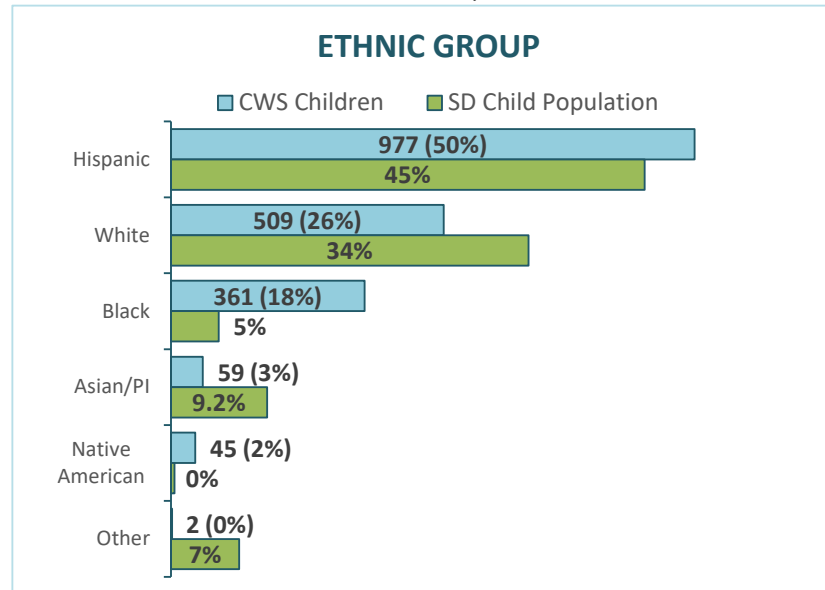


PLACEMENTS - POINT-IN-TIME ON JULY 1, 2019 (Children 0 to 17)

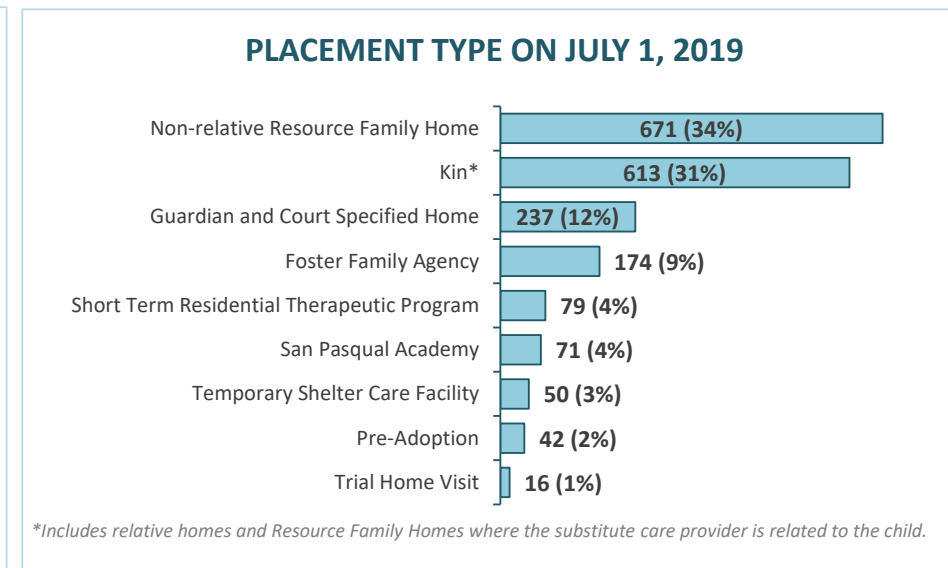
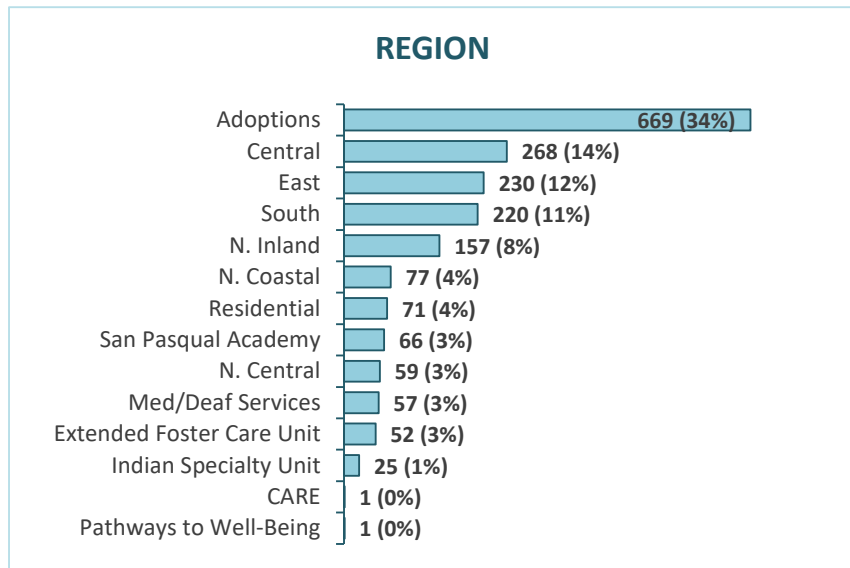
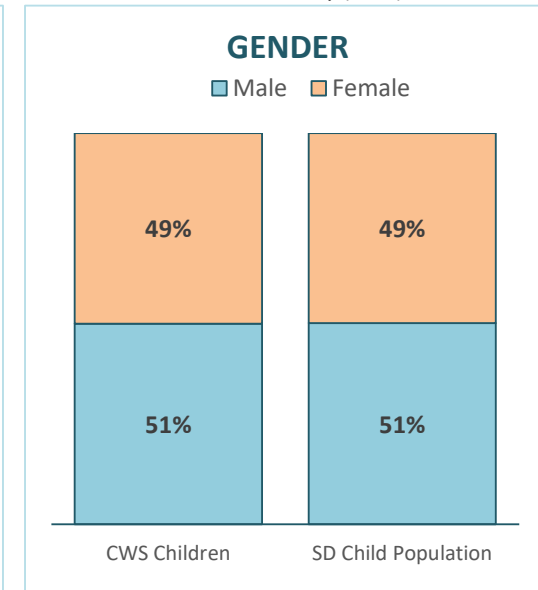

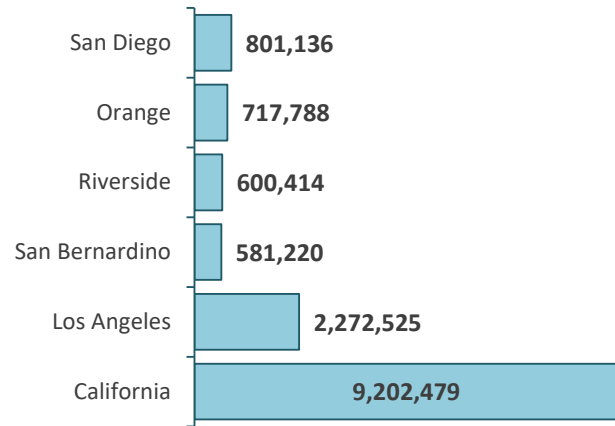

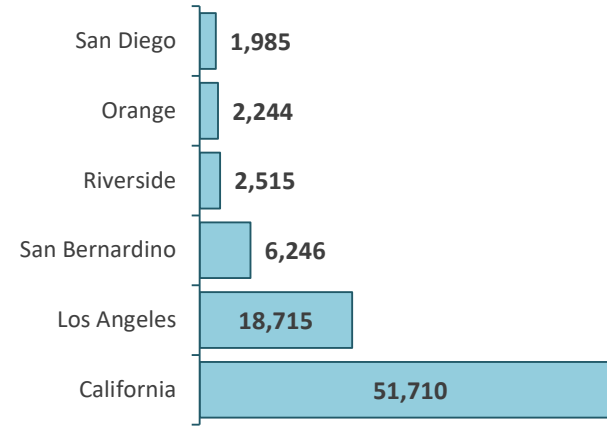

PLACEMENTS - FIVE COUNTIES WITH THE HIGHEST CHILD POPULATION COMPARISON ON JULY 1, 2019

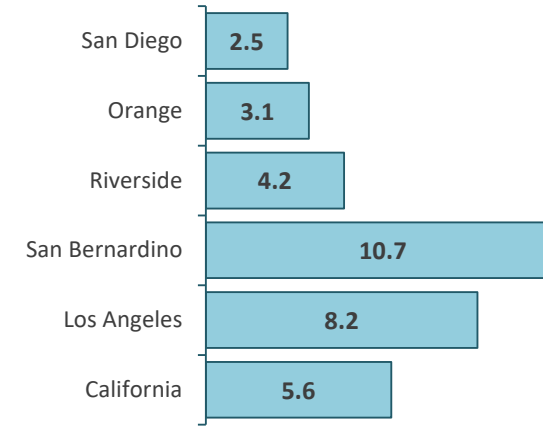
TOTAL CHILD POPULATION (0 to 17)



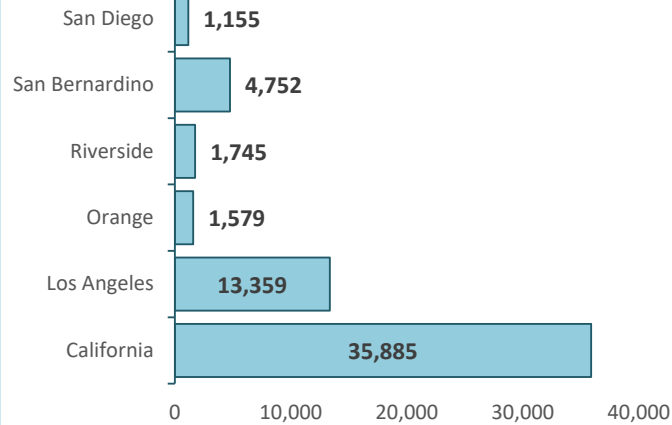
TOTAL CHILDREN IN OUT-OF-HOME



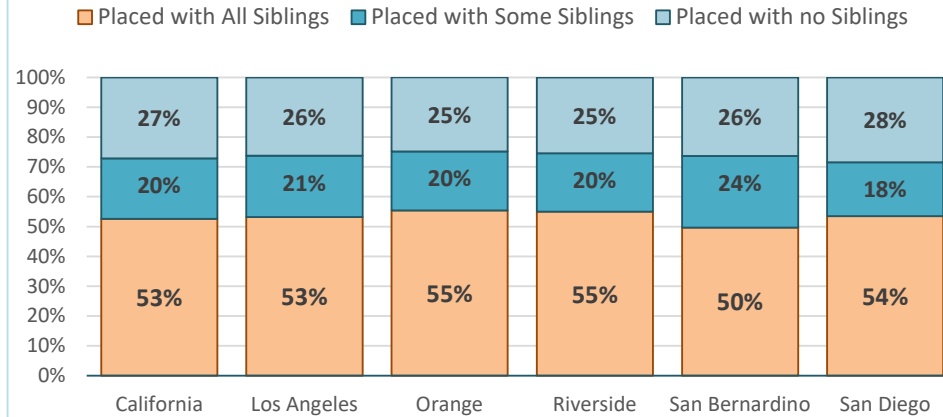
RATE OF CHILDREN IN OUT-OF-HOME CARE PER 1,000 CHILDREN



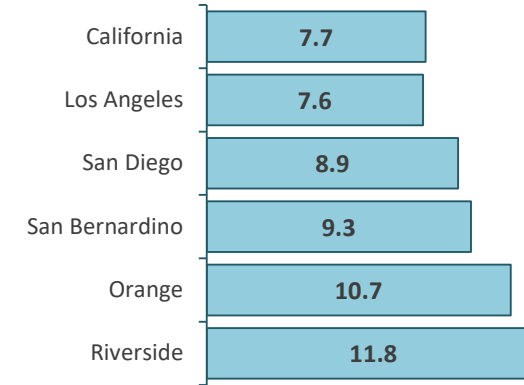
NUMBER OF CHILDREN WITH SIBLINGS JULY 1, 2019

ABUSE IN FOSTER CARE - INSTANCES PER 100,000 DAYS IN CARE



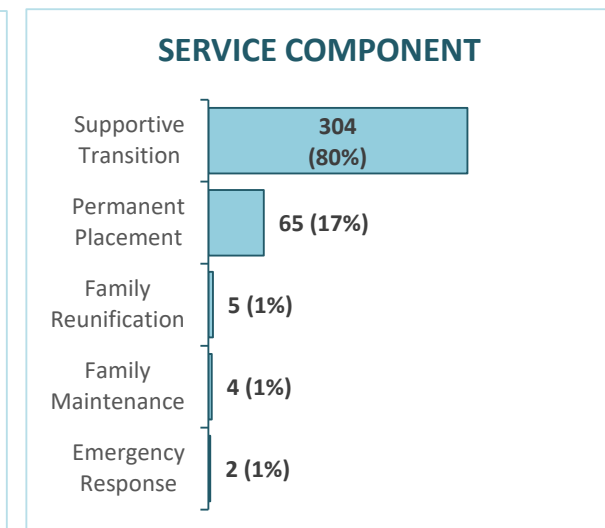
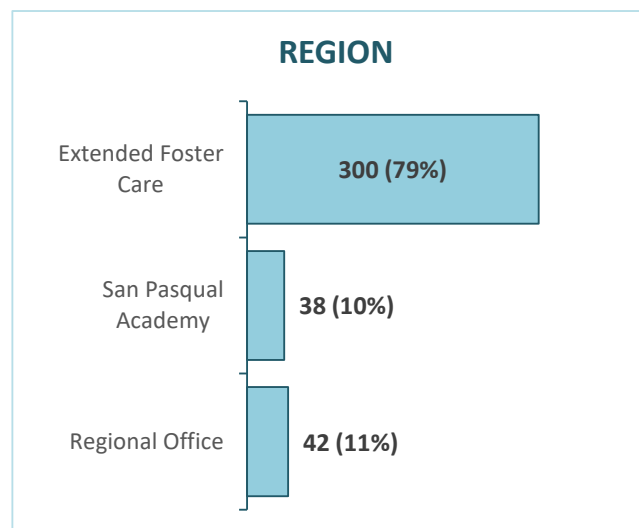
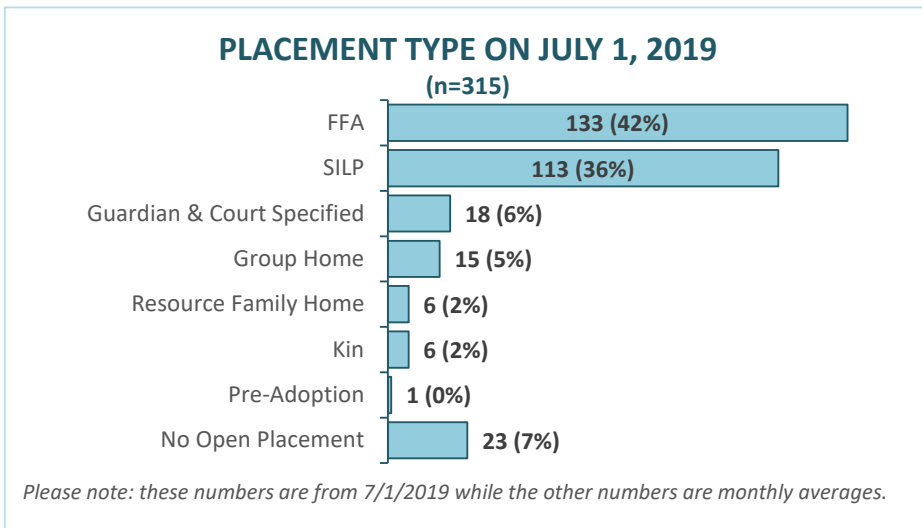
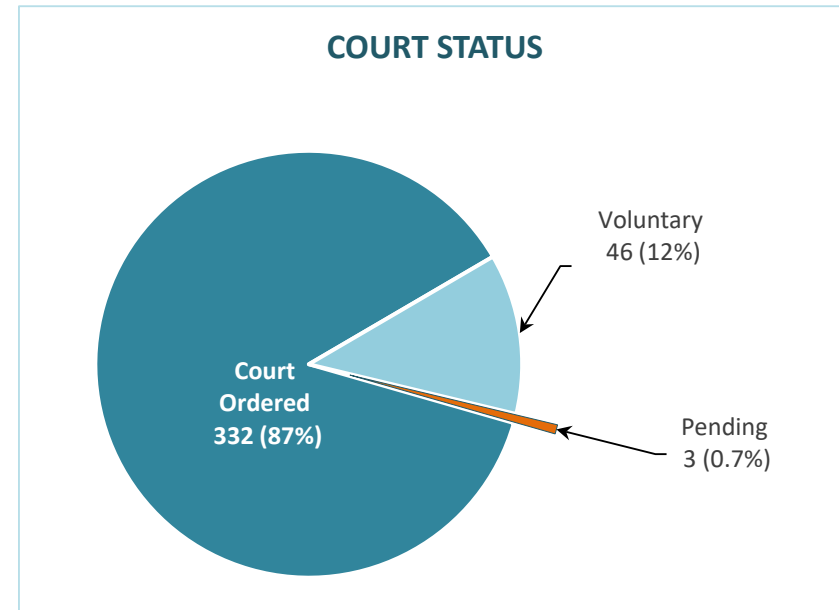
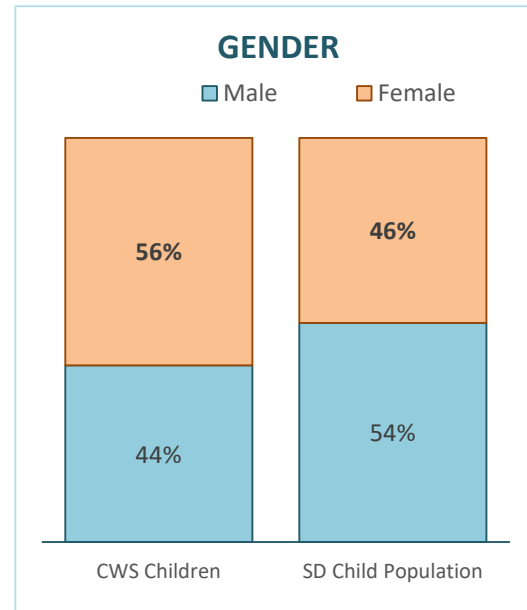
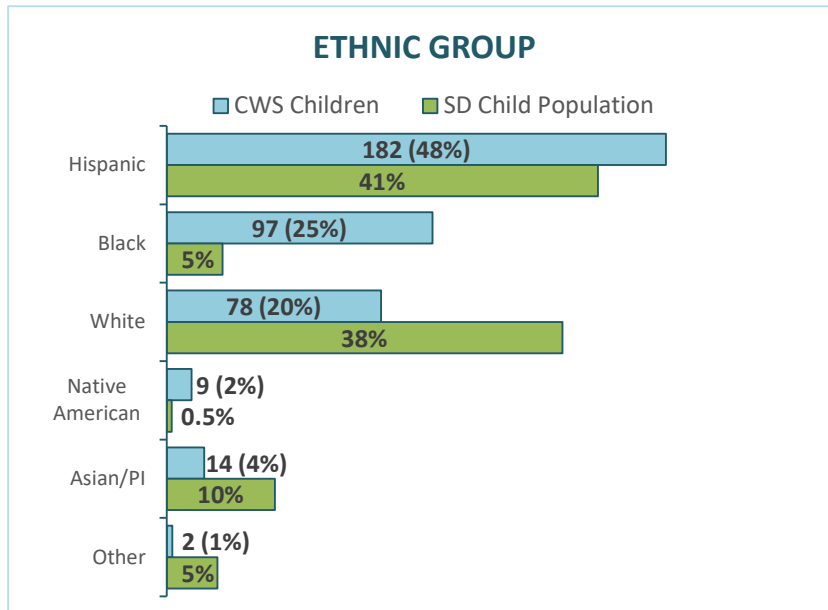
