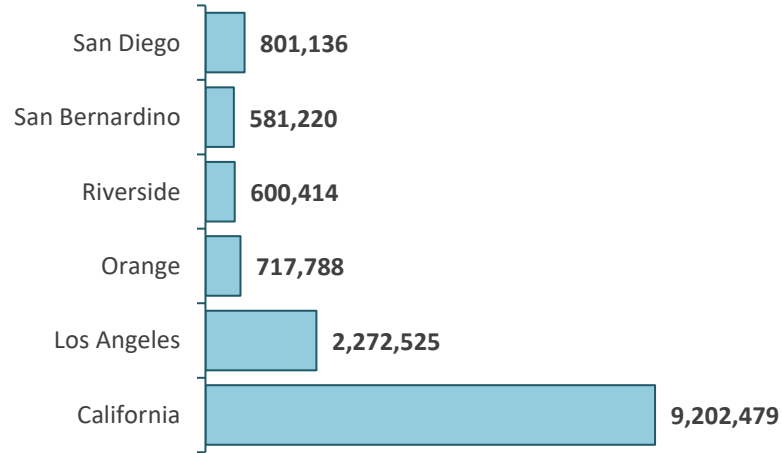

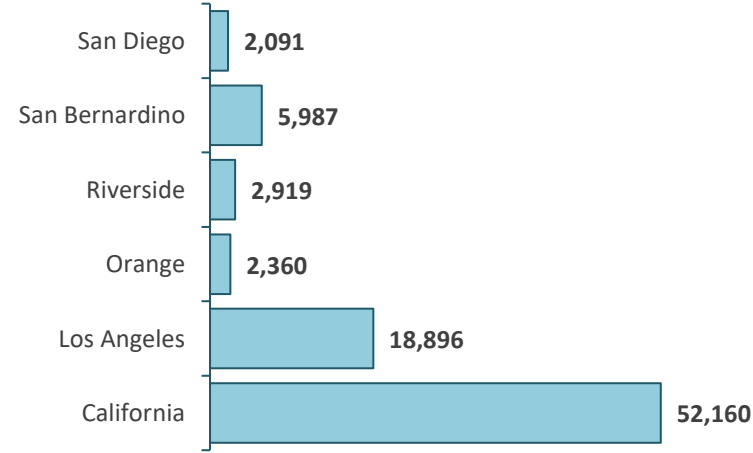

PLACEMENTS - FIVE COUNTIES WITH THE HIGHEST CHILD POPULATION COMPARISON ON Apr 01, 2020

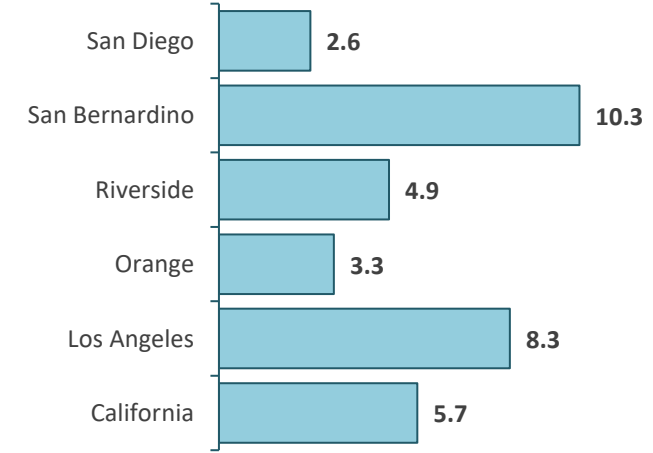
TOTAL CHILD POPULATION (0 to 17)



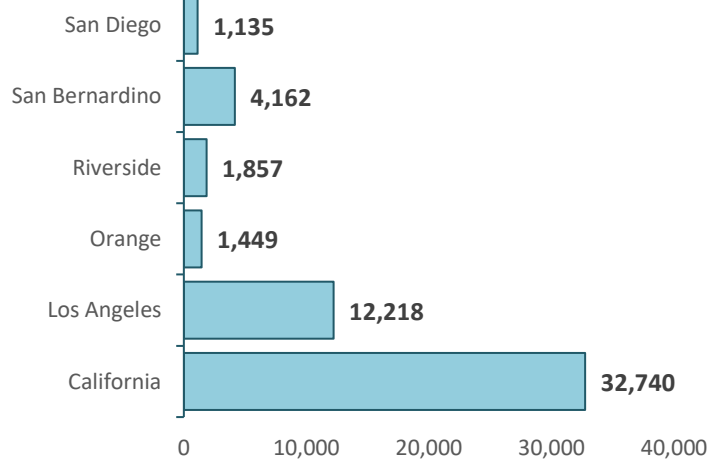
TOTAL CHILDREN IN OUT-OF-HOME



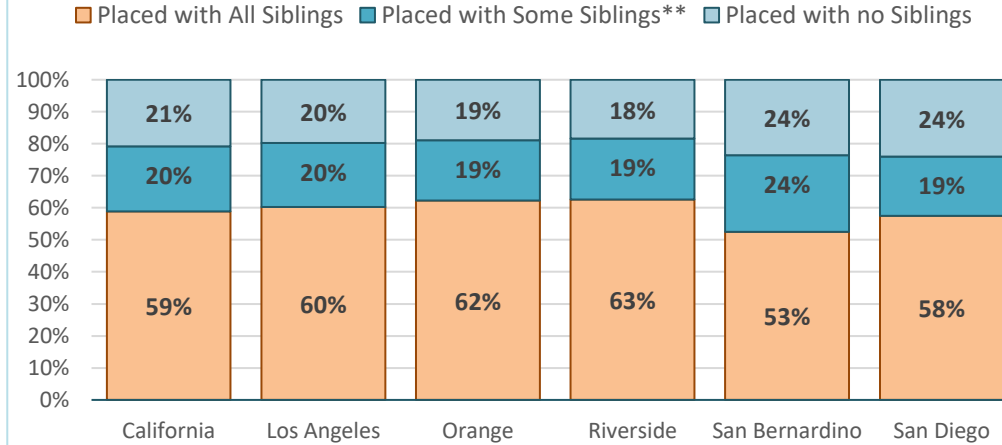
RATE OF CHILDREN IN OUT-OF-HOME CARE PER 1,000 CHILDREN



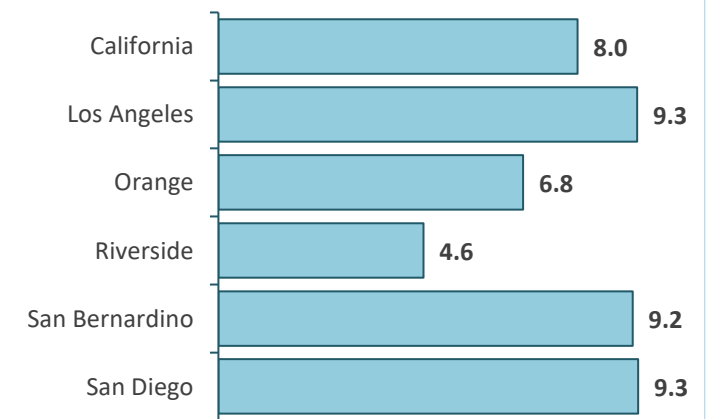
NUMBER OF CHILDREN WITH SIBLINGS JULY 1, 2019

ABUSE IN FOSTER CARE - INSTANCES PER 100,000 DAYS IN CARE



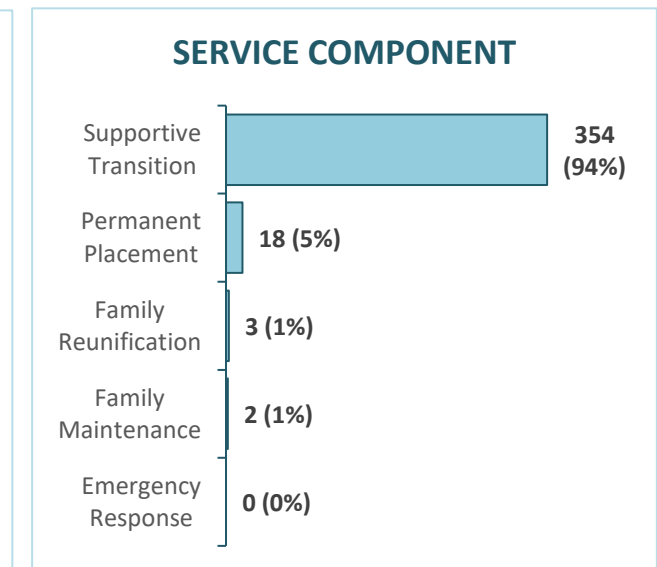
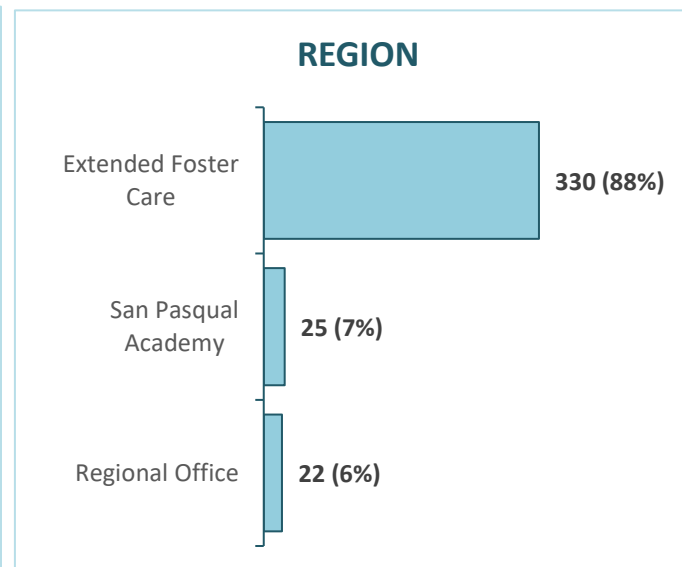
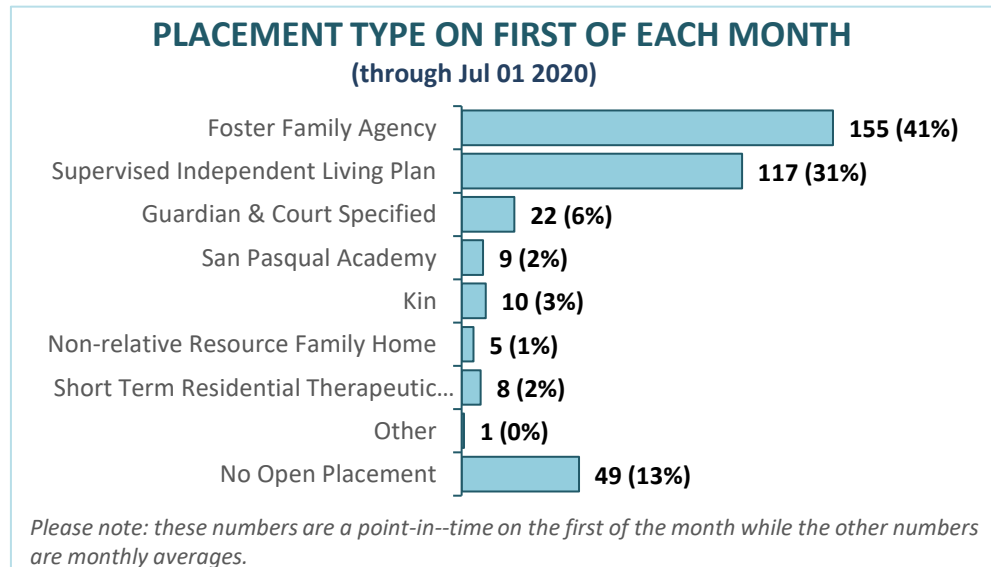
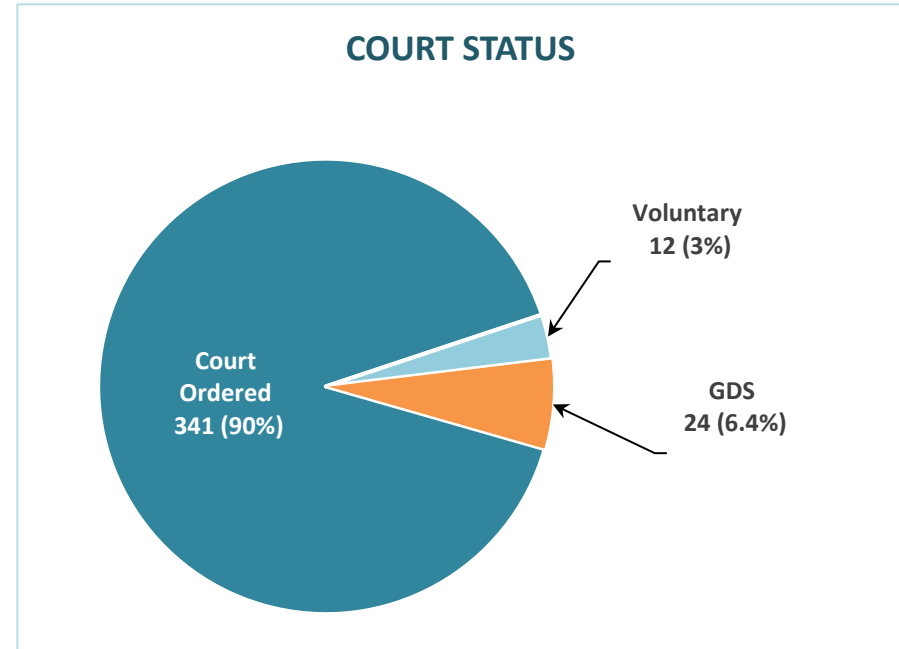
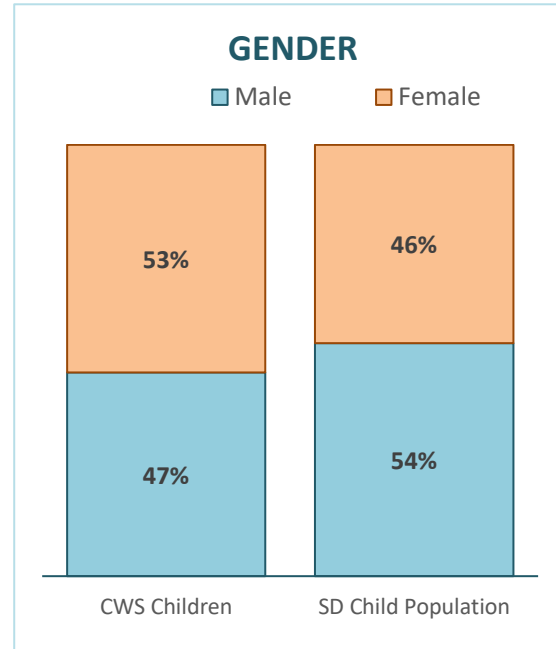
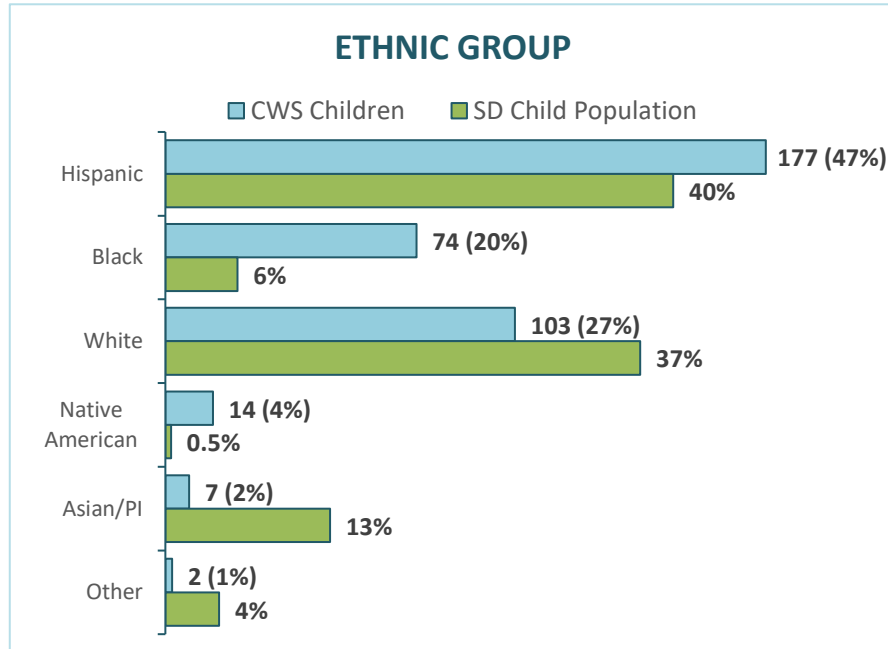
