- We will possibly be doing an Easter basket giveaway, more to come on that.
- I have had some people approach me with some questions: "What is the purpose of having meetings with HHSA when the same issues continue to arise and it isn't addressed but per HHSA it has been addressed and that it is case specific. However, the same concerns are still not being corrected. Will HHSA start putting things in to practice with Social Workers as a whole instead of as the issues arise." Examples are: Breach of confidentiality, CFT's not being conducted when they are forgotten, Transition are not being done properly. We want to know if these policies and procedures can be put into practice instead of taking things as a singular event. Where are the policies for Special Care Rates and where we can find them and we want to know how far out can HHSA go on written directives. Will send email to Diana Macis stating concerns so we can address.
- We have a foster/adoptive home that is offering boomerang lessons for foster youth which we have about 8 youth doing that, which is free of charge to the adoptive home.

- We wanted to share, last year the decision was made for CWS to take over RFA for probation.
  We will be approving all the homes for probation youth and monitoring those homes once they

## Foster & Adoptive Resource Family Services (FARFS)/Quality Parenting Initiative (QPI)-Diana Macis

- We will be sending out an email reminder for our last training with Casey Family on Brain Mapping which is next Wednesday (March 17<sup>th</sup>).
- We are currently planning a virtual QPI appreciation event this year, it will be done be Region and each region will nominate a resource parent and community partner that they would like to honor. The event will be in May and invitation will go to the regions (we divide the Resource Parent list by region).
- By the end of this month, we will be starting our Akido pulse survey, which will go out via text. We are starting with a small group of caregivers, caregivers who were approved within the last year and a half they will get a text survey on their phone, which will be a series of five questions. Akido Labs is the agency the Youth Law center has contracted with and we are one of the pilot counties that will be doing the survey. They will gather all the information and report back to what, and us, which can potentially help guide our practice and follow up on what is working well is not working well. The survey will be anonymous and for those who wish to disclose their name for follow-up the will be filtered through our OMBUDS kids line.
- We our flyer done both in Spanish and English we will send that out to the group here and the resource parent community as well.
- We started our Options training last week, we have about 23 people in training 11 of those are new Caregivers.
- We still have QPI masks please let me know if you are in need of any.

- Trudy in Retention will be retiring on 3/25/2021; Lorena Murrieta will be returning to FARFS and taking over the Kidsline position.
- Our Placement Coordinators Office is in the process of hiring a worker for Jennifer who is the Senior PSW.
- Options Spanish support Group that will take next week (3/17 from 3pm-5pm). The topic will be "Working with birth parents who have trauma history".

## Comprehensive Assessment & Stabilization Services (CASS) – Lisa Castagnola and Josie Lewis

- We have a new Spanish speaking Clinician (Jessica)
- We are still providing in-home services via in person or via Tele-Health depending on the preference of the family. We currently still have no waiting list.

## **Independent Living Skills (ILS)-Steven Wells**
