Important Information for Health Care Providers to Prevent Childhood Lead Poisoning



UPDATED BLOOD LEAD REFERENCE VALUE

In October 2021, CDC updated the blood lead reference value (BLRV) from 5 micrograms per deciliter (mcg/dL) to 3.5 (mg/dL). Healthcare providers are encouraged to provide retesting and follow-up for blood lead levels ≥ 3.5 mcg/dl.

California Health Care Provider Mandates

Under California state laws and regulations, all health care providers are required at each periodic assessment to:

- From 6 months to 6 years, inform all parents and guardians about:
 - oThe risk & effects of childhood lead exposure.
 - oThat children enrolled in Medi-Cal receive blood lead tests.
 - oThat children not enrolled in Medi-Cal who are at high risk of lead exposure receive blood lead tests.
- At both 12 & 24 months of age:
 - °Screen all children in publicly supported programs for low-income children. °Assess all children not in a publicly supported program for low-income children by asking: "Does your child live in, or spend a lot of time in, a place built before 1978 that has peeling or chipped paint or that has been recently remodeled?
 - °Obtain blood lead test if the answer is "yes" or "don't know"

Receive a call back from a Public Health Nurse and/or Health Education Specialist. Voicemails are checked during regular business hours and returned within 1- business day.

Tips for parents to protect their children from lead exposure

- 1. Get a blood test
- Check the child's home for lead most are exposed to lead by chipped or peeling paint in homes built before 1978
- Give your child healthy foods— healthy foods with calcium, iron and vitamin C may help keep lead out of the body
- 4. Regularly wet-mop floors and windowsills
- Shower and change clothes and shoes after working around lead-based products
- Avoid certain children's products and household items that may contain lead

Hazard: The markings on the outside of bottles contain levels of lead that exceeds the federal lead content ban.

Name of Product: Children's Desks and Chairs Hazard: Surface paint on the desks and chairs contains levels of lead that exceed the federal lead paint ban, posing a lead poisoning hazard.

Hazard: The toys' yellow poles contain levels of lead that exceed the federal lead content ban.

Hazard: Components of the promotional fishing duck contains a level of lead that exceeds the federal lead content standard.

Hazard: Surface paint on the brown bell found in "Day 10" of the advent calendar contains levels of lead that exceed the federal lead paint ban.

Hazard: The metal zipper slider, zipper 0-ring, d-ring, rivet and stud of the children's handbags contain levels of lead that exceed the federal lead content han

Name of Product: Adam the Apple™ Children's Stackable Toys

Hazard: Surface paint on the wooden toys contains levels of lead that exceed the federal lead paint ban.

Hazard: Paint on the wood wagons, the plastic handles, the red plastic cover contain levels of lead. That exceed the maximums allowed.

Hazard: Paint on the zipper pull contains levels of lead that exceed the maximums allowed.

Name of Product: Arc Collection Furniture Hazard: Surface paint on the furniture contain levels of lead that exceed the federal lead paint ban, posing a risk of lead poisoning.

Name of Product: 10-in-1 Incredible Inventions Science Kits

Hazard: Paint on the red and blue magnet contains levels of lead.

Name of Product: Ron Jon Surf Shop Sippy Cup Hazard: The plastic characters on the recalled Sippy Cup contain levels of lead that exceed the federal lead content ban and contain levels of a regulated phthalate that exceed the prohibition of specific phthalates.
