^{*}Primary vaccine series completion is defined as receipt of 3 vaccine doses for persons who received Pfizer-BioNTech, or those who received a bivalent Pfizer-BioNTech for their third dose in the 3 vaccine dose Pfizer-BioNTech series, or receipt of 2 doses for persons who received Moderna. Immunocompromised status cannot be determined, the recommended primary vaccine series schedule is not listed for immunocompromised individuals aged 6 months to 4 years.

^{**}Rates are calculated using 2019 population estimates from the San Diego Association of Governments.

^{***}HHSA Region determined by resident zip code or city; some zip codes not available.

^{****}Persons of Hispanic/Latino ethnicity may belong to any race group. All categories except Hispanic/Latino include persons for whom race is known but ethnicity is non-Hispanic or unknown. This report categorizes "Multiple Races" as "Other Race" so all people who report being multiple races are categorized as "Other Race." "Other Race" may not have a standardized definition across data collecting entities or among patients reporting their own demographics. ^The percentage and rate of the population vaccinated with a completed primary vaccine series may approach, or exceed, 99% or 999 per 1,000 San Diego residents under 5 years of age. The most recent age, gender, region, and race/ethnicity population are 2019 estimates, which may under estimate the current population. When these demographics are analyzed, the population estimates may not reflect social and environmental changes of a community, possibly leading to an under- or overestimate of a population.
