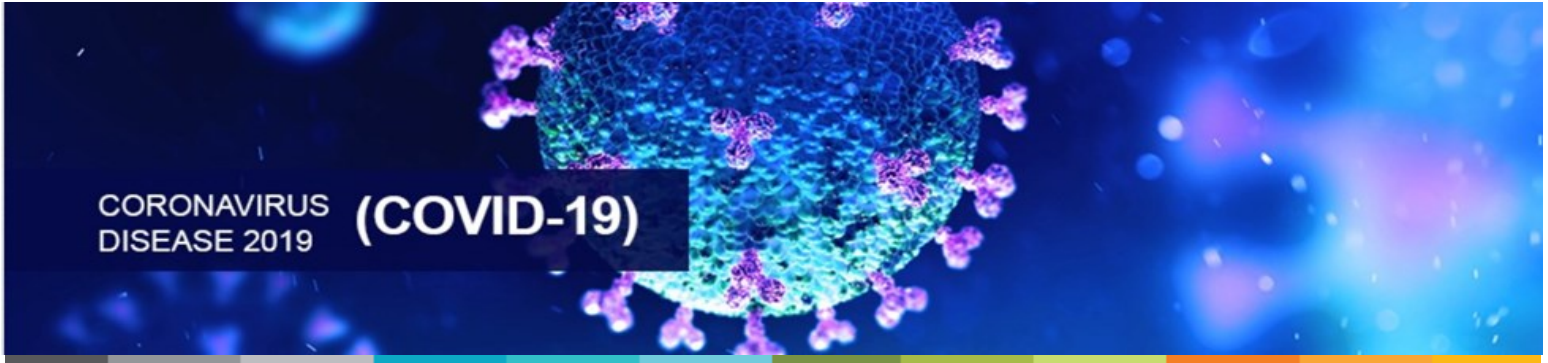

# County of San Diego COVID-19 Telebriefing Instructions



## Option 1- Computer (preferred):

- ◆ Click on the **PARTICIPANT LINK** for your sector using your computer, and type in the associated **MEETING ID**.
- ◆ All participants will be muted during the meeting. In order to submit questions during the call, use the chat feature on the Zoom platform.

## Option 2- Phone:

- ◆ Call into the meeting using the **CALL-IN** number for your sector using the associated **MEETING ID**.
- ◆ All participants will be muted during the meeting. If you call into the meeting, you will not have the opportunity to submit questions during the call.

You may submit questions at least 24 hours before each Telebriefing by using the link “**To send your questions prior to Telebriefing**” in the selected sector.
