TOBACCO RETAIL LICENSE FEE

WHAT IS THIS ABOUT?

In anticipation of the County of San Diego's upcoming **Tobacco Retail License fee**, you are invited to participate in one of three community forums about the fee and what you can expect.

On December 8, 2020, the County Board of Supervisors approved a new Tobacco Retail Licensing Ordinance for the entire unincorporated region of the county. The Ordinance requires retailers to obtain a license to sell tobacco products and to comply with certain operating and tobacco product requirements. The Ordinance went into effect on July 1, 2021. **Effective July 2022, an annual TRL fee will be required to obtain a license.**

The County Board of Supervisors will consider the amount of the fee and approve it on **Tuesday, May 24, 2022**. If you wish to participate in the Board meeting and/or comment on the item, you can visit the **Clerk of the Board** webpage on the County website at:
