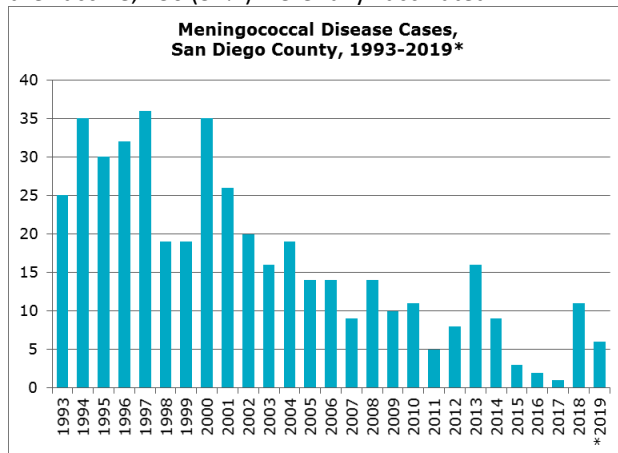
**Public Health Officer's Report**

**I. Communicable Disease Issues**

**A. Infectious Disease Issues**

**1. Meningococcal Disease Outbreak (CAHAN sent on September 28, 2018)**

- There were three San Diego State University (SDSU) undergraduate students diagnosed with serogroup B invasive meningococcal disease (IMD) between June and September 2018. The County is collaborating with and supporting SDSU in a response to this outbreak.
- A meningococcal outbreak was declared on campus on 9/28/18 after the third case in just over three months was diagnosed (onset dates: June 9, September 2, and September 25).
- The June case was later determined through testing at the Centers for Disease Control and Prevention to be a different strain of the meningococcal serogroup B bacteria, unrelated to the other two cases.
- The local health officer recommended that all unimmunized SDSU undergraduate students 23 years of age and younger get vaccinated with one of two available meningococcal B vaccines.
- Serogroup B was found in 37% of San Diego County cases between 2008 and 2018 and accounted for seven of the eleven cases reported in 2018. Serogroup B has been the cause of 11 U.S. university/college outbreaks since 2008, including two others in California: one at the University of California Santa Barbara, in 2013, and one at Santa Clara University, in 2016.
- No new meningococcal cases have occurred at SDSU since the last case with onset of symptoms on September 25, 2018.
- In 2018, eleven meningococcal disease cases were reported in San Diego County, the highest number reported since 2013.
- SDSU is continuing their campaign to get students to bring in their vaccination records if they have been vaccinated out of San Diego County for Meningococcal B. SDSU is also continuing their second dose campaign.
- SDSU students returned to campus in late January; efforts to educate and vaccinate them are continuing and vaccine is being offered to new students arriving on campus as second semester enrollees. The County and SDSU conducted four mass vaccination clinics this semester in addition to supporting other ongoing vaccination opportunities. The first 2019 vaccination clinic took place on 2/20/2019, with 160 doses given. On 2/27/19, 330 doses were administered; on 3/5/2019, 152 doses were administered; and on 3/21/2019, 153 doses were administered.
- As of 3/21/2019, utilizing the new spring roster of undergraduates currently on campus for analysis, 8,241 (35%) of undergraduates 23 years of age and younger had received at least one dose of the meningococcal B vaccine (the target is 55%); 3,381 (14%) were fully vaccinated. Among students living in the traditional residence halls, where the goal is to vaccinate 90%, 1,581 students (69%) had received at least one dose of the vaccine; 736 (32%) were fully vaccinated.



- On 4/16/2019, a new case of meningococcal disease was reported to Public Health Services, Epidemiology Program. After investigation and subsequent lab testing, this case was confirmed for serogroup B. The response actions to this case included post-exposure prophylaxis (PEP) for close contacts. In addition, a PEP and vaccine event was held at SDSU on 4/18 and 4/19 resulting in 315 doses of PEP medication and 114 Men B vaccines being administered.
  - As of 4/23/2019, those who received any vaccination (either fully or partially vaccinated) was 9,152, which is 34% of the student population 23 years of age and younger.
  - There have been six cases so far in 2019, including one additional case associated with SDSU as noted above.
  - Point of Dispensing (POD) vaccination clinics were held on April 23, 2019 and May 2, 2019.
  - **As of 5/28/2019, there have been no additional cases of meningococcal. The school year concluded with graduation ceremonies through May 19, 2019. The most recent vaccination outcomes for this outbreak are from May 9, 2019 and include: those who received any vaccination (either fully or partially vaccinated) for those in the fall student body was 9,237 which is 35% of the student population 23 years of age and younger. To date, 8,660 (37%) of t students 23 years of age and younger have been vaccinated.**
  - **There are no planned vaccination events for the summer. However, SDSU will continue to offer the Men B vaccine through their student health services clinic. In the fall, all new students will be required to vaccinated with both meningococcal vaccinations. Through President's Executive Order, in fall 2020, the CSU system is recommending that students have both vaccinations.**
2. **Seasonal Influenza**
- Influenza activity has been steadily decreasing in recent weeks. dsdfs
  - The last Influenza Watch weekly surveillance report of this season was released May 8, 2019
    - 9,373 reported influenza cases for the season to date
    - 68 deaths
    - 27 lab confirmed flu outbreaks
  - Because, influenza cases are detected each week of the year, ongoing monitoring will continue.
3. **Measles**
- There have been NO CASES of measles in San Diego during 2019.
  - Ongoing measles hot spots around the world continue to require extra vigilance by San Diego County.
  - Numerous suspect measles reports have been received and require immediate attention. So far, no local confirmed cases have been reported.
  - Two CAHAN alerts went out on **January 31, 2019** and **April 25, 2019**.
  - A press release was sent out on **May 2, 2019**.
  - An on camera interview with ABC news, Channel 10 was conducted with Dr. Dean Sidelinger on May 2, 2019.
  - **Weekly Situational Reports (SitReps) are being produced weekly, including cost analysis updates provided.**
    - As of May 18, 2019, there have been 67 reported suspect cases of measles which required evaluation and investigation. None of these have been confirmed to be a case of measles.**
    - Between January 1, 2019 and May 18, 2019, the cost to the county to respond to increased measles activity has been \$35,273. Of this, \$13,593 are costs due to increased lab testing of specimens for suspect case.**
4. **Increased Influenza-like Illnesses at Migrant Shelter**
- **On May 24, 2019, a San Diego CAHAN was issued to inform the local medical community about an increase of influenza-like-illness (ILI) being seen at a local migrant shelter.**
    - **The local migrant shelter has reported an increase in the number of ILIs seen in individuals arriving from Texas this week.**
    - **Several local migrant shelter residents have been confirmed to have either pandemic A/H1 or seasonal A/H3, both of which were matched to the 18/19 influenza vaccine.**
    - **To date, there is no evidence of transmission occurring at the local migrant shelter, as individuals apparently have been exposed in Texas and then developed symptoms after arrival to San Diego.**
    - **Likewise, there is currently no evidence of community-wide transmission of influenza associated with these cases.**
    - **Since 5/19/2019 through 12:00AM on 5/29/2019, a total of 868 individuals have been assessed at the migrant shelter, with a total of 59 Influenza- like illnesses detected.**
    - **On 5/29, a total of 27 specimens tested, 5 were positive for influenza: 3 were Flu A H1 (pandemic), 1 Flu A H3, and 1 Flu B Yamagata. The first two were strains identified last week. The B Yamagata was not previously identified in the shelter guests. All specimens (negatives and positives) are being sent to CDPH for further testing (viral respiratory panel or influenza subtyping, respectively).**

## II. Board Actions

- A. Getting to Zero: The next annual report via Board Memo will be issued in June 2019, to coincide with National HIV Testing Day.
- B. Hepatitis A Outbreak :
  - San Diego County declared a local health emergency, which was signed on Sept 1, 2017. It declares that the “spread of Hepatitis A in San Diego is a threat to public health” and “a local health emergency is declared in San Diego County”.
  - September 6 & 12, 2017: Ratify declaration of local health emergency: Hepatitis A Outbreak.
  - September 26, 2017, October 10, 2017, October 24, 2017, November 6, 2017, November 14, 2017, November 27, 2017, December 5, 2017, December 19, 2017, January 2, 2018, and January 9, 2018: Continue local health emergency.
  - San Diego County Board of Supervisors motion to end local health emergency on January 23, 2018.
  - Grand Jury Report issued May 18, 2018 and responses went to Board of Supervisors the morning of Aug 7, 2018. One recommendation was not implemented, with the remaining three completed.
  - Hepatitis outbreak officially declared over on October 19, 2018.
  - State Audit released on December 20, 2018; two of the three recommendations have been completed.
  - The 25 of 29 AAR recommendations are completed or in maintenance, with the remaining 4 in progress.
  - On Feb 26, 2019, BOS voted in support of AB262, authored by Assemblymember Todd Gloria, to give local health officers the authority to issue directives to governmental entities during an outbreak.
- C. Asylum Seeker Shelters: On January 29, 2019, the Board of Supervisors approved County property for temporary shelter use. **The location is available only through December 31, 2019.**
- D. **Tuberculosis (TB) Elimination Initiative: Has a goal to decrease the incident of active TB cases and is docketed for the Board of Supervisor meeting for July of 2019**

- C. CAHANs released on 8/31/18 (Hepatitis A Vaccination Reminder for Healthcare Providers), 9/14/18 (Fentanyl Overdoses Related to Illicit Drug Use), and 9/28/18 (Meningococcal Outbreak).
- D. San Diego County Hepatitis A Outbreak declared over on 10/19/18 after 100 days with no new cases reported.
- E. Asylum Seeker Shelters – On January 29, 2019, the Board of Supervisors approved County property for temporary shelter use.
- F. Asylum Seeker Shelters Continued:
  - The County of San Diego Health and Human Services Agency’s (HHS) involvement since 12/20/18 is focused on the primary goal to protect the health of the public, including families seeking asylum, by conducting health screening assessments in the setting of the shelter and referring for outside medical care as appropriate and identifying and preventing the spread of communicable disease.
  - The Asylum Seekers Border Shelter established by The San Diego Rapid Response Network is operated by Jewish Family Services with support from other NGOs at a confidential location in San Diego.
  - The common clinical findings based on screenings at the shelter have included influenza like illness, varicella (chicken pox), lice, and scabies. About 1% of guests have been referred out to the emergency department.
  - Since the shelter opening in late October 2018, the County HHS Public Health Services Department has received reports of **30** varicella cases in asylum seekers, **21** of which was at the shelter.
  - As of **5/29/19**, HHS has conducted a total of **12,321** health screening assessments.
  - The shelter has moved locations to the County approved property (92101) in the first week of March and has been operating there since March 6, 2019 until December 31, 2019.
  - **As of 5/19/19, San Diego County Public Health officials have been responding to an influenza outbreak among asylum seekers seen at the shelter. To appropriately monitor the situation, additional reassessments of shelter guests are being completed to identify individuals who develop symptoms of influenza-like illness after the initial screening, isolate ill families as appropriate to prevent further spread of the disease, and ensure individuals are healthy for travel before departure for their U.S. sponsor.**
- G. March 3-9 is Preteen Vaccine Week. Promotional materials will be distributed.
- H. National Public Health Week, April 1-7, 2019, with *Live Well San Diego* Public Health Champion Awards Ceremony will be held during this week.
  - Community asked to submit applications.
  - Nominations were received by the County.
  - Selection Committee met in early March of 2019.
  - 17 nominees were recipients at the Public Health Champion Awards Ceremony, which took place on Friday 4/5/19.

## IV. Grants

### A. New Applications

1. CDC Opioid “Data to Action” Public Health Grant
  - a. HHSa submitted a grant application titled “Data to Action: A San Diego Model for Opioid Overdose Surveillance and Prevention” on May 2, 2019.
  - b. Award notification will be given by **August 15, 2019**.
    - i. If successful, the project will begin at the beginning of the federal fiscal year on October 1, 2019. The full project term will run from October 1, 2019 to September 30, 2022.
    - ii. The funding amount requested was \$2,185,228 per year for up to three years.
    - iii. The total amount requested over the full project term is \$6,555,684.
2. **Kresge Emerging Leaders in Public Health Grant**
  - a. PHS was accepted into the third cohort of the Kresge Foundation’s Emerging Leaders in Public Health program. In addition to the \$125,000 in grant funding, PHS’ leadership will receive leadership development trainings and technical assistance to help implement their proposed transformative concept – convening municipal governments and local stakeholders to tackle public health problems affecting the entire region.
  - b. This new role builds off of the collaboration between city governments and the County to manage sanitation efforts during the hepatitis A outbreak.
  - c. Dr. Wooten and Dr. Thihalolipavan attended the first of three required in-person meetings on August 6-8, 2018 and the second required in-person meeting on January 9-11, 2019. **Dr. Wooten attended the third required in-person meeting on May 13-15, 2019.**
  - d. Interim Report submitted on March 3, 2019.
  - e. Dr. Wooten and Dr. Hernandez have continued to brief internal groups regarding the new Kresge Initiative. They have met with the City of San Diego as the first of the 18 municipalities to plan efforts to address the goals of the Kresge initiative, which also aligns with one of the recommendations of the State Hep A Audit. Will plan to schedule meetings with each of the other 17 municipalities over the remaining year. **Next meeting with City of San Diego is June 12, 2019.**
  - f. Training workshops will be held at the monthly Public Health Leaders meetings from April to October as part of the leadership development component of the initiative. The first training took place on 4/22/19. **The next training will take place on 6/5/19 (rescheduled from May 27 – Memorial Day).**

### B. Funding

1. **Maternal Child and Family Health Services (MCFHS) submitted and were awarded two new grant applications:**
  - **CDC-RFA-DP18-1817:** (\$900,000 per year for 5 years) Diabetes and Heart Disease & Stroke Prevent Programs-Innovative State and Local Public Health Strategies to Prevent and Manage Diabetes and Heart Disease and Stroke: This will provide funding for similar strategies that were in Component 1, Diabetes Prevention Program, and Component 2. The application was submitted on July 9, 2018. Notification of the award will occur on September 29, 2018. The County was awarded funding from the CDC for Category B for Heart Disease and Stroke, which will be effective September 30, 2018. MCFHS sent the final budget and work plan to the CDC for approval on October 31, 2018. The Year 2 Continuing Application was submitted to meet the April 1, 2019 deadline. **Single source contract with University of California, San Diego Be There San Diego executed on April 1, 2019. Scope of Work for 2-1-1 San Diego submitted to Eligibility with anticipated start date of July 1, 2019.**
  - **CDC-RFA-DP18-1813: REACH Grant:** (\$792,000 per year for 5 years) This will provide funding for similar strategies that were in Component 1, strategies 1-4 of the previous Prevention funding. This also has two additions for a tobacco cessation strategy and community linkages. The application was submitted on July 16, 2018. Notification of the award will occur on September 29, 2018. The County was awarded funding from the CDC, which will be effective September 30, 2018. MCFHS sent the final budget and work plan to the CDC for approval on November 15, 2018. The Year 2 Continuing Application was submitted before the deadline on April 15, 2019. **Scope of Work for 2-1-1 San Diego submitted to Eligibility with anticipated start date of July 1, 2019. Short-term Scope of Work for Circulate San Diego was sent to CDC for approval with anticipated start date of June 15, 2019. An RFQ was posted for media services on May 23, 2019, with an anticipated effective date of June 24, 2019.**
2. **Gonorrhea Surveillance:** The Centers for Disease Control and Prevention (CDC) has released the funding opportunity announcement for continued funding for the Gonococcal Isolate Surveillance Project (GISP) and expanded GISP (e-GISP) for the period of 8/1/19-7/31/19. As in previous years, the California Department of Public Health applied for this funding on behalf of San Diego and Orange Counties. This funding supports surveillance of Neisseria gonorrhoeae antimicrobial susceptibility. **Update May 2019: CDPH submitted the application during the first week of May 2019.**

3. **Naloxone Proposal:** Program is to participate in a naloxone distribution effort.
- Application submitted on May 1, 2017.
  - Approved, totaling \$248,300 (full amount).
  - First shipment of 5,372 naloxone doses was received on December 13, 2017 and second shipment of 1,248 naloxone doses was received on July 18, 2018.
  - A plan was developed and implemented.
  - As of February 22, 2019, 6,620 doses (100% of first shipment, 100% of second shipment, and 100% of total allocated supply for first and second) doses were picked up by 31 agencies: San Diego County Medical Examiner (46 doses), Chula Vista Police Department (200 doses), A New PATH (2,160 doses), Fallbrook Unified High School District (2 doses), Interfaith Community Services (50 doses), Mira Costa College Police Department (18 doses), La Maestra Wellness Supportive Services (100 doses), SDSU PD (62 doses), North County Health Services (100 doses), SD Police Department (1,840 doses), All Peoples' Encinitas (784 doses), House of Metamorphosis (40 doses), Oceanside Police Department (30 doses), Union of Pan Asian Communities (4 doses), Heartland House (4 doses), Mountain Health and Community Services Inc (12 doses), Indian Health Council (150 doses), Escondido Police Department (80 doses), Vista Community Clinic (30 doses), Confidential Recovery (6 doses), McAlister Institute for Treatment & Education (60 doses), San Diego County Probation Department (200 doses), The Bishop's School (4 doses), La Mesa Police Department (76 doses), UCSD Preuss Charter (2 doses), Family Health Centers of San Diego (350 doses), University of California, San Diego Unified School District (66 doses), El Cajon Police Department (130 doses), America's Finest Charter School (4 doses) and Escondido Union High School (10 doses).
  - There are 0 doses remaining to be distributed.
  - The County executed 31 (100%) out of 31 potential naloxone MOAs/MOUs (two of which are MOUs).
  - There is another MOU with the County Department of Environmental Health, but not part of the grant.
  - Final report submitted on March 29, 2019.
4. **Local Oral Health Program (LOHP):**
- Funding from California Department of Public Health (Prop. 56).
  - \$841,390/year for 5 years.
  - Overall funding period is 1/1/18 to 6/30/22. Currently in the second year of funding that started 7/1/18.
  - Four contracts executed in FY 18-19 to implement enhanced oral health activities within medical and dental office settings, school based interventions, outreach to vulnerable populations (e.g., refugees and senior population), and evaluation of oral health efforts. Contractors:
    - California American Academy of Pediatrics – Chapter 3 (health care providers).
    - Rady Children's Hospital (dental providers).
    - University of California San Diego (refugee and senior populations).
    - San Diego State University Research Foundation (evaluation).
  - San Diego State University Research Foundation launched four survey tools in December as a part of a County wide needs assessment. A draft needs assessment has been submitted highlighting four areas of focus:
    - Increasing public awareness about the importance of prevention, oral health and hygiene.
    - Leverage the patient – provider relationship with pediatricians.
    - Increase the number of dental providers that care for the very young, older adults, and underserved populations.
    - Create system linkages through collaboration and coordination.
  - Needs assessments are complete and in the approval process. Program will share draft results at the HSAB Subcommittee meeting on June 4, 2019 for further discussion and planning.
  - The draft Community Oral Health Improvement Plan has been submitted and is being reviewed.
  - **The evaluation component is being developed by San Diego State University - Institute of Public Health contractor and will be submitted for approval in June 2019.**
  - **Oral Health Forum will be held on June 13, 2019 at Marina Village 8:30 am – 3:30 pm (invitations will be going out soon).**
    - **Keynote speaker (Matt Savage, Professor of Communication at SDSU) will address oral health messaging.**
    - **Dr Jayanth Kumar, State Dental Director, will also speak on the progress for the state.**
    - **Dr. Thomas Olinger will present a historical review of oral health in San Diego County, as well as look at present and ongoing programs.**
    - **Breakout Sessions will focus on, medical/dental integration, seniors, refugees, pregnant women and children ages 0-5, school aged children, and homelessness.**

- **Live Well San Diego Oral Health Champion nominations were reviewed. Selected nominees will be awarded at the Oral Health Forum on June 13, 2019.**
  - Aging and Independence Services Oral Health Collaboration – begun brief discussion of how Public Health Services and Medical Care Services Divisions can collaborate. Examples plan a webinar to facilitate care. Plans to develop messaging specific to seniors for wide distribution, and oral health staff to present at the Vital Aging Event in June.
  - Public Health Center Collaboration – Beginning discussion on efforts to incorporate oral health instruction and the application of fluoride varnish in the Public Health Centers is underway. County staff will be working in conjunction with the UCSD Dental Health Initiative Share the Care contractor to provide staff training to apply the varnish. In addition, assessing the feasibility to have a continuous loop oral health video playing in the waiting area as well as the application of fluoride varnish in conjunction with vaccinations.
5. **Strategic HIV Prevention Projects:**
- Funded by the state: PHS will receive \$1.8 million over the next two years (July 2017 through June 2019). There were only four awards, and San Diego County was the only health department that was funded. The other awardees include two community-based organizations (the LA LGBT Center and the San Francisco AIDS Foundation) and one federally qualified health center (AltaMed in LA/Orange County). **Funding ends 6/30/19. California Department of Public Health has announced they will be releasing two new RFA's shortly. One RFA will be a demonstration project focusing on rapid linkage to antiretroviral therapy and the second is a continuation of a demonstration project on pre-exposure prophylaxis (PrEP) navigation.**
  - Proposal focused on a couple of core activities related to Getting to Zero:
    - PrEP education and navigation.
    - Rapid initiation of anti-retroviral therapy (ART) for individuals newly diagnosed with HIV.
    - **Awareness Campaigns.** The second phase of the Getting to Zero campaign was launched in November 2018 at the Getting to Zero summit. Campaign can be seen at getting2zerosd.com. **Update May 2019: placements of PrEP component of the Getting to Zero campaign are being extended through the spring/early summer. New movie theatre placements are being placed in four AMC theatres in San Diego (Mission Valley, Fashion Valley, Chula Vista and Oceanside).**
6. **Tobacco Control Resource Program (TCRP):**
- TCRP was notified on July 19, 2018 that the state will allocate \$2,805,276 in Tobacco funds (Prop 56 and Prop 99) for FY 17/18 and \$1,956,059 for FY 18/19. The County submitted paperwork on July 23, 2018 to the State to receive funding for quarter 1 and 2 of FY 18/19. The County received the quarter 1 and 2 Tobacco funds from the state on 9/25/18.
  - Additional Tobacco Funding \$182K one time only; pending funding from recent legislation (Prop 56).
  - TCRP staff members are working on the Budget revisions that are due on 10/4/18. Included in the changes will be: 1) revision of the FY 17-18 budget to reflect the actual expenses, 2) carrying over savings from FY 17-18 to FY 18-19, 3) reflecting staff vacancies and staffing at lower than budgeted FTE, and 4) increasing the FTE as directed for TCRP staffing. The revised budget and work plan were resubmitted to the state.
  - The County posted a Notice of Intent to Award for four regional contracts to Vista Community Clinic, Social Advocates for Youth (SAY) San Diego, American Lung Association of California and Community, Action, Service & Advocacy (CASA). Staff anticipate these 4 new contracts to be executed by 3/8/19. The program anticipates the releasing of a RFP for Media Services in in late February/March 2019. All contracts were executed effective 3/21/19. The Media Services RFP was posted to BuyNet on 3/21/19.
  - **Effective 5/27/19, Aaron De Leon will serve as Coalition and Community Engagement Lead for TCRP, fulfilling a CDPH-CTCP requirement for a 1.0 FTE staff allocation to focus on adult engagement activities.**
7. **STD Funding:**
- The CDPH STD Control Branch {STDCB} received a \$5 million one-time increase in funding spendable in FY16-17, FY17-18, and FY18-19. Recently received \$427,649 of that amount.
  - San Diego received notice of funding award for STD services in the amount of \$1,045,125 for the period of July 1, 2019-July 30, 2024. This represents an annual decrease of \$228,024 per year. CDPH has directed the majority of the funding to health jurisdictions experiencing high rates of congenital syphilis and syphilis among women of childbearing age.
8. **CalFresh Healthy Living (Formerly known as NEOP or Nutrition Education and Obesity Prevention, through the SNAP-ED Program):**
- Next 3-year cycle application and work plan due March 15, 2019; activities will continue to focus on policy, systems, and environmental change for nutrition and PA.
  - The next three-year grant cycle begins on October 1, 2019 and ends on September 30, 2022. The projected amount for the new three-year term is \$3,704,059 annually/\$11,112,177 cumulative with approximate

additional funds of \$555,608 annually/\$1,666,827 cumulative, for a total projected amount of approximately \$12,779,004. MCFHS started the contract procurement process. The County hosted an industry day on November 29, 2018 to gather input for the scope of work.

- NEOP Integrative Work Plan is now due April 2<sup>nd</sup> and not March 15<sup>th</sup>.
- Work plan was submitted to meet 4/2/19 deadline.

9. **Perinatal Equity Initiative:**

- The California Department of Public Health (CDPH) notified MCHFS of the allocation of \$448,047 (base of \$350,000 with an adjustment of \$98,047) for the Perinatal Equity Initiative planning grant to expand the scope of interventions to reduce infant mortality among African Americans.
- The term of the grant is from December 1, 2018 to September 30, 2019. CDPH will release a **Request for Supplemental Information (RSI) in June 2019. It is expected that CDPH will funding for FY 19-20 is approximately \$488.047. Final funding amount will be decided with the release of the RSI.**
- **Convened a Community Engagement Event on April 8, 2019 at the Jacobs Center Community Room. Over 50 community partners participated in providing input on what are some factors that impact preterm births and what strategies/interventions should be implemented to improve the health of African-American mothers and babies. A second Community Engagement Event will occur on June 4, 2019, in Oceanside.**

## V. **Public Health Initiatives**

1. **Getting to Zero** – Medical Advisory Committee: HIV, STD, and Hepatitis Branch (HSHB) has convened a Medical Advisory Committee consisting of healthcare professionals and executives from local healthcare systems and stakeholders to support Getting to Zero. The primary objectives of the committee are to increase routine HIV testing in healthcare settings and to optimize referral mechanisms for HIV linkage to care, pre-exposure prophylaxis, and post-exposure prophylaxis. Met with the Hospital Association of San Diego & Imperial Counties and community clinic networks on March 14, 2018; Met with San Diego County Medical Society on April 10, 2018; Met with Family Health Centers of San Diego on April 11, 2018. The “Getting to Zero” Board Memo went to the Board of Supervisors on June 26<sup>th</sup>. The Medical Advisory Committee met in June 2018. HSHB is working with the marketing company, MIG/MJE, to develop a “Getting to Zero” campaign to be launched at the end of November 2018. The PrEPSanDiego campaign will be a component of the “Getting to Zero” campaign, which addresses three main pillars: Test, Treat, and Prevent. The development of the expanded Getting to Zero (GTZ) marketing and media campaign has been completed. The press release and campaign launch occurred November 29, 2018, in conjunction with the Getting to Zero Summit. Speakers included Supervisor Roberts, Alberto Cortes (Mama’s Kitchen), Sayone Thihalolipavan, Patrick Loose and John Paul Hernandez (advocate). The GTZ Summit and campaign were covered by KPBS, KUSI and the County News Network. The Medical Advisory Committee last met on January 14, 2019. The Pacific AIDS Education Training Center (PAETC) presented information on how the organization can support the work of the GTZ Medical Advisory Committee. The committee reviewed a draft Dear Colleague letter that outlines the County recommendation for routine HIV testing, regardless of risk factors for

everyone aged 13-65 at least one time. The next meeting of the GTZ Medical Advisory Committee was scheduled for March 11, 2019. Update, March 2019: The March 11, 2019 meeting was cancelled due to low availability of committee members to attend. Next meeting too place on April 8, 2019. The CAHAN regarding routine HIV testing and supporting documents was disseminated on March 25, 2019. Partners also have pushed it out to all credentialed providers at Naval Medical Center San Diego and emergency department medical directors.

- **Update May 2019: Dr. Tilghman gave a presentation to the Emergency Medical Oversight Commission (EMOC) of the San Diego County Medical Society on May 10, 2019. He received a verbal commitment from EMOC to work toward implementation of routine HIV testing in local emergency departments within the next 12 months.**
  - **The last Medical Advisory Committee meeting was held on May 13, 2019. Dr. Tilghman presented a draft set of slides that can be tailored to a variety of audiences to allow committee members to participate in outreach in their healthcare systems and geographic regions. Based on feedback provided by Committee members, Dr. Tilghman is revising and finalizing the slides.**
2. **Hepatitis C Initiative – Approved by the Board of Supervisors in November of 2018.**
- Year 1 is and will be spent creating a plan, managing the process, and finalizing the draft Recommendations report.
  - The initiative is on track and continues to be a collective impact approach with American Liver Foundation providing a coordination role along with the participation and leadership of multiple other stakeholders.
  - Meetings for most committees have initiated (Steering; Research and Surveillance; Access, Testing, and Treatment; and Consumer) while the advisory committee for which Dr. Wooten and Paul Hegyi will co-chair is being finalized and scheduled.
  - First Advisory Committee Meeting was held on April 30, 2019 at the San Diego County Medical Society. Paul Hegyi and Dr. Wooten are co-chairs

## IX. Legislation

- A. AB 262 – Introduction of Assembly Bill 262 is an addition to Health and Safety Code Section 120175.5 related to the authority of the local public health officer. This bill specifies the following:
  - Would require local health officer to notify and update the local governmental entities within the health officer's jurisdiction about communicate disease outbreaks that may affect them, and make relevant information available to those entities, as specified.
  - Further, this bill would authorize the local public health officer to issue directives to other governmental entities. (a), if the local health officer knows or has reason to believe that any case of the diseases made reportable by regulation of the department, or any other contagious, infectious or communicable disease exists, or has recently existed, within the territory under that health officer's jurisdiction, the health officer may issue directives to other governmental entities within that jurisdiction to take any action the health officer deems necessary to control the spread of the communicable disease.
