Public Health Officer's Report

I. Communicable Disease Issues

A. Infectious Disease Issues

- **Influenza (As of week ending March 27, 2021)**
 - For the 2020/2021 flu season, CDC disease week ending March 27, 2021, there have been 727 lab confirmed flu cases reported and one death. This compares to a previous three-year average for the same time of the year of 17,073.
 - The total number of influenza vaccinations registered this flu season to date is 1,208,056 through February 27, 2021.
 - Given the small number of cases this season, this season's last weekly report was issued on March 3, 2021 with data through February 27, 2021
- **2019 Novel Coronavirus (As of March 29, 2021)**
 - The current number of COVID-19 cases in the U.S. is over 30,085,827 and 546,704 deaths
 - California Cases
 - The current number of cases in CA is now 3,564,468 cases and 57,778 deaths.
 - San Diego Cases
 - San Diego County residents – 269,770 with 3,547 deaths
 - The current number of COVID-19 vaccines administered as of 4/02/2021 is as follows:
 - 2,689,348 = San Diego County population 16 years of age and older (eligible population)
 - 2,017,011 or 75% = State goal to vaccinate eligible population
 - 1,887,395 total vaccine doses received in the region
 - 1,758,625 doses administered and entered in SDIR
 - 975,811 (36.3%) San Diego County residents only received one dose vaccine
 - 586,575 (21.8%) San Diego County residents only are fully vaccinated
 - See [COVID-19 Watch](#), published Tuesday, March 30, 2021.
 - Currently vaccinating Phase 1A, Phase 1B, Phase 1C.
 - April 1 – began vaccinating all persons 50 years and older (Phase 1C)
 - April 15 – will begin vaccinating all persons 16 years and older (Phase 2)
 - Vaccination sites include community PODs, Super Stations, other partners.

II. Board Actions

- A. On September 15, 2020, the BOS approved the receipt of \$20 million in funding for an Epidemiology & Lab Capacity (ELC) grant from CDC through CDPH. This is a two-year grant with a focus on enhancing communicable disease detection, surveillance, and diseases control.
- B. On September 22, 2020: The BOS voted to support the County Public Health Services Department continuing to make suggestions to the State to look at other factors that would contribute towards the adjustment of the reopening metrics. The suggested factors include hospital capacity, contact tracing efforts, and providing access to testing, and other COVID-19 response resources for vulnerable populations in the County.
- C. On October 13, 2020: County BOS agreed to several key reinvestment initiatives to support establishments and citizens impacted by COVID-19. Unspent CARES Act funding was voted on to be redirected to most vulnerable residents and small businesses.
- D. On October 21, 2020: County Registrar of Voters, Michael Vu, shared that voting centers for the upcoming Election days had been modified to address Public Health guidance for COVID-19. Specifically:
 - The number of days allowing for voting were expanded from one to four,

- The voting centers themselves have been consolidated into larger settings to allow for social distancing and proper infection control measures,
 - 30% of all voters have mailed in their ballots,
 - 3,500 to 3,600 poll workers will serve across the four-day voting period,
 - Poll workers are being trained over two days to learn more about testing, PPE, and cleaning/disinfecting protocols for the voting settings related to COVID-19 and screening for symptoms and temperature checks among poll worker staff will take place daily.
 - 25,000 tubs of hand sanitizing wipes, 1,800 sneeze guards, 800,000 gloves, 300,000 masks, and 12,000 hand sanitizing bottles have been purchased to support the effort.
- E. On October 27, 2020: The BOS approved the following in relation to the COVID-19 Pandemic:
- Extending annual permit fees and plan check fees, late fees for restaurants and food facilities, and extension on payment deferrals through 3/31/21.
 - Approved \$28 million to small businesses through 3,100 stimulus grants throughout San Diego County.
- F. On November 25, 2020: The BOS approved an additional \$20 million in stimulus funding to businesses in San Diego County impacted by COVID-19.
- G. On January 13, 2021: The County announced that it is prepared to spend \$100 million in vaccine distribution. The hope is that these funds get reimbursed at some point. The County stated its commitment to do all that it can to get as many vaccines administered to the public as possible.
- H. On February 3, 2021: The BOS announced the launch of the community health worker Promotora Pilot Program that maintains the goal of conduct outreach to the most vulnerable populations
- 100 Promotoras have been trained to conduct outreach in the appointment setting
 - This is an important project that we are doing in the South Bay. The County has blocked appointments from 9:30 am and 12:30 pm for community PODs including San Ysidro, Imperial Beach, Chula Vista, and National City for these appointments
- I. On February 9, 2021: The BOS chose vaccination option B, to administer vaccines for COVID-19 using State and Federal Funds using a model that was designed by the State, as opposed to allowing the State to do this or to concurrently and separately provide immunizations along with the State.
- J. On February 17, 2021: San Diego County indicated that it has provided 663,000 vaccines which places it at the top of the list in vaccines provided in the State of California.
- K. On February 17, 2021: Supervisor Vargas provided an overview of the Scheduling Assistance for Vaccination Equity (SAVE) Program. This is a pilot program supports eligible, higher-risk individuals being able to obtain COVID-19 vaccination appointments in their community.
- The County is working with a variety of community partners on this Program, including the following:
 - The Chicano Federation
 - United Women of East Africa
 - San Diego Refugees Communities Coalition
 - San Diego Latino Health Coalition
 - San Diego State University
 - Mental Health America of San Diego County
 - Multicultural Health Foundation
 - PCI (A Global Communities Partner)
 - UPAC
 - Somali Family Service of San Diego
 - SBCS (South Bay Community Services)
- L. On February 17, 2021: The BOS indicated having success with the Black Nurses Association and will be expanding those efforts to the Filipino Nurses Association and our Hispanic Nurses Association to provide access to vaccines in an equitable way
- M. On February 24, 2021: San Diego County reported that the adjusted case count and hospitalizations are going down significantly, as low as they were in the Fall of 2020. Also, 20% of San Diegans had received at least the first dose of the vaccine. Lastly, schools are planning to reopen, some as early as April of 2021.**
- N. On March 2, 2021 San Diego County HHSA along with partners provided an update on the COVID-19 response to the BOS with the following specifics:**
- **The number of cases has continuously declined, with the last two days showing daily counts below 300.**

- Almost Four million tests have been conducted
 - San Diego County is steadfast in drive to vaccinate 70% of citizens 16 and older by 7/1/21.
 - Commitment to Health Equity remains, with vaccination sites being inside or adjacent to those communities that are the most impacted by COVID-19.
- O. On March 3, 2021, San Diego County reported that it continues to head in a proper direction to mitigate the effects of COVID-19.
- The County has vaccinated the vaccinators and health care workers
 - 100% of the SNF and 93% of the LTCFs have been visited at least twice with vaccine administration (Updated as per MOC Director).
 - Although the case rate (as reported by the State) is at 10.8 (March 2) which was not low enough to enter the Red Tier, the County believes that there is a high possibility that in the next few weeks, it will be able to go to the lower Tier.
 - San Diego County has been in conversation with the State of California with possible adjustments to the formulation to alter the case rate needed to go into the lower Tier.
 - San Diego County is also nearing the milestone of administering its' one millionth vaccine, but this is also met with a reality that we have a shortage of vaccines
- P. On March 10, 2021, San Diego County reported it had been a year since having its' first COVID-19 case, and recognizes how difficult this has been for our citizens. It also recognized the difficulty in the 3,400 San Diegans that lost their lives in this Pandemic. Vaccine shortage continues to be a challenge. It also outlined two paths for entering the Red Tier:
- The State achieves the measure of two million vaccines in a certain Healthy Places Index (HPI).
 - If the State does not hit the measure, we can do so with the percentage of positive in the Health Equity Index
- Q. On March 16, 2021, San Diego County reported to the BOS on the COVID-19 response with the following specifics:
- Case counts continue to decline, as it has seen a case count below 200 daily in the past two days.
 - Vaccine supply continues to be a challenge
 - As of 3/15/21, there are 279 total confirmed cases (82 more cases reported from two week ago) of the UK B.1.1.7 Variant strain. Of the total cases, there had been 4 hospitalizations (1 additional hospitalization since the last report) and 1 death (unchanged).
 - Currently, San Diego County can vaccinate 34,000 San Diegans per day, which translates to over 1 M vaccinations in a single month
 - Ensuring that Health Equity is integrated into the response remains a priority for San Diego County.

III. Public Health Issues

- A. The following Health Observances are throughout the month of April:
- National Public Health Week: 4/5/21-4/11/21.
 - National Youth HIV and AIDS Awareness Day: 4/10/21.
 - National Transgender HIV Testing Day: 4/18/21.
 - National Infant Immunization Week: 4/24/21 -5/1/21.
 - World Meningitis Day: 4/24/21.
 - STI Awareness Month: throughout April 2021.
- B. New Applications
- California Department of Justice "Tobacco Grant Program 2020-2021":
 - a. HHS submitted a grant for the California Department of Justice Grant Program on August 7, 2020.
 - i. This funding would support Tobacco Retail Licensing Program enforcement efforts.
 - ii. It would also help the Program deliver a focused digital media campaign to increase knowledge about the

dangers of youth tobacco use.

- b. If funded, award notification will be in November 2020.
 - i. If successful, the project will begin on or about January 1, 2021 (per the Department of Justice's Request for Proposal). HHS applied for 36 months of funding (January 2021 to December 2023).
 - ii. The funding amount requested was \$754,063.00 for 36 months.
 - iii. The funding amount requested per FY is: FY 2020-21 (\$65,143), FY 2021-22 (\$281,599), FY 2022-23 (\$284,842), and FY 2023-24 (\$122,479).
 - iv. This is a competitive grant application.
- c. PHS was notified on 12/31/21 that the application was awarded
 - i. The funding amount awarded is \$532,405 for 36 months for the period 7/1/21-6/30/24. To accept funds, PHS is required to return a Letter of Intent (submitted on behalf of HHS on 1/15/21), obtain approval from the Board of Supervisors to accept the funds, and complete an MOU.
 - ii. The funding amount per FY is: FY 21-22 \$174,262, FY 22-23 \$176,611, and FY 23-24 \$181,532.
 - iii. A Board Letter to accept funds and approve a resolution is scheduled for 3/16/21.
- **Kresge Emerging Leaders in Public Health Grant:**
 - a. Due to continued shift of priorities towards the COVID-19 response, the County of San Diego PHS has requested an additional extension to the grant period. The grant's new end date is March 31, 2021.
 - b. Contracted with public speaker, Reggie Caldwell, to develop a curriculum and provide a training series to all permanent PHS staff on Racial Equity in Public Health and the Public Health Workforce.
 - This training series includes three sessions – Session #1: The Basics of Racial Equity, Session #2: Structural Racism, and Session #3: Privilege and Power.
 - These trainings were conducted between 1/12/21 – 2/18/21.
 - Consultation and office hours with Branch Managers were offered to each branch, upon request of the speaker.
 - c. Working with the *Live Well San Diego* Team to contract with speaker, Trabian Shorters, to provide a series of community conversations on Asset Framing.
 - This is a five-part series where the first session, Session #1: Asset-Framing Keynote, will be paid for by Kresge grant funding.
 - Session #1 tentatively scheduled for June 24, 2021.
 - **The following four sessions will be on a quarterly basis where a select group of ~50-100 people work in a cohort to do more of a deep dive on topics within the Asset Framing subject.**
- **National Association of Chronic Disease Directors (NACDD) Multi-state EHR-based Network for Disease Surveillance (MENDES)**
 - HHS is participating in the MENDES project, to build real-time chronic disease surveillance capacity in participating jurisdictions as a first phase in the development of a national surveillance model.
 - A contract for \$50,000 was received on 11/16/2020 and is under review.
 - The project is sponsored by CDC and facilitated by the National Association of Chronic Disease Directors (NACDD) in partnership with the Public Health Informatics Institute (PHII).
 - The project will involve collaboration between HHS and San Diego Health Connect (SDHC) with each entity receiving separate funding to support participation.
 - San Diego Health Connect has discontinued their participation. HHS is looking for other opportunities to continue the project in conjunction with other critical Public Health IT projects.

C. Funding

- **Local Oral Health Program (LOHP):**
 - The Give Kids A Smile (GKAS) program will take place February 22 – March 19, 2021. This year the event will include private dental offices and community dental clinics. Promotion, recruitment, and outreach efforts will be in collaboration with community partners.
 - LOHP contractors continue to provide services virtually. To date for this fiscal year, 33 pediatric providers and 21 dental providers are participating in our program and providing important oral health messages. UCSD Dental Health Initiative/Share the Care and County staff are working with home visiting programs to train and support their staff.
 - The San Diego Oral Health Coalition and the Oral Health Advisory Board continue to meet virtually.

- **The San Diego Oral Health Forum will take place on June 4, 2021 and the theme will be equity.**
- **California Department of Public Health, Office of Oral Health released a request for application due April 21, 2021. This is a new one-time funding opportunity that will be available to support the creation and expansion of community-clinical linkages to promote oral health.**

- **EISB Funding:**
 - On Tuesday, July 21, 2020, the County was notified by CDPH of a nearly \$900,000 additional funding amount to support enhanced flu and COVID-19 immunization efforts.
 - On August 12, 2020, the County was notified by CDPH of \$20,000,000 funding through the CDC Epidemiology & Laboratory Capacity (ELC) grant funding. These are for this current and next fiscal years. On September 15, 2020, the Board of Supervisors approved the receipt of this funding to support enhanced surveillance, investigation, response, prevention and partner coordination/engagement efforts.
 - On October 21, 2020, the CDPH formally notified the Counties of additional funding supplements to the existing Immunization Action Plan Annual Grant funding. This will be in the additional amount of \$1,064,731 and comes with specific requirements about COVID-19 vaccine planning and implementation.

- **STD Funding:**
 - San Diego received notice of funding award for STD services in the amount of \$1,045,125 for the period of July 1, 2019-July 30, 2024. This represents an annual decrease of \$228,024 per year. CDPH has directed most of the funding to health jurisdictions experiencing high rates of congenital syphilis and syphilis among women of childbearing age.
 - HSHB is receiving \$775,254 in STD funding from CDPH State Local Assistance Funds for the time period of 7/1/2019 – 6/30/2022 for STD prevention and control activities. Fifty percent of the funding will be contracted out to local community providers.

- **CalFresh Healthy Living (Formerly known as NEOP or Nutrition Education and Obesity Prevention, through the SNAP-ED Program):**
 - Single Source contract for Champion Childcare Provider Program with the YMCA of San Diego County effective date: 10/21/19.
 - Funded at \$100,000 annually through 9/30/22.
 - Single Source contract for Physical Activity and Nutrition Education with San Diego Unified School District (SDUSD) effective date: 8/7/20.
 - Funded at \$200,000 annually through 9/30/22.
 - Contract 561555 for Healthy Food Access with University of California, San Diego – Center for Community Health effective date: 12/21/21
 - Funded at \$500,000 for initial term and \$500,000 annually through 9/30/22
 - Contract 562520 for Healthy Cities, Healthy Residents--SafeRoutes to Healthy Places with Vista Community Clinic effective date: 7/8/20.
 - Funded at \$88,000 annually through 9/30/22.
 - Contract 563031 for Active Living Planning and Policy Services for City of Vista Project with Alta Planning + Design Inc. effective date: 8/6/20.
 - Funded at \$148,368 for initial term and \$99,800 annually through 9/30/22

- **Perinatal Equity Initiative:**
 - Mental Health America of San Diego was selected as the contractor for the PEI Fatherhood Parenting Program. Services for African-American fathers will begin in August 2020.
 - To commemorate Black Breastfeeding week, MCFHS in collaboration with the San Diego County Breastfeeding Coalition hosted a free screening of the documentary film, Chocolate Milk, which promotes breastfeeding in the African-American community, on August 26th.
 - The next PEI Community Advisory Board meeting will be held on September 11, 2020 via Microsoft Teams.
 - The PEI public awareness campaign developed by Civilian is scheduled to kick-off in October 2020. The campaign will educate the community on how systemic racism negatively impacts African-American maternal and infant mortality.
 - The PEI public awareness campaign developed by Civilian went live on September 14, 2020. <https://blacklegacynow.com/>

- The campaign will educate the community on how systemic racism negatively impacts African-American maternal and infant mortality.
- The Request for Quotation for PEI's Implicit Bias Educational Training Program was on BuyNet from October 26, 2020 through November 23, 2020. Proposals will be reviewed in the coming weeks.
- A contractor for the PEI Implicit Bias Educational Training (IBET) has been selected and program is moving forward with the procurement process with a potential 1/1/2021 start date.
- PEI is planning a media conference in January 2021 to increase awareness of inequities in infant and maternal health outcomes for African Americans and to the PEI program.
- The PEI media conference is planned for 11:30 am on Thursday, January 28, 2021, at County Operations Center. Speakers include Chairman Nathan Fletcher, Dr. Wilma Wooten, and representatives from medical community and two mothers from the PEI Community Advisory Board.
- A contract was executed on January 15, 2021 between the County of San Diego and Health Resources in Action to provide implicit bias education to healthcare providers (and their staffs) who provide care for African-American pregnant women.
- Phase 2 of the *Black Legacy Now* media campaign ran from January 4 – February 5, 2021 and included a press conference held on January 28, 2021. Fifteen individuals reached out to program staff after the press conference, most requesting to join the PEI Community Advisory Board.
- **Phase 3 of the Black Legacy Now Media campaign will run in April and May of 2021.**
- **San Diego Racial and Ethnic Approaches to Community Health (SD REACH):**
 - Contract 560458 for Information and Referral Services with 2-1-1 San Diego for bidirectional community-clinical linkages services effective date: 6/20/19
 - Funded at \$225,545 for initial term and \$42,060 annually through 9/30/23
 - Contract amendment for REACH project year 1 executed with Circulate San Diego (existing CalFresh contractor) to develop plans for Active Transportation planning to be led by the City of San Diego through the end of the 5-year CDC grant (Sept. 31, 2023).
 - Contract 563034 for Active Transportation Project with Circulate San Diego -year RFQ for Active Transportation services effective date 8/7/20.
 - Funded at \$120,000 for initial term and \$60,000 annually through 8/31/23.
 - Contract amendment for Cardiovascular and Diabetes Prevention and Management Project with University of California – San Diego (contract number 559701) to add REACH specific Community Health Worker scope of work. Effective date on 8/14/2020
 - Potential funding at \$105,000 for period from 1/15/2021 (tentatively) to 6/30/2021
 - Funded at \$60,000 for period from 8/14/2020 to 9/29/2020 with carryover from 9/30/2020-12/30/2020. Pending Contract amendment for Child Obesity Prevention Services Project with University of California – San Diego (contract number 560830) to implement a media campaign to increase participation in a market match program “Mas Fresca”.
- **CDC Racial and Ethnic Approaches to Community Health (REACH) Grant Supplemental Funding:**
 - a. HHS submitted a grant application for supplemental funding to support flu vaccination coverage. Project began September 30, 2020 and will run through September 29, 2021 and will involve a collaborative effort between EISB, Office of Strategy and Innovation, and MCFHS/CDHE.
 - b. A media contract Brown Communications was established on November 17th, 2020 through an existing County- wide service contract and funded at \$140,000 to develop the REACH: Fight the Flu campaign
 - c. The first phase of the campaign launched digital and radio ads on 12/6/20 during National Influenza Vaccine Awareness Week and ran through 12/20/20.
 - d. The second phase of the campaign will include digital, television, radio, and billboard ads and will run from 12/21/20 to 3/31/21.
 - e. CDC announced a new supplemental funding opportunity to promote vaccine awareness for COVID-19 and the 2021-22 flu season, building upon and extending the existing flu supplemental funding. The funding available to San Diego is \$629,640 for an 18-month period 3/30/21 through 9/29/22. Applications are due 3/1/21.

IV. Public Health Initiatives

A. Major Initiative Updates and Highlights

- **Getting to Zero**
 - Dr. Tilghman continues to try to engage HASDIC to get on an upcoming meeting agenda. The Medical Advisory Committee members also have requested a “champion” for routine HIV testing in the Board of Supervisors. The next meeting is not currently scheduled due to COVID-19.
 - The HIV, STD and Hepatitis Branch has been awarded \$9,693,670 in Ending the HIV Epidemic funding for HIV prevention for the time period 8/1/2020-7/31/2025. This complements the \$5,000,000 awarded earlier this year for Ending the HIV Epidemic funding for HIV care and treatment for 3/1/2020-2/28/2025. Procurements necessary to administer the services in each of the grants are under development.

- **Hepatitis C Initiative – Approved by the Board of Supervisors in November of 2018.**
 - The initiative is on track and continues to be a collective impact approach with American Liver Foundation providing a coordination role along with the participation and leadership of multiple other stakeholders.
 - Meetings for all committees have initiated and on track (Steering; Research and Surveillance; Access, Testing, and Treatment; and Consumer).

- **Tuberculosis Elimination Initiative**
 - On December 17, 2020 the TBEI Joint Advisory/Steering Committee Meeting: The Steering Committee members (action committee co-chairs) presented high impact activities developed by their action committees and associated short term objectives that support the TBEI Recommendations.
 - In February 2021, the AOC submitted the TBEI Board Memo and Recommendations Report to the County Board of Supervisors that describes barriers to LTBI care, recommendations for progressing toward TB elimination and experiences of TB survivors.
