Federal initiative to reduce new HIV infections nationally by 90% by 2030



# Acceptance of Funding



## Ryan White Part A and Part A Minority AIDS Initiative

- Medical treatment and support services
- Funding period: March 1, 2025 – February 29, 2028
- Funding amount: **\$40 million**

## Ending the HIV Epidemic

- Enhances and support Ryan White services
- Funding period: March 1, 2025 – February 28, 2030
- Funding amount: **\$12.8 million**

- Conduct RFSQ and award contracts

# Recommendations



1. Waive Board Policy B-29, Fees, Grant, Revenue Contracts.
2. Authorize acceptance of \$37.4 million and \$2.6 million in grant funds from the United States Health Resources and Services Administration for the period of March 1, 2025, through February 29, 2028, for Ryan White Part A and Ryan White Part A Minority AIDS Initiative, respectively.
3. Authorize the acceptance of \$12.8 million in grant funds from the United States Health Resources and Services Administration for the period of March 1, 2025, through February 28, 2030.
4. Authorize the Director, Department of Purchasing and Contracting, to issue a Request for Statement of Qualifications for Outpatient Ambulatory Health Services and Re-Engagement in HIV Care, Oral Health Services, and Psychiatric Services; upon successful negotiations and determination of a fair and reasonable price, award contracts for a term of one year with four option years and up to an additional six months if needed.

# Recommendations



5. Authorize the Director, Department of Purchasing and Contracting, to amend Outpatient Ambulatory Health Services and Re-engagement in Care, Oral Health, and Psychiatric Services contracts (#556170, #556172, #556212, #556175, #563231, #563284, #566466, and #566476) to extend the contract term for six months through December 31, 2025.
6. Authorize the Director, Department of Purchasing and Contracting, to amend administrative services organization contracts (#507645 and #554288 ) to extend the contract term for six months through December 31, 2025.
7. Authorize the Deputy Chief Administrative Officer, Health and Human Services Agency, or designee, to apply for any additional funding opportunity announcements.
