9. Information Item: Youth Engagement on County Boards & Commissions

CAP staff and CAB members Nicole Murphy and Connie Cepeda met briefly with the Live Well Youth Sector Team on May 20, 2021 to discuss ideas and ways in which CAB can support and be supported to promote youth engagement and participation on the CAB. Further information will be shared in the upcoming fiscal year.

PROGRAM UPDATES

- Contracted providers continue to administer COVID-19 response services through the CSBG CARES Act:
 - In the months of April and May 2021, the following COVID response and recovery services were provided by the **Communities in Action (CinA)** providers:
 - Jewish Family Service in the North Central Region held a pop-up diaper distribution event on May 21, from 1:00-4:00pm at the Lawrence Family Jewish Community; 80 families received 75 no-cost diapers per child.
 - In the North Coastal Region, North County Lifeline provided 29 emergency needs supports, assisted 8 families with housing supports, and 10 families with transportation supports.
 - As the demand for assistance and support continues, staff is currently working to add additional CARES funds to the CinA contracts to further assist individuals and families affected by the pandemic.
 - The **EITC tax season** wrapped up in April 2021. The North Coastal CinA provider North County Lifeline is extremely proud of their amazing VITA (Volunteer Income Tax Assistance) team for its adaptability in using online platforms to assist individuals 100% virtually this year. Through **1200+** hours, **18** volunteers completed **223** returns resulting in over **\$468,000** in refunds.
 - 2-1-1 San Diego and the United Way of San Diego are hosting a post-tax season Press Conference that will take place on June 24, 2021 at 10:00 am to highlight the accomplishments of the 2020 season.
- The National Conflict Resolution Center (NCRC) administers various programs, all of which continue to be very active with trainings and community sessions:
 - The Live Well Exchange program engaged a total of 353 participants in April through trainings, restorative circles, and bystander trainings. 159 of those attended COVID recovery and response specific activities. Trainings consisted of social service/workplace communication focused workshops, communication between parents and school sites and how to de-escalate tensions and promote more proactive communication, a professional development focused workshop for primarily Latina college students and graduates, and a

pilot bystander training for young, diverse professionals/job seekers that provided a positive space for discussing challenges at works such as ageism.

- COVID workshops focused on job-searching and returning to a late-stage pandemic
 workplace with various community organizations across the county, there were also parent
 focused workshops with Chula Vista Elementary Schools and Exceptional Family Resource
 Center focused on the reopening experience for parents of children with disabilities,
 transitional age youth at San Diego Youth Services shelter discussed intergenerational microaggression challenges with grandparents and other family members and how COVID has
 increased problematic communication on social media. In addition, several restorative circles
 were held which addressed COVID-loss, divided families and reconnecting.
- The Work Readiness Exchange program for refugees trained 7 participants in Arabic with a focus on workplace communication and conflicts within families, around children and their schoolwork and between spouses.
 18 refugees completed the Art of Inclusive Communication training, focus topics were centered on the frustration and challenge of being unemployed currently and family/household conflicts.
- The **Resident Leadership Academy (RLA) Coordination** program administered by Community Health Improvement Partners (CHIP):
 - Completed 2 Supplemental Trainings Understanding Gang-Related Documentation in Our Communities by Genevieve Jones-Wright of Community Advocates for Just and Moral Governance (on 4/2/2021, attended by 40 individuals), and Restorative Practices: Building Positive Relationships and Addressing the School to Prison Pipeline by Brett Hall of CHIP and Anthony Ceja of SD County Office of Education (on 4/9/21, attended by 34 individuals).
 - Cohort 9 of the RLA facilitator training that began on March 10, 2021 wrapped up on April 8, 2021, **14** individuals graduated.

FISCAL UPDATES

The **RFQ** (#10989) for RLA Coordination Services for the period of July 2021 through June 2022, with one option year period for FY 2022/2023 was released on June 1, 2021 and will be open until June 15, 2021. The contract is funded with CSBG funds, but also includes CSBG CARES funded components through May 31, 2022. The solicitation can be found by logging into BuyNet (https://buynet.sdcounty.ca.gov/) and searching the RFQ number.
