




# San Diego County Immigrant Legal Defense Program (ILDP)

#### **ABOUT THE ILDP**

The San Diego County Immigrant Legal Defense Program (ILDP) was established in 2021 by Supervisor Terra Lawson-Remer and the San Diego County Board of Supervisors. The groundbreaking program provides legal representation to detained immigrants facing deportation, ensuring due process and fairness in immigration proceedings. Launched in April 2022 by the Office of Assigned Counsel (OAC) within the Public Defender's Office, ILDP operates on a merit-blind basis.

As a border region, we are the epicenter of the nation's broken immigration system. The immigration court system is slow, bureaucratic, and riddled with errors and inefficiencies. That's why the Board of Supervisors established the Immigrant Legal Defense Program - to ensure we protect the constitutional right to due process and make our system faster and fairer. Since then we've gttotten 17 calls a day from people detained in San Diego County and facing the immigration system in need of help.

### PROGRAM IMPACT



2,500 individuals represented since 2022



7,275 calls recieved from individuals seeking representation, an average of 17 calls per day



Representation rates of clients detained at Otay Mesa nearly tripled, from 10% to 28%



66% of cases with substantive outcomes resulted in a win or stay in the country.

#### CASE EXAMPLES

- A young gay man fled El Salvador after being persecuted by gangs and targeted under the government's "State of Exemption" policy, which imprisons people for suspected gang ties. He was beaten by police and repeatedly raped in prison. After fleeing to the U.S., the ILDP secured his release from detention, and he now lives safely with family in Maryland.
- A Cuban refugee was tortured for opposing the government and continued his activism online after arriving in the U.S., making him a target under Cuba's new libel laws. A judge granted him protection under the Convention Against Torture. Although the Department of Homeland Security appealed, he was released with the support of the ILDP and is now living in a Texas shelter while awaiting a work permit.
