They need somebody who could help in filing it, like the VBA. There are still few people there we can trust, give advice, there are still vets now living in the streets and doesn't have any VA benefits.

# 11. Information Item: 2022 Legislative Initiatives Summary:

Chairman Jack Harkins shared that the CA Senate & Assembly Legislation page is as good as The Library of Congress. The website **www.Congress.gov** "homepage" has prominent search types and topic categories.

Member Tony Teravainen commented to highlight on-going legislation to support the targeted constituency that can come up or find something VA San Diego get an award letter to Sacramento, a position to one of these so that Council's voice could be heard a little more. Chair Jack Harkins will make recommendations for the Supervisors to get support.

Member Danny Jackson appreciate sending members out, as a group need to go forward, need some discussion with some representative if there's something on there that's hot, would like to discuss with them and will just have to educate him a little bit.

# 12. <u>Information Item</u>: **SD** County Office of Military and Veterans Affairs (OMVA) Update. Submitted by Ex-Officio Wil Quintong.

- Despite the surge in Covid cases due to the Omicron variant, OMVA lobbies remain open and non-profit Veteran Support Organizations can still utilize their assigned workspaces at the MVRC's.
- Vet-Connect station expansion to the Bunker in Tijuana is currently on hold due to the need for the Deported Veterans Support House to relocate to another facility. We will not be moving forward with the installation until a new facility is identified and a pre-visit by the contractor is completed.
- OMVA will be conducting an event with the Live Well on Wheels mobile unit at the Campo VFW on Jan 31, 2022. We are also planning another event at the Ramona Library on Feb 7, 2022. Attached flyers for the Campo and Ramona events.
- HHSA will be holding a meeting with all Advisory Council Chairs and possibly Vice Chairs on February 1, 2022. Invites should be sent shortly. I did update the SDMVAC contact information.
