- 1. Meeting called to order at 1:02 pm by Jude Litzenberger, Chair
- 2. Pledge of Allegiance
- 3. Roll Call
 - SDMVAC present members noted above.
- 4. The June 17, 2025, meeting minutes were approved by the five Council members present and one abstained.
- 5. Public Comments:
 - No public comment

- 6. **Discussion Item:** New Community Connections: SDMVAC Council members share community events they have recently attended. Council member David McCulloh shared his attendance at the Veterans Advisory Committee in North County on August 4,2025, and announced the upcoming Grape Day 5K Run on September 13,2025, at Escondido. Paula Jansen reported on her visit to the VFW, where she participated in a tree seed-packing activity for veterans and their families, and attended the Purple Heart Ceremony at the Balboa Museum and the Military Stamp Unveiling at the San Diego Midway Post Office on July 10, 2025. Chair Jude Litzenberger shared her participation in the Cal TAP event held at the LGBT Center, focused on resources for LGBTQ+ Veterans. John Paul Sillivan attended the 126th VFW National Convention, which took place from August 9–13, 2025, in Columbus, Ohio.
- 7. **Action Item:** Nomination for the 2025 SDMVAC Chair and Vice Chair. Jude Litzenberger, the current Chair of SDMVAC, was nominated to continue serving as Chair for the next term. Danny Jackson, the current Vice Chair, was also nominated to continue serving as Vice Chair for the next term. All members were in favor; there were no abstentions. Both nominations were unanimously approved.
- 8. **Action Item:** Election for the 2025 SDMVAC Chair and Vice-Chair: All San Diego Military and Veterans Advisory Council Members. An election was held for the 2025 Chair and Vice Chair positions. All five San Diego Military and Veterans Advisory Council (SDMVAC) members participated in the vote. Jude Litzenberger was elected as Chair, and Danny Jackson was elected as Vice Chair for the 2025 term.
- 9. Presentation Item: Steven A. Cohen Military Family Clinic at VVSD: Ashley Tatum, Caser Manager/Substance Use Disorder (SUD) Counselor at Steven A. Cohan Military Family Clinic at VVSD. Ashley Tatum, Case Manager and SUD Counselor, provided an overview of the clinic's services, including mental health counseling, substance use treatment, case management, and support for veterans and their families regardless of discharge status.
- 10. **Discussion Item**: Administrative Code Update: Ray Flores, Military and Veterans Affairs Officer, Office of Military and Veterans Affairs. Ray Flores, OMVA officer, discussed that all committees and councils with public members are governed by an administrative code that outlines their structure, operations, and framework. He noted that OMVA and Self-Sufficiency Services (SSS) periodically review this policy, and there are currently no updates or changes.
- 11. **Discussion Item**: Nonprofit Board Training Strengthening San Diego nonprofits serving Military, Veterans and their families; Chair Jude Litzenberger announced that this year, the Good for Others Foundation will conduct a nonprofit board training program aimed at strengthening San Diego-based organizations that serve military members, veterans, and their families.
- 12. **Discussion Item**: Suggested topic for future meetings: All San Diego Military and Veterans Advisory Council. David McCulloh suggested inviting David Whitley Commanding Officer, Headquarters & Support Battalion at Marine Corps Base Camp Pendleton.

San Diego Military and Veterans Advisory Council (SDMVAC) 2024 Annual Report to the County Board of Supervisors

August 2025

In accordance with the County Administrative Code, Article XLVIII, Section 820 the San Diego Military and Veterans Advisory Council (SDMVAC) submits the following report of activities and accomplishments for Fiscal Year 2024-2025.

Background:

The Board of Supervisors of the County of San Diego sets the policy of the County to take a leadership role in identifying and addressing the needs of Military Veterans. In order to fulfill the tasks related to this, the Board established a San Diego County Military and Veterans Advisory Council. The Council shall function as an independent body in carrying out its duties and responsibilities, reporting directly to the Board of Supervisors, as well as the Chief Administrative Officer.

The plan for Fiscal Year 2024-2025 was to advise the Board of Supervisors on goals and objectives relevant to the County of San Diego Office of Military and Veterans Affairs (OMVA) Department.

Membership and Organization:

The SDMVAC consists of nine volunteer citizens who are appointed by the Board of Supervisors. Five members are appointed by the Board of Supervisors, with each Supervisor nominating one Council Member from their respective District. Four members are appointed by the Board of Supervisors, as Members-at-Large. A Chair and a Vice-Chair are elected on odd-numbered years and serve a two-year term.

Jude Litzenberger (Member-at-Large) was elected as the new Chair and Danny Jackson (D3) was elected as the new Vice-Chair, in August 2023.

The SDMVAC started the Fiscal Year with two membership vacancies: District 5, Seat 5 and Member at Large, Seat 6. In May 2025, Jaime Yslas, who held the position of District 1, Seat 1, resigned from the Council. Following his departure, two new members were appointed: David McCulloh filling Seat 5 for District 5 on April 22, 2025, and John Paul Sullivan filling Seat 6 for Member at Large on June 24, 2025.

SDMVAC meetings were regularly announced to the public via the Clerk of the Board and SDMVAC websites. Meetings were also broadcast via Zoom for virtual public and staff participation.

Focus and Oversight:

This year, budget constraints made clear the importance of healthy nonprofits in meeting more needs of the military/ Veteran community in the future. The Council continued to look at the health of the County's military veterans including the nonprofit organizations who play an important role in caring for them. The Council invited presentations from a number of key nonprofits asking questions that provided a good sense of what was working and what needed attention. The primary focus areas of the SDMVAC in Fiscal Year 2024-2025 were

- Service Delivery to Veterans
- Local Military and Veterans Events
- Community Outreach to Veterans and their Family Members

• Collaboration with different Veteran services organizations.

The Council identified the need to have workgroups/ad hoc committees to look deeper into activities that affect the health and full participation of the military/veteran population. The Council is establishing working groups that address Education, Employment, Food Security, Housing, Healthcare, and Legislation. Each working group will monitor progress and anticipate challenges in these areas to provide more accurate information regarding the health of San Diego County active-duty military, veterans and their families to support the Board of Supervisors.

Additionally, the issue of viable boards of directors to serve local nonprofit organizations revealed that many key organizations were having difficulty identifying, recruiting and retaining qualified board members. The Council identified a solution that would provide training for these important organizational leaders and help them create strong boards to serve in the future. The SDMVAC Chair invited Good for Others (a San Diego based impact focused nonprofit) and The Nonprofit Institute at University of San Diego to assist with expertise in identifying training options. Soon, Good for Others will fund the USD Nonprofit Institute in conducting training for the boards of nonprofits serving military/veterans. They also will build up a pool of military veterans to serve as qualified nonprofit board members in the future. The Council believes this training will strengthen both military/veteran-serving nonprofits and qualify a pool of military veterans willing to serve on other nonprofits where veterans voices will be helpful throughout the County.

- DOD/VA Policy Changes Regarding Gender-Affirming Care and fate of Trans Service Members
- All Chairs County Boards Meeting
- Veteran's Events
- 25/26 Proposed Operational Plan Budget
