- 1. Meeting called to order at 1:00 pm by Jude Litzenberger, Chair
- 2. Pledge of Allegiance
- 3. Roll Call
  - SDMVAC present members noted above.
- 4. The April 17, 2025, meeting minutes were approved by the four Council members present and one abstain.
- 5. Public Comments:
  - No public comment

- 6. **Discussion Item:** New Community Connections: SDMVAC Council members share community events they had recently attended. Council members shared highlights from recent veteran-related events they attended, as well as upcoming engagements.
- 7. **Action Item:** Nomination for the 2025 SDMVAC Chair and Vice Chair. Phil Kendro nominated Jude Litzenberger for her second term as Chair, and Tony Teravainen nominated Danny Jackson for his second term as Vice Chair. Chair Jude Litzenberger moved a motion to accept both nominations, and all members present voted unanimously in favor. OMVA Officer Ray Flores confirmed that the election of the new Chair and Vice Chair will take place at the next SDMVAC meeting, scheduled for August 21, 2025.
- 8. **Presentation Item:** 25/26 Proposed Operation Plan Budget Presentation: Maryneeza Moraleja, Assistant Group Finance Director, Financial & Support Services Division, Health and Human Services Agency (HHSA). Maryneeza Moraleja Assistant Group Finance Director of Financial and Support Services Division provided an overview of recent economic updates, State and Federal budgets, the CAO Recommended Budget for HHSA for Fiscal Year 2025-2026, and shared information on upcoming budget events.
- 9. **Presentation Item**: Support The Enlisted Project (STEP): Tony Teravainen, PMP, CSSBB- CEO and Co-Founder of Support the Enlisted Project (STEP). Tony Teravainen CEO and Co-Founder of Support the Enlisted Project shared how the organization helps enlisted service members, Veterans and their families by improving financial wellness. STEP provides counselling, education, and financial assistance to help prevent issues like food insecurity, homelessness, mental health struggles, suicide and other crises. Their goal is to help families become financially stable and self-sufficient.
- 10. Discussion Item: Committee Reviews: Chair Jude Litzenberger updated the group on the formation of committee for Food Security, Housing, Education, Employment, Healthcare, and Legislation. She noted members have volunteered and emphasized the need for regular meetings. Chair Jude Litzenberger requested a template to draft the committee charters and reminded that each committee can have only three members per the bylaws. She asked about available data or metrics for each committee, public access to these records and sources of information. Committee will rotate presenting updates, with the goal of compiling a report for the Board of Supervisors supported by data and committee structure.
- 11. **Discussion Item**: Suggested topic for future meetings: All San Diego Military and Veterans Advisory Council. Chair Jude Litzenberger encouraged the Council members to invite organization that supports Veterans and their families, as well as those involved in family engagement and community support.

## Clinical Overview

- Short-Term Model
  - o Telehealth or in-person
  - o 8-12 sessions
  - Weekly
- Measurement-Based Care
  - Completed prior to your session, either virtually or in person.
- Discharge
  - o Booster sessions (3 sessions within 12 months).
- New Care
  - New intake assessment must be completed per presenting issue.



#### Case Management Services

- We provide comprehensive case management services to veterans and their families who are clients or in the process of seeking mental health services at our clinic.
- We facilitate direct referrals for housing, employment, health care, legal services, education opportunities, peer support and all other essential community-based needs for clinic clients. Provides appropriate referrals, as necessary.



## Substance Use Disorder Counseling

- Provides addiction severity assessments.
- Creates relapse prevention plans.
- Sets treatment goals.
- Shares AA or SMART Recovery approaches.
