Board of Supervisors asked County Communications to put together a Culturally Competent Language Plan for County employees. Tammy's objective of meeting with the Committee is to solicit feedback and suggestions.

#### Plan Objectives:

- Convene a working group of communications stakeholders within the County
- Create County-wide communications strategy to ensure equitable, culturally responsive, inclusive and trauma-informed processes
- For creating and distribution of County documents and communications
- Develop plans to ensure communications, business operations and public facing documents use appropriate language that is culturally responsive and inclusive

### Suggestions and feedback from the Committee:

- Create an online form to allow input in a private or anonymous manner
- Define 'culturally competent' and what that encompasses
- Highly encouraged trauma informed training and communication for County services, forms and employees

- Improve reasonable accommodations to ADA assistance form
- Identify local organizations to source
- Identify which cultures to proactively source and involve
- "Role Play" or source input from internal COSD employees
- Research how people should deal with sensitive issues from cultural differences
