### **Office of Military and Veteran Affairs**

Guest Speaker: Wilfred Quintong, Director of the Office of Military and Veterans Fair

The Office of Military and Veterans Affairs falls under the Self Sufficiency Services department with HHS. Speaker provided an overview of San Diego's veteran and military population. San Diego has the largest concentration of military and veterans in the world, approximately 355,000 and over 22% of this population have a disability.

The Office conducts outreach to meet Veterans and support their needs through the following:

- Veteran Outreach Program – Veteran Service Representatives conduct outreach programs at six county libraries, in rural areas, Vista Jail for incarcerated veterans, as well as Tijuana.
- Live Well on Wheels
- Military and Veterans Resource Centers
- Collaboration with many local coalitions, councils, committees and Chambers of Commerce

The Office has several active initiatives such as:

- Vets Moving Forward
- Leave No Veteran Behind

### **2022 Accessibility Board Letter**
