Vote to Approve Meeting Minutes

Circulate San Diego

Presenter: Jana Schwartz, Circulate San Diego

Topic: Mobility Safety for All

Jana reviewed mission of Circulate San Diego, including mobility assessments, safety campaigns, and advocacy.

Vision Zero: a strategy to eliminate all traffic fatalities and severe injuries in the next 10 years

• Jana presented multiple planning scenarios to request committee's feedback with a focus on disabilities. Examples included protected/separated bike lanes, raised crosswalks, narrower traffic lanes, lead pedestrian intervals, street lighting, pothole repair and mid block crossings.

Public Right-of-Way Accessibility Guidelines:

- 4 feet minimum width for side walks
- 60" x 60" passing space at intervals of 200 feet
- Shared use path width determined by use and not accessibility
- Pedestrian access route running slope: grade of pedestrian route shall not exceed 5%

Affordable and Accessible Housing

This topic will be discussed at the June meeting due to timing.

Santa Fe Train Station

Michelle has spoken with Karen Landers at MTS. Karen is creating a priority list of projects with the committee's feedback in mind.

Members of the committee will do another site visit and board a train to observe accessibility and space on the trains themselves.

Accessible Parking

The committee approved a letter to Kaiser Permanente about accessible parking and will be mailing it to Kaiser.

Michelle brought up concerns about accessible parking as restaurants have now implemented outdoor dining that takes up space previously designated for walkways and parking.

The committee is considering writing letters to city managers to discuss concerns around parking availability. This item will be added to the June agenda.
