#### 2022 Accessibility Board Letter

In response to the 2022 Board directive, Todd and his team completed the following to date:

- Accessibility Awareness Community Engagement webpage
- Three community engagement sessions
- Community engagement survey

Todd provided an overview of responses and lessons learned from the engagement sessions and survey.

- Staffing for accessibility support

#### Committee Recommendations and Feedback

- Kaye supported the need for staffing and additional resources.
- She also recommended that the County should put more effort towards advertising committee openings to recruit persons with disabilities for other committees as well.

#### **Ethics Training**

Guest Speaker: Randall Sjoblom

Randall joined the meeting to provide background and direction for the required ethics training. California bill AB1234 requires this training for all government agencies and appointed committees complete required ethics training. This committee is entitled to reimbursement of expenses therefor they are subject to this requirement.

Kaye requested that the County provide the training to the group instead of the link provided. Todd and Katie will check with Randall's department and options. If the committee wishes to have the training during a meeting, they will need to schedule a special meeting or use a regular meeting to complete.

#### **Committee Sunset Review**

In light of committee feedback and concern related to the demographic survey and omission of any disability related questions, Michael Vu recommended that the Office of Ethics delay the Board presentation scheduled for August 30<sup>th</sup>. The committee will work with Todd to come up with additional survey questions so that the Clerk of the Board can send a second survey out to all appointed committee members.
