Meeting Minutes



Regular Meeting – September 17, 2025 – 3:00 pm

Call to Order – Meeting was called to order at 3:00pm by the Vice Chair

Welcoming Remarks and Introductions

Vote to Approve Meeting Minutes – August 20, 2025

 A motion was made and seconded to approve the August 2025 meeting minutes; committee approved. Julie abstained.

Non-Agenda Comment

LiveWell Advance Conference and School Summit

- Cameron confirmed the committee's LiveWell Advance and School Summit session proposal was accepted and that the LiveWell Advance Connection Hub booth is still pending approval.
- Sue presented an overview of the session. Sessions may have75 to 100 attendees.
- The committee discussed the two roles, moderator and representative, on the panel that need to be filled by committee members.

- A motion was made for Jessica to be the committee representative on the Live Well panel; no second was received.
- A motion was made and seconded for Sue to be the moderator on the Live Well panel; committee approved. Julie abstained.
- A motion was made for Janette to be the committee representative on the Live Well Panel; committee approved. Julie and Brennan abstained.

Working Session – Strategic Focus Areas

- The committee discussed the results of last month's breakout session regarding the four strategic focus areas and reviewed handout.
 - o Behavioral Health and Crisis Stabilization Accessibility
 - Brennan expressed interest due to life experiences.
 - Julie expressed interest due to previously having served on a mental health commission and connections with two counties in Northern California around county health with a person-centered approach.
 - Chair Dr. Smith and Jessica not present but previously expressed interest in focus area.
 - Brennan, Jessica, Karolyn, and Julie are assigned to the focus area to bring concepts and thoughts to the committee for recommendations to the board.
 - Emergency and Public Safety Accessibility
 - Laura expressed interest since focus area is timely given natural disasters and possibly less of a funding issue.
 - Julie expressed interest due to personal connection to recent natural disasters in California and connected to community members impacted by the Los Angeles fires.
 - Sue expressed interest since previously being a Co-chair on Red Cross committee Disability Integration Team.
 - Chair Dr. Smith not present but previously expressed interest in focus area.
 - Sue, Janette, Laura, Julie, and Chair Dr. Smith are assigned to the focus area.
 - Housing Accessibility
 - Brennan expressed interest since he currently works in this field.
 - Laura expressed interest specifically around service dog registration.
 - Michelle expressed interest and requested to provide ranked choices.
 - Jessica not present but previously expressed interest.

- Julie expressed interest since previously worked on technical guide with housing and desires to work with Brennan on establishing group homes.
- Brennan, Michelle, Jessica, and Julie are assigned to the focus area;
 Paul and Chair Dr. Smith tentatively assigned due to previous interest.
- Transportation Accessibility
 - Michelle expressed interest specifically around recertification policy.
 - Sue recommended focusing on one or two easy recommendations for efficient collaboration as well as timeline of fiscal year 2025-2026.
 - Chair Dr. Smith not present but previously expressed interest in focus area.
 - Michelle, Chair Dr. Smith, and Janette are assigned to the focus area with Sue and Laura resources.

Committee Business

November Room Availability

- Todd stated our usual room may not be available in November
- o The committee requested to keep the date and use a different room.

Organizational Goals

- Sue recommended using same template across all four focus areas with main point of contact and structure to track progress.
- Todd stated a previous committee member attended Board of Supervisor meeting regularly and granted awards for community members for awareness for consideration.
- The committee discussed working closer with supervisor's staff to increase awareness of the committee with local cities and constituencies and providing quarterly updates to them to be shared.
- A motion was made to work independently, via ad hoc committee, with no more than four members, to address four strategic areas and report back at each meeting; committee approved.
- Julie recommended using Alameda County as a framework for best practices to celebrate wins and build community.

Future Meeting Structure

- Todd recommended scheduling some meetings as working sessions while others will feature speakers on focus areas.
- Todd confirmed he can bring county resources and other community advisory groups to the committee for reports, presentations, and speakers.
- o Committee members can schedule external resources and speakers.
- Todd recommended gathering information and presenting it at October meeting as a starting point.
- Laura encouraged members to do own independent research.

New Business – Future Agenda Items

- Behavioral Health Services Request for Modifications
 - Todd will connect with Jessica on clarifying next steps since this is a strategic focus area.
