

One Call Claims

A simpler way to file your Short-term Disability (STD) claim

With One Call Claims, you can submit your STD claim seamlessly over the phone in a matter of minutes.



Here's how the process works:

1

Call 888-480-8710

Submit an STD claim if:

- You've been absent from work because of a non-work-related illness or injury, and will not be
 returning within the elimination period (the period of time before your benefits kick-in) outlined in
 your company's policy.
- You're within one week of a planned surgery or childbirth.

Provide your information

When you call, you'll need to submit your.

- Name and date of birth
- Address and phone number
- Social Security number
- Employer
- Group policy number: **010261914-00000**
- Group ID: 800020

- Doctor's name, address, phone, and fax numbers
- Occupation and the last day you worked
- Condition or diagnosis

Stay tuned for a decision

After you submit your information, a claims examiner will process your claim and, if necessary, contact your employer and/or healthcare provider. If we need additional information, your claims examiner will reach out to you.

It's also likely your physician will need to complete an Attending Physician's Statement. To make sure your physician receives this form, simply:

- Supply your doctor's fax number during your call, and we will fax the form directly to their office;
- Ask the claims examiner to send you the form and then give it to your doctor; or
- Print the form at Lincoln4Benefits.com

Once we receive and review your information, we will notify you of our claim decision. If approved, your benefits will be paid as outlined in your company's policy.

To access the forms and benefits information you need, simply:
