

#### The Position

The County of San Diego, Land Use and Environment Group is seeking qualified candidates for the position of Hearing Officer – Temporary to work on an as-needed basis as hearings are scheduled. The hours of work vary depending on the complexity of the case; as an estimate, hours may vary from two to 20 hours per month. These hearings take place during regular business hours and are located at 9325 Hazard Way, San Diego, 92123.

Hearing Officers are responsible for presiding over civil administrative penalty hearings for enforcement of agricultural and weights and measure laws and regulations; and writing reports on such hearings.
