The immigration panel contract is on a per case basis and does not have a set term or number of cases-per-year commitment. OAC will contact panel member attorney and assign cases based on immigrant representation need. OAC reserves the right to terminate panel membership and/or case assignments at any time within the discretion of the program legal coordinator. Pay point deliverables will be paid on a per case milestone. Payments will be billable immediately upon completion of said work, not necessarily upon case closure. See chart below for rates. If milestones occur multiple times they can be billed for each appearance or task. Ancillary Service Requests will be made to the legal coordinator for pre-authorization. Payments will be made directly from OAC and the County to the provider. Please note the stringent case data maintenance and 30-day reporting requirements mandated by the Board of Supervisors.
