**Unified Disaster Council Virtual Access.**

Due to the [Coronavirus disease \(COVID-19\)](#) public health emergency, the County of San Diego is making several changes related to Unified Disaster Council meetings to protect the public's health and prevent the disease from spreading locally.

California Governor Gavin Newsom issued [Executive Order N-29-20](#) on March 17, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic. Pursuant to the Executive Order, and to maintain the orderly conduct of the meeting, members of the Unified Disaster Council may attend the meeting via teleconference or phone conference and will participate in the meeting to the same extent as if they were present.
