**Unified Disaster Council Virtual Access.**

Due to the [Coronavirus disease \(COVID-19\)](#) public health emergency, the County of San Diego is making several changes related to Unified Disaster Council Sub-Committee meetings to protect the public's health and prevent the disease from spreading locally.

California Governor Gavin Newsom issued [Executive Order N-29-20](#) on March 17, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic.
