Urban Area Working Group Virtual Access.

Due to the [Coronavirus disease \(COVID-19\)](#) public health emergency, the County of San Diego is making several changes related to Unified Disaster Council Sub-Committee meetings to protect the public's health and prevent the disease from spreading locally.

California Governor Gavin Newsom issued [Executive Order N-29-20](#) on March 17, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic. Pursuant to the Executive Order, and to maintain the orderly conduct of the meeting, members of the Urban Area Working Group may attend the meeting via teleconference or phone conference and will participate in the meeting to the same extent as if they were present.

Additionally, the County of San Diego will allow the public to participate in the meetings via teleconference, instead of attending in person. **Due to the Executive Order to stay home, in person participation at Unified Disaster Council Sub-Committee meetings will not be allowed at this time.**
