#### A. Regional Emergency Care and Sheltering- Bixie Howe, American Red Cross

- Provided updates on American Red Cross operations, processes and resources.
- Southern California Region is ranked 2nd in Nation for FY23 Readiness Report.
- Total of 420 mass care trained workers and 80 shelter managers.
- Currently have 270 shelters with 41 being high-capacity shelters.

#### B. WebEOC Update-Patty Jordan, OES

- New platform went live on July 6, 2023.
- There are currently 2,000 users, 18 jurisdictions, 241 organizations and 171 power users supported.

#### C. CERT/AFN Regional Disaster Training- Nick Thomlison, OES

• First train the trainer course for City Emergency Managers, CERT and County Departments was held on July 27, 2023. Four more courses are planned in August in preparation for National Preparedness Month in September.

#### D. Regional Hazard Mitigation Grant- Nick Zubel, OES

- Updates were provided to proposed scope of work.
- County of San Diego Office of Emergency Services is funding this plan.

#### E. Cal OES Report- Patrick Buttron, Cal OES

- Hazard Mitigation assistance has been sent out.
- Monitoring fires, Hurricane Hilary, Border Mission, and exercises with the Port of San Diego.
- Sent Cal Fire and Cal OES staff to Maui.

#### F. State Homeland Security Grant Program- Valentine Dama, OES

- FY20 Reimbursement checks have been received. There are still nine open projects that have been extended through 2024.
- FY21 The official three-year window has ended as of May of 2023, open projects will need an
  extension.
- FY22 We submitted our Bi-Annual Strategy Implementation Report to FEMA. We anticipate receiving our grant letter award from CalOES this fall.
- FY23 SHSGAP application is pending final FEMA review and approval.
- Hosted Annual Homeland Security Grant Program Workshop together with the City of San Diego Office of Emergency Services on July 12, 2023. It was well attended with about 50 representatives from 27 jurisdictions.

## **FY21 SHSP Reallocation**

### **BACKGROUND**

- Starting in FY11 SHSP, a competitive Reallocation process was implemented.
- For FY20 SHSP, a total of \$100,372 was returned to our region & funded:
  - (1) Cellular Gateway Network
  - (44) Regional Cellphone Boosters for Enhanced Communications
  - (4) P25 Compatible Public Safety Radios, and
  - Upgrades to Command Vehicle Communication Equipment.
- The anticipated funds available for Reallocation for FY21 SHSP is \$90k.



## PROJECT REQUIREMENTS

- 1. Proposed projects have a <u>three-month</u> completion timeframe (October 21, 2023 to January 21, 2024).
- 2. Projects must not require EHP, Aviation, or Watercraft approvals.
- Projects must not require new Sole Sourcing pre-approvals for Project Expenditures that are over \$250,000.

\*Requested projects that have a sole source pre-approval in place for the FY21 SHSP will be accepted.








# Great ShakeOut Earthquake Drill: How? Why?



Today we are joining millions of people who are practicing earthquake safety!

Earthquakes may happen anytime and almost anywhere.

Most earthquake injuries are from falling or flying objects.

It is important to practice DROP! COVER! and HOLD ON!



## The safe response to an earthquake?



Drop where you are, onto your hands and knees.





Cover your head and neck.

Crawl underneath the table or desk.

Stay on your knees and bend forward to protect vital organs.

No desk? Then crawl next to a wall, away from any windows. Stay on your knees and bend forward to protect vital organs.



Hold On to your shelter with one hand Keep covering your head/neck with your other hand.

## Adapt for Your Situation

- If you can't get back up again by yourself, don't drop to the ground.
- Wheelchair or walker: **lock** the wheels
- Bend over, **cover** your head and neck.
- Or hold on to a book over your head.
- Instruct others how to assist you.



How to prevent items from falling during earthquakes




Imagine your entire home or workplace being picked up and shaken during an earthquake – even heavy objects can fall or be thrown around! This usually causes the most injuries during earthquakes, and replacing items or repairing damages can also be very costly.

These issues can be prevented through simple actions to secure furnitue and other items in place. That's why "Secure Your Space" is Step 1 of the Seven Steps to Earthquake Safety!

Start now by moving tall furniture like bookcases away from beds, sofas, or other places where people spend a lot of time. Move heavy objects to lower locations.

Then continue by securing things such as televisions,
