- i. April 28, 2022

- 2. **ACPG Statement:** The Alpine Community Planning Group was formed for the purpose of advising and assisting the Director of Planning, the Zoning Administrator, the Planning Commission and the Board of Supervisors in the preparation, amendment and implementation of community and sub-regional plans. The Alpine Community Planning Group is an advisory body only.

- i. Mr. Walsh: Provided an update on the Loveland Reservoir. Sweetwater Authority seeking contractor to lower lake approx. 85 feet. They are considering taking water from the reserve and allowing water to drain from the reservoir. Communication is to change the policy to no longer allow storage of excess water from the reservoir. T. Lyon will work to get the Sweetwater Authority on the agenda for a future meeting.

- 1. As part of its Socially Equitable Cannabis Program, the San Diego County Board of Supervisors will consider a Cannabis Tax Ordinance for potential placement on the ballot for the November 2022 gubernatorial elections. The Board of Supervisors will be discussing and voting on proposals at its June meetings. The group may make a recommendation on the Cannabis Tax Ordinance proposals. **Presentation, Discussion & Action**
- i. T. Lyon motions to recommend to Board of Supervisors a special tax be imposed vs. a general tax. The special tax to be structured to ensure that tax dollars raised in the unincorporated areas remain in the unincorporated areas. J. Easterling Second. 11 yes, 0 no, 0 abstain, 4 absent/vacant.

The County of San Diego Department of General Services is processing a request to vacate a portion of the old alignment of Japatul Road that bisects private property at 20763 Japatul Road, APN: 524-020-36. The owner/applicant of a property located at 3547 "C" East Victoria Drive, Alpine, CA has applied for a discretionary permit for a major use permit to install a wireless cell tower and new ground equipment (PDS2021-MUP-21-004). The cell tower will be a mono-tree type facility and will replace an existing 30' tower with a 60' tower. - 4. The San Diego County Department of Public Works (DPW) has requested the ACPG's participation in identifying a prioritized list of transportation improvement projects on the county-maintained road network in Alpine. Project types include the following:
- i. Road Reconstruction/Reconfiguration/New Roads: Improvements include adding and/or modifying street lighting, lanes, turning lanes, roundabouts, or bike lanes to improve safety and/or increase roadway capacity.
- ii. *Bridges Repair/Reconstruction:* Improvements include adding and/or modifying street lighting, lanes, or bike lanes to improve safety and/or increase bridge capacity.
- iii. Sidewalk/Pathways/Pedestrian Access Ramps: Improvements include sidewalks, pathways, and ramps that promote safety and walking in the community.
- iv. Drainage: Improvements include corrections to storm drain problems on roadways or dip sections.
- v. *Traffic Signals:* Installation of traffic signals to improve safety and traffic operation.
- vi. Intersections: Improvements could include new signals and turn lanes to improve safety and traffic operation.
