The owner of a property located at 2812 Alpine Blvd, Alpine, CA 91901 has applied for a discretionary permit for a Site Plan (PDS2024-STP-24-015) for construction of a new 3,822 sf steel building to be used for retail sales / specialty production. The county has requested the group make a recommendation on this application. **Presentation, Discussion & Action**

- 2. The owner of a property located at Taberna Vista Way, Alpine, CA 91901 (APN 403-380-64-00) has applied for a discretionary permit for a Site Plan (PDS2025-STP-25-003) for construction of 13,000sf of heavy vehicle storage, 7,386sf 2 story office building, 29 off street parking stalls, and 1 trash enclosure on the 3.86-acre lot. The property is zoned M52 which allows for industrial use. The county has requested the group make

a recommendation on this application. **Presentation, Discussion & Action**

The owner of a property located at 714 Tavern Road, Alpine, CA 91901 has applied for a discretionary permit for a Site Plan (PDS2024-STP-25-014) for the addition of a 5,000 square foot storage building, bathroom, workshop, trash enclosure, and associated parking. The county has requested the group make a recommendation on this application. **Presentation, Discussion & Action**
